3. Report Respecting Municipal Services and Operations

The City undertook the following initiatives in 2011:

Conservation and Green Energy

 Amended Official Community Plan to incorporate targets and strategies aimed at enhancing community energy and resource efficiency, including greenhouse gas emission reductions.

- Water meters reduce consumption, which saves water and reduces infrastructure costs. Phase 1 of the metering project was completed and funding was approved for Phase 2 under the Towns for Tomorrow Program. Phase 2 commenced in late 2011. A background review for a new rate structure to promote conservation has commenced.
- Obtained funding approval to complete a water leak detection program that will identify water loss problem areas and establish a repair schedule.
- Applied for funding for a Bio Energy Heating System at the sewer treatment plant and public works facility.
- Completed the sludge dewatering and nutrient removal project at the wastewater treatment plant.
- Received funding approval under the Gas Tax Program to undertake the Knoll Neighbourhood Integrated Sustainability Plan. This will provide a sustainable plan for development areas within the City.

Bylaw Enforcement

- Contracted with the Commissionaires to implement Council policy respecting bylaw enforcement.
- Policy is complaint-driven and emphasizes compliance, with a focus on property maintenance, open air burning, and street and traffic violations.

Infrastructure, Asset Management, and Drainage

- Evolved preventative maintenance schedule to extend the life of assets.
- Developed life cycle replacement schedule to anticipate future resource needs.
- Worked with Highways for completion of the first two phases of the Highway 97A upgrade, which included the installation of new underground infrastructure at significant savings to local taxpayers.
- Completed the design of the Knight Street upgrade tender for completion in 2012 in partnership with School District 83.
- Completed improvements to the storm sewer lift station on Regent.
- Designed and commenced with drainage improvements in a number of areas within the City including the first phase of a major upgrade to Regent Avenue.
- Worked with School District 83 and developer to address drainage issues in the northwest area of the community.

Recreation

- Completed the Master Parks Plan.
- Completed a new access at Grindrod Park that will enhance safety.
- Commenced work on securing right-of-ways for the trail system at Twin Lakes.

- Converted the hardball diamond at Riverside Park to a slow pitch diamond.
- Established a priority list for addressing safety concerns at the pool including installation of a second drain, gutter restoration, and changing from a gas to a liquid feed chlorinator based on Pool Safety Regulations and Interior Health recommendations.
- Completed the Development Cost Charges (DCC) review and introduced a new DCC bylaw for parks. Forwarded the draft bylaw and background report to the Regional District for advancing the new DCC bylaw.

Health, Safety and Food Security

- Completed sprinkling, fire code and energy projects at the arena and curling rink.
- Worked with other jurisdictions within the Regional District to directly provide Jaws of Life service.
- Adopted an Inter-Municipal Emergency Operations Bylaw that enhances safety through regional cooperation, training, and planning.
- Completed operational guidelines and new policies for fire operations in consultation with the Fire Department. Adopted a fire inspection policy and a fire fighter training policy.
- Appointed Fire Chief Kevin Alstad and Deputy Fire Chief Travis Horsman.
- Adopted inspection and maintenance policies for Public Works operations in order to manage risk effectively. Adopted a Risk Management In-House Claims Management Policy.
- Submitted an application under the 2012 Age-Friendly Community Planning and Project program for a community garden at the Enderby Memorial Terrace.

Cooperation

- Participated in the development of the Regional Growth Strategy.
- Continued to work with the Province to change legislation to finalize Enderby/Area F service transfers.
- Participated in a Community-to-Community Forum with Splatsin to identify common issues and opportunities for enhanced cooperation.
- Renewed Service Agreements with Splatsin for water, sewer and fire protection.

General and Operational

- Commenced with the integration of Recreation and Public Works to promote flexibility, efficiency, effectiveness, and continuity.
- Renewed the collective agreement with CUPE.
- Completed review of benefits as identified in existing collective agreement.

- Completed a succession plan for the Chief Administrative Officer and Treasurer, which included hiring a new Chief Financial Officer and Deputy Chief Administrative Officer.
- Entered into a three year cemetery maintenance contract.
- Renewed the contract for Blue Bag and Garbage collection.
- Administered the 2011 local government elections for the City of Enderby.

6. Goals and Objectives for 2012

Community Vitalization

 Work with the community to complete a plan including implementation of Community Vitalization strategies objectives.

Conservation and Green Energy

- Commence with the Knoll Neighbourhood Integrated Sustainability Planning process with funding from the gas tax.
- Commence with terms of reference for an Official Community Plan review, Zoning Bylaw review, Subdivision and Development Bylaw Review and Development Cost Charge Bylaw review as a follow up to the Knoll Neighbourhood Integrated Sustainability Plan.
- Complete the Bio Energy heating system project at the public works/sewer treatment plant site with funding from the gas tax.
- Continue to work with a local private energy supplier for servicing facilities within the City with a Bio Energy heating system.

- Complete Phase 2 of the water metering project and introduce the new rate structure in late 2012 or 2013.
- Undertake a leak detection program to identify water loss problem areas and establish a repair schedule.

Bylaw Enforcement

• Ongoing emphasis on compliance on a complaint-driven basis focusing on property maintenance, open air burning, and street and traffic violations.

Infrastructure, Asset Management, and Drainage

- Complete the overall drainage review and continue with storm sewer improvements including the main storm sewer replacement on Regent Avenue.
- Complete Asset Management analysis which will identify future costs and suggest sustainable development standards.
- Subject to program announcement, make application for water system upgrades previously submitted under the Canada Infrastructure or Gas Tax funding program.
- Complete the reconstruction of Knight Street fronting M.V. Beattie Elementary School in partnership with the School District.
- Evaluate options for the Granville/Hubert connector.
- Review options for the reconstruction of Regent from Highway 97 to Sicamous including storm sewer and roadway.
- Review options for reconstruction and capping of portions of Sicamous Street from Knight to Mill.

Recreation

- Implement the priority list for addressing safety concerns at the pool including installation of a second drain, gutter restoration, and changing from a gas to a liquid feed chlorinator based on Pool Safety regulations and Interior Health standards.
- Subject to program announcement, make application for the walkway project (Riverwalk to Waterwheel) previously applied for under the Local Motion program.
- Work with the Regional District to adopt the new Development Cost Charges Bylaw for Parks.
- Enhance small walking trail at the head of Norleen Lane.

Health, Safety and Food Security

- Complete risk assessment for boiler at arena/curling club.
- Provide Jaws of Life service directly.

- Participate in Inter-municipal Emergency Operations.
- Work with Enderby Memorial Terrace Society to administer grant to build a community garden.

Cooperation

- Complete transitional matters related to the Enderby/Area F service transfers.
- Review options for a Share Shed in partnership with community organizations.
- Continue to work with Splatsin to identify common issues and opportunities and to establish collaborative efforts to move forward on such matters.
- Work toward establishing longer term service agreements with Splatsin.

General and Operational

- Complete a review of municipal operations to establish work programs, schedules and priorities.
- Continue to integrate the Recreation operations with Public Works operations.
- Restructure cost accounting system and chart of accounts to improve information and reporting.
- Analyze potential resources to advance the GIS component to the next phase.
