DISCUSSION ITEMS

Late Item: Public Art Work

- Councillor Shishido suggested that before committing to the placement of the Runaway Moon art project, an inventory of art works be done to determine if it a good "fit" for Belvidere Park. It is important to keep the art work consistent with what already exists.
- Placing the work near the Chamber could interfere with other user groups that use the park such as Music by the River.
- Perhaps an educational site such as the elementary school, Kingfisher Interpretive Centre, or a Splatsin site would be more appropriate for this type of educational art.
- The expansion area of the Riverwalk with the Splatsin could also be a good site.

Moved by Councillor Shishido, seconded by Councillor Case that Council defer the placement of the Runaway Moon Art Project and direct Staff to explore an alternate site for installation.

The Chief Administrative Officer will meet with Ms. Stubbington and forward feedback to the Council Projects and Events Management / Community Services portfolios.
