<u>2015 Water Consumption and User Fee Revenue</u> – Analysis and Memo from Chief Financial Officer dated January 27, 2016

The Chief Financial Officer reviewed her report and analysis.

It was consensus of Council to invite comments from the public:

Tony Vetter of 806 Sicamous Street stated that we are not being fair by basing our fees on households rather than number of people per household.

Gary Restorick of 41 Preston Crescent stated that the current system successfully targets water wasters who wash cars and water lawns excessively.

Discussions:

- Water is a utility and as such a "user pay" model is fair.
- CFO explained that the differences in numbers between the staff report and Richard Vetter's letters is that he did not include commercial information.
- Over 2 years was spent developing this rate structure. Under the flat rate, 2/3 of the community are paying less than they would under the old flat rate system.
- During budget deliberations, staff to report back with potential adjustments to the rate model to soften impact for those with lawns or large families.

Moved by Councillor Shishido, seconded by Councillor Knust that Council directs Staff to refund the difference between the targeted and actual metered water rate revenue for 2015 based on an equal amount to each residential customer;

AND THAT Council directs Staff to review the metered rate structure for 2016 once the 2016 water fund budget is known.

<u>Terms of Reference for Spring Volunteer Fair</u> – Memo from Assistant Corporate Officer and Planning Assistant dated January 27, 2016

Moved by Councillor Shishido, seconded by Councillor Case that Council approves the Terms of Reference for a Spring Volunteer Fair as presented and provided the following feedback:

Tony Vetter of 806 Sicamous Street queried why the Cliff Avenue upgrade has been given such a high priority when Federal funding may become available. Mayor McCune explained that Federal funding could take a very long time and the infrastructure works need to get done. City will look to applying for grant funding as part of future projects – there is a significant infrastructure backlog.

Gary Restorick of 41 Preston Crescent commented that since labour costs will only rise in the future, it is best to get the works on Cliff Avenue done now.

RECOMMENDATION

THAT Council gives three readings to the City of Enderby Municipal Ticketing Information (MTI) System Bylaw No. 1518, 2013 Amendment Bylaw No. 1588, 2016;

AND THAT Council gives three readings to Bylaw Notice Enforcement Bylaw No. 1581, 2015 Amendment Bylaw No. 1589, 2016.

BACKGROUND

Staff are advancing amendments to the Municipal Ticketing Information (MTI) Bylaw and Bylaw Notice Enforcement Bylaw to include penalty provisions under the following bylaws:

1. Building Bylaw No. 1583, 2015

Staff are advancing consequential amendments to the MTI Bylaw and Bylaw Notice Enforcement Bylaw to include penalties from the recently adopted Building Bylaw No. 1582, 2015 related to i) obstruction of a Building Official, ii) commencing or continuing any construction, alteration, reconstruction, demolition, removal or relocation of any building or structure without a permit, and iii) failure to comply with 'Stop Work Order' and 'Do Not Occupy' notices.

2. Zoning Bylaw No. 1550, 2014

Staff are advancing amendments to the MTI Bylaw and Bylaw Notice Enforcement Bylaw to include penalties related to i) industrial uses creating annoyances or nuisances to surrounding areas by reason of unsightliness or the emission of odours, liquid effluence, dust, fumes, smoke, vibration, noise or glare, and ii) industrial uses creating or causing a health, fire, or explosion hazard, electrical interference, or undue traffic congestion.

3. Fire Protection Bylaw No. 1529, 2013

Staff are advancing amendments to the MTI Bylaw to resolve a few minor housekeeping matters related to the Fire Protection Bylaw schedule; furthermore, amendments to the Bylaw Notice Enforcement Bylaw are being advanced in order to include penalty provisions from the Fire Protection Bylaw No. 1529, 2013, which will enable the City to enforce this bylaw through the use of Bylaw Notices.

Re: Vernon/North Okanagan Detachment Policing Activity Report – 4th Quarter 2015

All crime statistics are featured at the end of this report. Statistics reflect monthly totals for October through December 2015 and comparisons of the previous year, 2014.

Over all, the Vernon/North Okanagan Detachment (V/NOD) recorded a 0.1% decrease in criminal code cases from the previous year with property crime up 1.9% this quarter. There was a 1.67% increase in our calls for service from 28,149 in 2014 to 28,621 in 2015.

The road safety check-stops reporting a 9.3% increase from this quarter in 2014. Impaired driving investigations continued its' downward trend with a decrease of 16.9% this quarter from the previous year.

On October 1st, our members were up early handing out breakfast and conducting traffic control for the United Way 'Drive thru Breakfast' to help raise funds for this worthy cause. On October 31st, Halloween was on a Saturday night which kept the detachment busy with extra patrols to supplement our general duty members. V/NOD had members on foot patrols, Auxiliary members and volunteers conducting patrols of the communities. Early in the evening, we saw the children out Trick or Treating and even handed out a candy or two from our patrol cars. Later, we attended to parties and disturbances. We interacted with many people dressed up in costumes with most enjoying the evening.

In November, members of V/NOD proudly wore our Red Serge in order to participate at Remembrance Day services at seven cenotaphs throughout our area which included Vernon, Armstrong, Coldstream, Enderby, Lavington, Lumby, and Westwold. We are proud that we had representation at each cenotaph this year with 32 active, retired and auxiliary members in attendance.

The month of December brought the holiday season with our members attending to two separate Christmas Luncheons. The Senior Centre in Enderby and the Halina Senior Centre in Vernon held events for the seniors in the community. Keeping with tradition, our members to attend in Red Serge to serve coffee, tea and dessert. The attendees are always so appreciative of our member's involvement and it was great to be involved in a successful, well run event.

This report reflects a representative sampling of our policing activities for the 4th quarter of 2015.

GENERAL INVESTIGATION SECTION (GIS):

Serious Crimes Unit:

The following report is a synopsis of some of the most recent investigations that the Vernon Serious Crimes Unit (SCU) and Sex Crimes Unit have received and investigated; however, does not reflect all investigations that investigators are working on. SCU investigators continue to work on numerous other historical major cases which were initiated outside of this reporting period.

- November 2015, a report of a child had been sexually assaulted by another child (2015-25247). Subsequent investigation revealed another victim (2015-25295). Victim services and MCFD working with the families. Charges have been recommended to Crown Counsel against a 17 year old.
- December 2015, BC Integrated Child Exploitation Unit advised a user from Vernon had uploaded a video of suspected child pornography. Investigation revealed the youth appearing in video created and posted the video by their own choice. MCFD Social Worker and School Liaison Officer engaged in file. No charges pursued against youth for upload of child-porn due to age, vulnerability and mental state (2015-27064).
- December 2015, a local marihuana dispensary was robbed at gunpoint. The matter is still under active investigation (2015-28536).
- Polson Part Homicide: on-going case from August 2015, three persons arrested and charged with second degree murder. Vernon SCU has conduct of this investigation and two members contributing significant amounts of time in the completion of disclosure to crown counsel (2015-19215).
- As report in previous Quarterly report of the clandestine drug lab in an apartment, charges have been recommended against one person for Arson Disregard for Human Life and Criminal Negligence Causing Bodily Harm (2015-18114).
- November 2015, members conducted surveillance, subsequent arrest and interview of a suspect with regards to possession of a stolen vehicle over \$5000 (2015-26215).
- November 2015, an infant presented with an unexplained skull fracture at the Vernon Jubilee Hospital. Subsequent investigation revealed the infant had fallen from a height onto a hard floor. MCFD contacted by SCU and established child safety plan (2015-26508).

Domestic Violence Unit (DVU):

- Integrated Case Assessment Team (ICAT): There have been six new ICAT referrals since October 2015.
- Facilitated a presentation to detachment members with regards to Provincial domestic violence legislation and RCMP policy as well as the dynamics of domestic violence.
- Conducted a domestic violence information session to Immigrant Women at the Vernon and

District Immigration Services Society.

- DVU applied for and received a \$10,300 Civil Forfeiture grant to facilitate a one day workshop with Doctor Lori Haskell for police and service providers to take place this spring. Dr. Haskell is an expert on victims of trauma from sexual assaults and domestic violence.
- In December, DVU attended a two day conference in Vancouver with over 900 service providers from across BC on various issues regarding domestic violence, sexual violence, and violence against Aboriginal Women.

TARGETED POLICING:

The members from the Targeted Policing Unit meet regularly with numerous partner agencies including;

- Interagency: RCMP, Parole, Adult and Youth Probation, and Ministry of Children and Families meet monthly to discuss current status, activities, monitoring and enforcement related to persons deemed a high risk to re-offend. Attendance was also made to a similar meeting hosted by Salmon Arm as offenders in Enderby area fall under supervision of Salmon Arm Justice system;
- Outreach: RCMP, Probation, Ministry of Housing and Social Development, Interior Health, VJH, ACSS Team, Mental Health and Addictions, and Mental Health Forensic Services meet weekly to discuss status and risk factors related to persons in community who suffer from mental illness and are currently in the Justice System;
- Mentally Disordered Offenders: RCMP, Crown Counsel, Forensic Psychiatric Services, Probation, Vernon Jubilee Hospital and Interior Health meet quarterly to discuss status and risk factors related to high risk offenders with a mental disorder.

Targeted Policing provided assistance to General Duty, Serious Crimes and Provincial GIS investigations including the following:

- Interview of a suspect in custody for local thefts which resulted in admission to local thefts and break and enter in Provincial area (2015-21655);
- Attended to and provided all five Marihuana Dispensaries in Vernon a warning that their drug trafficking activities were illegal and could result in future enforcement action by police;
- Continues to have the lead role in investigating a series of Arsons from 2014 the investigation continues with the completion of numerous outstanding tasks;
- Continues to investigate the shooting incident at a Townhouse Complex parking lot in September (2015-21569);
- Assisting with the investigation of a shooting incident at a private party in Coldstream area (2015-22335).

Task Force (TF):

• Members targeted a subject suspected of drug trafficking. Investigation led to the arrest on an outstanding warrant and new charges of possession for the purpose of trafficking heroin and methamphetamine (2015-27158);

- Members assisted in the execution of a search warrant of the property of a local Prolific Offender who was arrested in a Kelowna theft of motor vehicle investigation;
- Members are investigating a possible recipient of a quantity of precursor for the manufacture of GHB that was intercepted by CBSA in Vancouver and destined for Vernon (2015-26641).

Crime Reduction Unit (CRU):

- Prolific Offenders: There are twenty-three Prolific Offenders identified for monitoring in our area with 14 not in custody (three currently residing outside of jurisdiction) and nine in custody.
- Members conducted an investigation into thefts and breach of conditions by one of the Prolific Offenders that resulted in arrest and return to jail (2015-24670, 2015-24674, 2015-24790 & 2015-24885).
- Members conducted an investigation into credit card frauds believed to be committed by a Prolific Offender who was also committing thefts from auto. The suspect was arrested and currently in custody (2015-22164 / 2015-22241).
- Bait Vehicle: Crime Reduction continues to utilize bait vehicles as a means to target and combat theft of and theft from vehicles. There were two activations this quarter resulting in charges (2015-22814 / 2015-27608).

Provincial Tactical Enforcement Priority (PTEP):

• Targeted Policing continued participating in this policing priority of identifying, profiling, selecting and targeting individuals and/or groups that are involved in criminal activity and because of their association to gangs / organized crime pose a safety risk to the community. There are currently five persons / groups identified in the Vernon North Okanagan area.

NORTH RURAL GENERAL INVESTIGATION SECTION (GIS):

The following report is a synopsis of some of the most recent investigations that the Provincial Rural General Investigation Section (GIS) have received and investigated; however, does not reflect all investigations that investigators are working on. Rural GIS investigators continue to work on numerous other historical major cases which were initiated outside of this reporting period.

- In October 2015, a report of shots fired at a rural Enderby residence. The victim was transported to hospital with life threatening injuries. Subsequent investigation lead to the arrest of a 58 year old male has been charged with numerous offences, including attempt murder (2015-23606).
- Rural GIS investigator trained in Digital Computer Field Triages (DCFT) completed seven electronic device examinations and associated reporting for detachment Investigations.

NORTH OKANAGAN SIGNIFICANT INVESTIGATIONS/INCIDENTS:

- On October 1 in Mara, a truck hauling logs to a log home builder failed to negotiate a corner on Hwy 97A and rolled. The driver was subsequently issued a violation ticket (2015-22196).
- On October 1 in Armstrong, unknown person(s) climbed onto the roof of Lenwood Middle School damaging several roof vents (2015-22187). Two weeks later, similar damage discovered at Pleasant Valley Secondary School. No suspect have been identified (2015-23253).
- On October 19 in Enderby, a report of shots fired at a rural residence. The victim was transported to hospital with life threatening injuries. North Rural members were assisted by members from Vernon City and Salmon Arm Detachments. Subsequent investigation lead to the arrest of a 58 year old male has been charged with numerous offences, including attempt murder (2015-23606).
- On October 30 in Spallumcheen, members set up a road block on Rose Swanson after learning a high school party was planned for the area (2015-24409). Members completed patrols of Kelly Main FSR and Yankee Flats Road and checked vehicles for impaired drivers (2015-24412).
- On November 1 in Enderby, members set up a check stop near Rosoman Road resulting in a small quantity of drugs and alcohol seized (2015-24531).
- On November 9 in the Westside Road area, report of cruelty to animals where a dog died after being left tied to a tree. The deceased dog was buried in a location further into the woods by the member. No suspect was identified (2015-25055).
- On November 11 in the Westside Road area, a rancher reported two cows were found dead on a grazing lease land. Both animals had been slaughtered on site (2015-25029).
- On November 26 in Ashton Creek, a report of a "Grow Rip" occurring initiated a high risk response by members. Investigation revealed the growers were dismantling their marihuana grow operation and no other persons were involved. Members arrested the growers and seized the marihuana (2015-26168).



- During this quarter a total of 12 individuals were identified on 13 files through fingerprints or other types of physical evidence.
- Overall stats for the 4th quarter this year compared to the same time last year were up 3 files in Vernon and down 12 files in the Rural.

POLICE DOG SERVICES (PDS):

• The three member Police Dog Services has been running below capacity as a result of an on duty medical injury sustained by one of our handlers and training. The PDS handler was at Innisfail Kennels retraining with a new police dog partner, PDS "Farook". As a result of the restricted capacity, scheduling generally provides for one-member shifts and a third of the remaining hours being availability for operational call outs after hours.

RESERVISTS:

- Our reservists have all been kept busy with their various duties including both general and specific dedicated traffic enforcement in Vernon, Coldstream, Armstrong and Spallumcheen and performing other duties as required in support of our General Duty and specialized units.
- This past quarter, our reservists have continues to perform limited functions and have each been required to exercise their mandatory 2 week break within their contract periods.

Reservists Traffic Enforcement:

SCHOOL RESOURCE OFFICER:

• Cst. COCKS commenced the duties of the dedicated SRO position in early September, however has been subject to some medical restrictions and not in uniform. He is still attending to meetings within the school district in an administrative capacity.

AUXILIARY CONSTABLES:

• With the departure of the Auxiliary Coordinator this past fall, the supervision of the auxiliary constable program initiatives have been split into two components, one related to the current training for new troop of auxiliary constables by Cpl. Trevor TRIBES and the management of veteran auxiliary constable activities by Cpl. Tania FINN.

HUMAN RESOURCES:

- During this reporting period, there has been some changes occurring with personnel and the overall establishment of the detachment. With the two new resources secured, we are in the process of identifying suitable members for the Downtown Enforcement Unit. Sgt TRIANCE continues in the Operations Officer role while awaiting a replacement. V/NOD had four members transfer out due to promotions and varying job opportunities. We have seen six members transfer to V/NOD bringing with them a range of experience from a new recruit to northern postings and major crime investigations.
- The established policing level for the integrated Vernon/North Okanagan Detachment is currently at 97 Regular Members (54 City of Vernon; 32 Provincial; 7 Coldstream; 3 Spallumcheen & 1 Splats'in First Nations Police).
