PORTFOLIO REPORTS

Councillor Baird

- Friday Night Lights event went very well.
- Fundraiser for Gary Baker was well attended. Over \$32,000 was raised.
- No left turn issue at Cliff Avenue onto the highway needs to be addressed. Several suggestions were presented. CAO will explore installing a left-hand turn sign on the reverse of the stop sign on the west side of the intersection.

Councillor Shishido

- Recreation Services introduced several new programs resulting in record attendance numbers at the pool.
- Spatsin has an Economic Development Officer.
- The museum is very busy on Fridays with people from the market using their washroom.
- Chamber of Commerce:
 - Board of Directors is intending to have executive meetings prior to regular meetings.

- o Garbage on the river is an ongoing issue.
- Washrooms at the RV park need additional help with cleaning.
- Welcome package for new businesses is being made.
- Board seeking to get more engaged with businesses.
- o Partnering with the City on Business Walks.
- Time to start planning for Christmas celebrations.
- Mayor McCune suggested a meeting with the Chamber on October 17th to discuss river stewardship. Also, a meeting with the Board of Directors prior to the Chamber AGM in November should be set up.

Councillor Davyduke

- Kudos to Councillor Schreiner, Sean Hamilton and city staff for a successful Friday Night Lights.
- The Fundraiser for Gary Baker was very impressive with lots of money raised.
- August food distribution served over 80 households.
- Although there are many Food Bank volunteers, they could use some more.

Councillor Case

- Friday Night Lights was awesome and indicated that there is an appetite for cheap family entertainment. Kudos to Councillor Schreiner.
- Enderby and District Services Commission meeting:
 - o Pool use is up.
 - o Isolation valves for chiller at the arena were replaced.
 - Smoking regulation survey is on the City website and has resulted in many submissions.

Councillor Knust

- Food Bank:
 - Volunteers needed, especially for the afternoons. Interested persons can contact Scott Hemenway or FED members.
- FACT:
 - The HUT has been very successful. Volunteer base is stable, but need volunteers that can do heavy lifting.
 - o A larger space is needed, perhaps at a future community garden site.
 - Another celebration lunch will be held in October, hosted by Enderby and District Financial.
 - October 10th is the last day for the HUT.

Councillor Schreiner

- Pleased with the Friday Night Lights event. Appreciative of the praise and noted the event was truly a team effort.
- Phase II of the Cliff Avenue upgrade is underway.
- Appreciation to finance staff for the report on permissive tax exemptions.
- Enderby Evangelical Chapel has a vacant property on Meadow Crescent that they are willing to make available for community purposes.
