# Councillor Baird

 With RDNO, met with Ministry of Forests, Lands and Natural Resource Operations (FLNRO). They are aware of the river issues. Other aspects of the river were discussed which included economic opportunities.

#### Councillor Davyduke

- The City was strongly represented and had great leadership in Mayor McCune.
- Interior Health discussed mental health issues.
- Small Talk Forum provided opportunity to share success stories with other communities.

The new Splatsin Administrator introduced himself and provided a brief background of his career working with First Nations government. First Nations have been identified as the driver in new economic development and the Splatsin team is growing. Things will be happening soon including the creation of a water treatment facility and a landfill. He lives with his family in Salmon Arm and is looking forward to working closer to home.
