## Re: Vernon/North Okanagan Detachment Policing Activity Report – 3<sup>rd</sup> Quarter 2016

Crime statistics for each area are featured at the end of this report. The statistics reflect monthly totals for July to September 2016 with comparisons of the previous year, 2015.

Continuing with the recent trend in the southeast district of the province, the Vernon/North Okanagan Detachment recorded an increase in criminal code cases of 5.82% from the previous year. Property crime is up 8.68%, with a noticeable spike in reports of break and enters and theft from vehicles. There has been a decrease of 9.43% in driving investigations involving alcohol despite road safety check-stops increasing 56.25% from this quarter in 2015.

The summer of 2016 was a busy one with many great community events bringing visitors to enjoy the beautiful Okanagan. Numerous residents participated in Canada Day activities and were thrilled with the great fireworks display by the Coldstream Fire Department at Kal Beach. On the same weekend the Funtastic baseball tournament was held in Armstrong, Enderby and Vernon with local beer gardens and nightly concerts at the Army Camp. The Okanagan Military Tattoo in July drew large crowds to Kal Tire Place to enjoy pipe bands and drill displays. During the Labour Day long weekend Armstrong hosted another successful Interior Provincial Exhibition and Stampede. The Vernon/North Okanagan RCMP were well prepared for all these events with operational plans and additional resources in place.

This quarter our members were involved in many great charitable events, including the annual Cops for Kids Ride, a 1000 km cycling route through southeast BC to raise funds for kids in need. The 10 day event in September involved RCMP members Cst's Nick Reimann and Krista Boudreau as well as RCMP transcriptionist Denise McMahon. Also in September our members participated in the United Way Drive-thru breakfast fundraiser, handing out bags to motorists making a donation. Both events were hugely successful and raised needed funds for the area.

This report reflects a representative sampling of our policing activities for the 3<sup>rd</sup> quarter of 2016.

#### **GENERAL INVESTIGATION SECTION (GIS)**

#### Serious Crimes Unit:

The following report is a synopsis of some of the most recent investigations that the Vernon Serious Crimes Unit (SCU) have received and investigated but does not reflect all investigations being worked on. SCU investigators continue to work on numerous other historical major cases which were initiated outside of this reporting period.

- In July, members of Vernon SCU assumed conduct of an investigation into a drive by shooting of an occupied residence in Coldstream. No injuries resulted from this shooting and the incident remains under investigation; 2016-15946.
- In July, Vernon SCU investigated the aggravated assault of an infant which occurred earlier in the spring. The investigation is ongoing; 2016-20618.

- In August, a traffic stop of a high risk offender (HRO) from Vernon resulted in the male being arrested for breach of undertaking of a youth court order. Subsequent search located a large quantity of drugs prepared for trafficking at the street level (total street value of \$1600). The male is facing charges of breach of an undertaking and possession for the purpose of trafficking; 2016-17301.
- In August, a foster parent providing respite for a youth in care reported the teenaged youth touched two younger children for a sexual purpose. The incident was investigated by SCU and resulted in the arrest of the teenaged youth for sexual interference; 2016-19413.
- In September, SCU members investigated three males from the Lower Mainland area associated to drug trafficking groups which led to the seizure of various quantities of powder cocaine, crack cocaine, meth and heroin with a street value of \$3600. One male youth from Surrey was arrested and released to the care of his mother; 2016-21969.
- In September, the Vernon SCU investigated a report of sexual assault and assault in Vernon. A charge of assault has been forwarded; 2016-22823.
- In September, the members of SCU assisted Vancouver Police Department with a homicide investigation. The suspect was arrested in Vernon and SCU members assisted with conducting interviews and collecting evidence; 2016-22777.

#### Domestic Violence Unit (DVU):

- This quarter DVU had 2 new Integrated Case Assessment Team (ICAT) referrals; 2016-14820 & 2016-14730.
- DVU attended a day long training seminar on technology safety for victims of Domestic Violence.
- The DVU member assisted with the implementation of a DVU position and ICAT procedures at the William's Lake Detachment.
- DVU received a \$12,000 funding grant to train local members in Crime Prevention through Environment Design to be held in November.
- DVU applied for a grant to implement the "Stop Taking it Out on your Partner" (S.T.O.P) Program in Vernon. Twenty years ago, the S.T.O.P. Program was developed in Prince George by the John Howard Society as a pro-active approach to managing the dynamics of relationships and domestic violence. The Program is expected to commence in the Spring of 2017.

## TARGETED POLICING

Officers from our Targeted Policing Unit meet regularly with numerous partner agencies including weekly Outreach meetings, monthly Interagency working group, and quarterly Mentally Disordered Offender meeting to discuss status and risk factors related to high risk offenders.

Targeted Policing provided assistance to a number of General Duty, Serious Crimes and Provincial GIS investigations as well as conducting surveillance and assisting with overall disruption as a result of a number of violent crimes during this reporting period.

#### Task Force (TF):

- In July, members arrested and subsequently charged a male and a female for possession of heroin and methamphetamine for the purpose trafficking; 2016-15264.
- In July and August, members worked with Salmon Arm Detachment to locate and arrest a male wanted on a Canada wide warrant and believed responsible for numerous property crimes in the area; 2016-16276.
- In August, members assisted general duty with the arrest of a prolific offender. The investigation led to additional charges of possession of cocaine and fentanyl for the purpose of trafficking; 2016-17360.
- In August, members executed an arrest of a drug trafficking target where the investigation supported an additional charge of possession of cocaine for the purpose of trafficking; 2016-19434.
- In September, members arrested a male for uttering threats when he attempted to confront a plain clothes officer conducting surveillance, believing the officer was a drug dealer impeding on his business. The investigation led to additional charges of possession of cocaine, heroin and methamphetamine against the male and a female; 2016-21011.

#### Crime Reduction Unit (CRU):

- Prolific Offenders: There are 25 prolific offenders identified for monitoring in our area, of which 12 are not in custody and 13 currently are in custody.
- The Crime Reduction Unit has played a prominent role in conducting patrols in key areas of the community including downtown, Polson Park, Recreation Center, Kal Tire Place and downtown Safeway areas.
- In July, CRU arrested a prolific offender for several offences including possession of stolen property obtained from a break and enter; 2016-15583.
- During patrols of the Upper Room Mission in July, CRU members observed a male with what was believed to be a concealed handgun. The subsequent arrest of the male led to the seizure of a large knife, replica handgun and drug trafficking paraphernalia; 2016-16373.
- In August, the investigation of two robberies of liquor stores and two thefts of purses at the downtown Safeway led to the identification and arrest of a suspect; 2016-19052, 2016-19244, 2016-19319, 2016-19333.

- In September, Downtown Enforcement Unit (DEU) met with several downtown Vernon businesses to discuss the recent break and enters and how RCMP and business owners could work together.
- In September, DEU arrested a male wanted Canada wide for breach of parole; 2016-21359.
- In September, the DEU conducted a short term project in Polson Park aimed at education and enforcement with the assistance of General Duty and volunteers of the Safe Communities Unit. The RCMP command post trailer was utilized for a visible police presence in the park. Volunteers provided park goers with information on personal safety and vehicle security. Uniform members were present to conduct foot patrols and enforcement. The dedicated work resulted in very positive feedback from the community, seizure of stolen property and liquor act enforcement.

## Provincial Tactical Enforcement Priority (PTEP):

- Targeted Policing continues to participate in the policing priority of identifying, profiling, selecting and targeting individuals and/or groups involved in criminal activity and, because of their association to gangs/organized crime, pose a safety risk to the community. Police attend meetings regarding criminal groups and violence impacting detachments across the Okanagan.
- There are currently seven persons/groups identified in the Vernon North Okanagan area.

## NORTH RURAL GENERAL INVESTIGATION SECTION (GIS)

The following report is a synopsis of some of the most recent investigations that the Provincial Rural General Investigation Section (GIS) have received and investigated, however does not reflect all investigations that officers are working on. Rural GIS investigators continue to work on numerous historical major cases initiated outside of this reporting period.

- In July, Rural GIS investigated the disappearance of a female who was last seen at her residence in Yankee Flats. Immediate and extensive search efforts have been undertaken. Investigators remain in regular contact with the family and foul play is not suspected; 2016-15909.
- The Rural GIS are investigating numerous suspicious fires which have occurred in the BX area over the past several months; 2016-12993.
- The Rural GIS continue to assist with a Dangerous Offender Application for an Armstrong male who is currently in custody, hearing scheduled for January 2017; 2016-12252.



#### SCHOOL RESOURCE OFFICER

After enjoying a summer break, schools are back in session and Cst Daniel Cocks is in his second year as the Vernon Detachment's School Resource Officer. Cst Cocks has been busy visiting the schools, conducting risk assessments and getting reacquainted with this year's students. As well, Cst Cocks publicly acknowledged the supporters of the 2016 Jean Minguy Memorial Youth Academy in the Morning Star dated Sunday October 2<sup>nd</sup>, 2016.

#### COMMUNITY POLICING

Vernon RCMP Volunteers consists of 58 members who have volunteered 1,133 hours this quarter, conducting 30 Speed Watch operations and having driven 4,600 km being the 'eyes and ears' of the police with Citizens on Patrol. The seven Lumby RCMP Volunteers have contributed 89 hours between Speed Watch operations and participation at local events. As well, some volunteers were able to complete a specialized marine training in order to detect invasive mussels resulting in the check of 97 vessels. The Vernon Community Safety Office currently has 22 active volunteers who donated 790.5 hours and managed 45 complaints by the public. The Safety Ambassadors conducted bike and foot patrols of parks, beaches and transient camps providing public education in personal safety.

#### AUXILIARY CONSTABLES

The RCMP's National Crime Prevention Services has developed three Auxiliary Program options. Consultation with local governments regarding those options is being led by the Province of BC's Police Services Branch through UBCM and the Local Government Contract Management Committee. The RCMP is awaiting the results of that consultation.

#### HUMAN RESOURCES

• The Vernon/North Okanagan Detachment welcomed the recent addition of many members from other detachments including Sgt. Rob Farrer, Cpl. JR Lechky, and Cpl. Darcy Reeves. As well, we are pleased to have three brand new cadets from Depot joining our team.

- Established Levels: Vernon/North Okanagan Detachment is currently at 97 Regular Members: 50 City of Vernon; 32 Provincial; 7 Coldstream; 3 Spallumcheen & 1 Splats'in First Nations.
- Funded Levels: As of September 30, 2016, the Vernon/North Okanagan Detachment billed 47.75 City of Vernon; 29.61 Provincial, 5.11 Coldstream; 2.49 Spallumcheen and .55 Splats'in First Nations.
