DELEGATION

Curtis Hodges, Monaghan Engineering and Consulting Ltd.

Re: Salmon Arm Drive Concept Design

Mr. Hodges presented a report on the scope of works to be done over a 2 year period:

- Drainage issues will be addressed. There have been some significant failures in some areas.
- No change to the design of Salmon Arm Drive. This is a rehabilitation project, not a revitalization.
- Storm sewers will be minimized and ditching will be maximized for drainage so as to not impact downstream flows.
- Pathway will be resurfaced. The 3 metre width will be maintained. Lighting will also be installed.
- A sidewalk will be installed on the north side to accommodate the area that does not have access to the walking path due to the steep grade (between crosswalk at school and 173 Salmon Arm Drive).

- Utilities storm sewer will be added as necessary. Sewer lines need a lot of work.
 They are undersized and will require complete replacement. Water pipes also need replacement.
- Street lighting existing hydro lights are not adequate. New LED street lights will be installed on street with decorative lighting on the pathway.
- A lock block wall will be installed on the steep slope of the pathway (across from Skyline Ridge) with curb and gutter.
- All problem area drainage will be curb and gutter with ditches in remaining areas.
- Timeline to tender by mid-May; tender close in mid-June; contract awarded by end of June.
- Sanitary and water connections along Salmon Arm Drive will all be replaced.
- New 8" water lines are replacing 4" ones which will help towards fire flows. Other works will still be required to increase fire flows for increased density development.
- The two phases will be split with complete works being done on one section, and then continuing with remaining section the following year.
- Allowing traffic flow during the construction will substantially increase costs, productivity and time-line. It will be best to divert traffic from the area during construction. Of course emergency access will be available.

The Chief Financial Officer then reviewed the funding formula.
