PETITIONS AND DELEGATIONS

Herman Halvorson – Area F Director

Information on RDNO Conservation Officer Service and Boat Patrol Results Re:

Mr. Halvorson provided an overview of the Shuswap Lake Watershed Sustainability Plan.

- Phase II has just been completed. An agreement has been reached on the Upper Shuswap. There is no agreement on the Lower Shuswap (Mara Lake to Mabel Lake).
- River patrols were done a few weeks ago. Fines will be given out. More patrols are being planned this year. A guardianship program is being considered.
- Looking forward to working with Enderby.
- Presentations from river user groups are available on the RDNO website.

Dave Smith, V.P – The Adams River Salmon Society

Regional Watershed Activities and Events Re:

Mr. Smith explained the role of the Adams River Salmon Society. They are dedicated to stewardship, education, enhancement and protection of salmon.

There is good news in that Department of Fisheries and Oceans (DFO) have announced that there will be no cuts to funding. The bad news is that salmon numbers are on the decline and are expected to continue to decline. There are numerous environmental issues that face the salmon population. Wild pacific salmon need help.

A list of events were provided:

- June 28 Sept 30 A film showing the migration of wild pacific salmon is being shown on the Cambie Street Bridge in Vancouver.
- Every Wednesday from July September there are interpretive walk-abouts held at Robert Haig-Brown Park.
- A Gala Fundraiser Event is taking place September 22 at Quaaout Lodge.
- October 11 12 in Chase there will be sacred ceremony and events to celebrate the return of migrating salmon.

The Adams River Salmon Society is seeking support by asking Council to consider proclaiming October as the Month of the Returning Salmon. Mr. Smith will be in touch with Council in September with the proclamation wording.

Burkhard Heimann, Lay Pastor – Enderby Seventh Day Adventist Church Re: Request for Permissive Tax Exemption

Mr. Heimann provided a brief history of the Church from when they were renting space at the United Church to acquisition of their current location on Vernon Street. It is his understanding that statutory exemption does not apply to government leased land, so all tax forgiveness must be in the form of a permissive tax exemption from Council. The church raises monies for the Conference, but they also provide assistance to the community such as their soup kitchen program.

- Allow and regulate detached suites within the community;
- Use a site specific zoning approach for regulating detached suites:
- All detached suite proposals will require an application to rezone the property to a specific detached suite zone, which would result in a Public Hearing;
- Proceed with implementing an annual permitting/licensing regime.

Subject:	Zoning Bylaw Amendment Bylaw No. 1636, 2017 - First and Second Reading

RECOMMENDATION

THAT Council gives First and Second Reading to Zoning Bylaw No. 1550, 2014 Amendment Bylaw No. 1636, 2017 and forwards it to a Public Hearing.

BACKGROUND

Since the adoption of the Official Community Plan and Zoning Bylaw in 2014, Staff have been initiating regular updates to keep these bylaws reflective of the community context.

At the Regular Council Meeting of July 17, 2017, Staff advanced a number of items for policy consideration, including:

 <u>Detached suites:</u> Council supported permitting detached suites within the community and regulating the use through a site-specific approach whereby all detached suite proposals would require an application to rezone the property to a specific detached suite zone. Council supported the proposed regulations for detached suites as well as developing an annual license/permit to manage impacts.

Council requested that rezoning applications on hillsides include a grading plan which would help Council understand the potential impacts of the proposed development. Staff note that matters related to grading, drainage, and slope stability may be addressed through existing Development Approval Information powers prior to rezoning, and no Zoning Bylaw amendment is required.

- 2. <u>Short-term vacation rentals:</u> Council chose to not proceed with permitting short-term vacation rentals within the community at this time. The Zoning Bylaw has been amended to include a provision within the General Regulations that explicitly states that short-term vacation rentals are not permitted in any zone.
- 3. <u>Marihuana-related businesses:</u> Council supported updating the Zoning Bylaw to align it with the Business License and Regulation Bylaw, with no new policy or restrictions over and above that specified in the latter.

4. <u>Minor housekeeping items</u>: Council supported updating the Zoning Bylaw to include, i) a provision whereby an increase in residential density within the Downtown Designated Parking Area would trigger the provision of additional parking stalls, and ii) a requirement for properties to have lane access in order to waive the off-street loading space requirement when located within the Downtown Designated Parked Area. Furthermore, Staff have updated the general regulations of the Bylaw to make the industrial and service commercial nuisance provisions have general application with respect to unsightliness, odour, glare, noise or other hazards.

Staff have prepared Zoning Bylaw No. 1550, 2014 Amendment Bylaw No. 1636, 2017 which will amend the Zoning Bylaw consistent with the policy direction provided by Council. Following First and Second Reading, the Bylaw will be advanced to a Public Hearing where members of the public will be given the opportunity to make representation respecting matters contained in the Bylaw.

BYLAW NO. 1636

A BYLAW TO AMEND THE CITY OF ENDERBY ZONING BYLAW NO. 1550, 2014 AND AMENDMENTS THERETO

WHEREAS pursuant to Section 479 of the *Local Government Act*, Council of the City of Enderby may, by bylaw, divide the whole or part of the City of Enderby into zones, name each zone, establish boundaries for the zones and regulate uses within those zones;

AND WHEREAS Council has created zones, named each zone, established boundaries for those zones and regulated uses within those zones by Bylaw No. 1550, cited as "The Corporation of the City of Enderby Zoning Bylaw No. 1550, 2014";

WHEREAS Council of the City of Enderby has determined to make an amendment to "The Corporation of the City of Enderby Zoning Bylaw No. 1550, 2014";

NOW THEREFORE Council of the City of Enderby, in open meeting assembled, enacts as follows:

<u>CITATION</u>

1. This bylaw may be cited as the "City of Enderby Zoning Bylaw No. 1550, 2014 Amendment Bylaw No. 1636, 2017".

AMENDMENTS

2. Amend Division Two - Interpretation of Schedule "A" of Zoning Bylaw No. 1550, 2014 by adding the definition of 'Marihuana-Related Business', 'Detached Secondary Suite', and 'Short-Term Vacation Rental' as follows:

MARIHUANA-RELATED BUSINESS means a business, not-for-profit, charity, cooperative, shared economy venture, or other entity which uses a premises for the consumption, display, storage, sale, trade or other exchange of marihuana or marihuana-containing products, including but not limited to dispensaries and compassion clubs.

DETACHED SECONDARY SUITE means a dwelling unit with a maximum floor area of 90 square meters (968.8 square feet) that is contained within a building which is accessory to a single family dwelling, and shall not include a mobile home, travel trailer, recreational vehicle, or a storage container, but specifically includes manufactured homes.

SHORT-TERM VACATION RENTAL means the rental of a dwelling unit to tourists or the vacationing public, provided that the provision of such accommodation does not constitute a tenancy pursuant to the Residential Tenancy Act.

3. Amend Division Two - Interpretation of Schedule "A" of Zoning Bylaw No. 1550, 2014 by replacing the definition of 'Secondary Suite' with the following:

Page 1 of 9

ATTACHED SECONDARY SUITE means a self-contained, accessory dwelling unit located within a single family dwelling. A secondary suite has its own separate cooking, sleeping and bathing facilities. It has direct access to outside without passing through any part of the principal unit.

- 4. Amend Schedule "A" of Zoning Bylaw No. 1550, 2014 by replacing all references to 'Secondary Suite' with 'Attached Secondary Suite'.
- 5. Amend Division Three General Regulations of Schedule "A" of Zoning Bylaw No. 1550, 2014 by adding Section 307.3.g and 307.3.h as follows:

The following uses shall be prohibited in all zones:

- g. Short-Term Vacation Rentals.
- h. Nothing shall be done which is or will become an annoyance or nuisance to the surrounding areas by reason of unsightliness, the emission of odours, liquid effluence, dust, fumes, smoke, vibration, noise or glare; nor shall anything be done which creates or causes a health, fire, explosion or other hazard, electrical interference, or undue traffic congestion.
- 6. Amend Division Three General Regulations of Schedule "A" of Zoning Bylaw No. 1550, 2014 by replacing the title of Section 308.4 as follows:

Accessory Residential Buildings and Structures in Residential Zones (Not including Detached Secondary Suites)

7. Amend Division Three - General Regulations of Schedule "A" of Zoning Bylaw No. 1550, 2014 by adding Section 316 as follows:

316 Marihuana-Related Businesses

- 1. For the purposes of this bylaw, any business, not-for-profit, charity, cooperative, shared economy venture, or other entity which uses a premises for the consumption, display, storage, sale, trade or other exchange of marihuana or marihuana-containing products shall be considered a Marihuana-Related Business.
- 2. In order to be permitted, a Marihuana-Related Business must demonstrate that the proposed use is lawful under all applicable Provincial and Federal statutes and regulations.
- 3. A Marihuana-Related Business must obtain a municipal Business License before any operation may begin.
- 4. No Marihuana-Related Business shall be located within 100 meters of any residential zone, daycare facility, preschool, playground, community centre, school, public park, civic or religious institution or any use catering to individuals under the age of 18.

8. Amend Division Three - General Regulations of Schedule "A" of Zoning Bylaw No. 1550, 2014 by adding Section 317 as follows:

317 Detached Secondary Suites

- 1. A detached secondary suite shall:
 - i. be constructed to meet the requirements of the BC Building Code;
 - ii. be located entirely to the rear of a principal single family dwelling;
 - iii. be sited equal to or farther from the side lot line than the principal single family dwelling;
 - iv. be accessible by a cleared and constructed pathway from the off-street parking stall(s) to the entrance to the suite;
 - v. have sufficient access and be appropriately serviced;
 - vi. be enclosed on all sides not facing directly upon the principal single family dwelling via solid fencing no greater than 2 m (6.562 feet) in height;
 - vii. have a floor area not to exceed 75% of the floor area of the principal single family dwelling; and
 - viii. only be permitted when at least one (1) of the registered owners of the property resides within the primary single family dwelling.
- 2. In accordance with Schedule "B" of this Bylaw, one (1) off-street parking space must be provided for each detached secondary suite.
- 3. No accessory building or structure shall be used as a dwelling unit except for an approved detached secondary suite.
- 4. Subdivision or stratification of a detached secondary suite is not permitted.
- 9. Amend Division Four Commercial Zones (C.1) of Schedule "A" of Zoning Bylaw No. 1550, 2014 by adding 'Marihuana-Related Business subject to the provisions of Section 316' as a permitted use under Section 401.1.
- 10. Amend Division Four Commercial Zones (C.1) of Schedule "A" of Zoning Bylaw No. 1550, 2014 by replacing Section 401.8 as follows:
 - 8. Off-Street Loading:

Off-street loading shall be provided and maintained in accordance with Schedule "C" of this Bylaw except that no off-street loading shall be required for properties with lane access that are located within the area designated as Downtown Designated Parking Area on Schedule "H" which is attached to and forms part of this Bylaw.

Page 3 of 9

- 11. Amend Division Four Commercial Zones (C.2) of Schedule "A" of Zoning Bylaw No. 1550, 2014 by adding 'Marihuana-Related Business subject to the provisions of Section 316' as a permitted use under Section 402.1.
- 12. Amend Division Four Commercial Zones (C.4) of Schedule "A" of Zoning Bylaw No. 1550, 2014 by adding 'Marihuana-Related Business subject to the provisions of Section 316' as a permitted use under Section 403.1.
- Amend Division Five Industrial Zones (I.1) of Schedule "A" of Zoning Bylaw No. 1550, 2014 by adding 'Marihuana-Related Business subject to the provisions of Section 316' as a permitted use under Section 501.1.
- 14. Amend Division Five Industrial Zones (I.2) of Schedule "A" of Zoning Bylaw No. 1550, 2014 by adding 'Marihuana-Related Business subject to the provisions of Section 316' as a permitted use under Section 502.1.
- 15. Amend Schedule "A" of Zoning Bylaw No. 1550, 2014 by adding Division Six -Residential Zones (R.1-B), following Division Six - Residential Zones (R.1-A), as follows:

602.a Residential Single Family with Detached Suite Zone (R.1-B)

1. <u>Permitted Uses of Land, Buildings, and Structures:</u>

The following uses and no others shall be permitted in the Residential Single Family Zone (R.1-B):

- a. Accessory residential
- c. Single family dwellings
- d. Attached secondary suites subject to the provisions of Section 602.a.12.a.
- e. Detached secondary suites subject to the provisions of Section 317
- f. Civic and public service use
- 2. <u>Accessory Residential Buildings:</u>

The siting, size, and dimensions of accessory residential buildings (not including detached secondary suites) and structures shall be in accordance with Section 308.4 of this Bylaw.

3. <u>Maximum Number of Suites:</u>

The number of suites allowed per lot shall be not more than:

a. One (1) attached secondary suite; or

- b. One (1) detached secondary suite.
- 4. Buildings Per Lot:

The number of buildings allowed per lot shall be not more than:

- a. one (1) single family dwelling; and
- b. two (2) accessory residential buildings; or
- c. one (1) accessory residential building and one (1) detached secondary suite.
- 5. Floor Area:
 - a. The floor area for a single family dwelling shall be not less than 60 m² (645.8 square feet).
 - The floor area for a detached secondary suite shall be not greater 90 m² (968.8 square feet) and not less than 36 m² (387.5 square feet).
 - c. The floor area for an attached secondary suite shall not be less than 36 m² (387.5 square feet).
- 6. Height of Buildings and Structures:
 - a. The height of single family dwellings shall not exceed the lesser of 9 m (29.53 feet) or two (2) storeys except where the average natural slope of the lot exceeds five percent (5%), in which case the height of residential dwellings on the downhill side of a road shall not exceed a height of 7 m (22.97 feet) above the centre line of the road immediately adjacent to the center of the front of the residence and residential dwellings located on the uphill side of the road shall not exceed a height of 7 m (22.97 feet) above the midpoint of the rear property line on which the residence is located. The average natural slope of the lot shall be measured from the lowest point on the lot to the uppermost point on the lot.
 - b. The height of detached secondary suites shall not exceed 4.5 m (14.76 feet).
- 7. Lot Area:

Each lot shall have an area of not less than:

- a. 560 m² if there is lane access or second street frontage; or
- b. 650 m² if there is not lane access or second street frontage.

- 8. Lot Coverage:
 - a. Maximum lot coverage shall be not greater than fifty percent (50%) of the lot area for all buildings and structures and together with driveways and parking areas shall not exceed sixty percent (60%).
 - b. The maximum combined lot coverage for all accessory buildings and structures, including detached secondary suites, shall not exceed 16%.
 - c. The maximum combined area of all accessory buildings/structures and detached secondary suites (e.g. footprint size) shall not exceed 90 m² (968.8 feet).
- 9. Lot Frontage:

Subject to the provisions of Section 1101.1.a., b., and c. of this Bylaw, each lot shall have a minimum lot frontage of:

- a. 15 m (16.40 feet) if there is lane access or second street frontage; or
- b. 18 m (59.06 feet) if there is not lane access or second street frontage.
- 10. Off-Street Parking:

Off-street parking shall be provided and maintained in accordance with the provisions of Schedule "B" of this Bylaw and the number of parking spaces required to be provided on a lot or lots, shall be determined by the use or uses being carried on such lot or lots from time to time.

- 11. <u>Setbacks:</u> [Subject to the special building line setback provisions of Section 308.5 of this Bylaw]
 - a. <u>Exterior Side Yard:</u>

An exterior side yard free of all buildings and structures shall be provided with a depth of not less than 5 m (16.40 feet) where applicable.

b. Front Yard:

A front yard free of buildings and structures shall be provided with a depth of not less than 6 m (19.68 feet), except that the front yard may be reduced to 4.5 m (14.76 feet) for single family dwellings on lots exceeding twenty percent (20%) average natural slope determined from the uppermost point on the lot to the lowest point

on the lot.

c. <u>Other Buildings:</u>

Buildings shall not be sited within 3 m (9.842 feet) of any other building.

- d. Rear Yard:
 - i. A rear yard free of buildings and structures shall be provided with a depth of not less than 6 m (19.68 feet) for single family dwellings except that the rear yard may be reduced to 4.5 m (14.76 feet) for single family dwellings on lots exceeding twenty percent (20%) average natural slope determined from the uppermost point on the lot to the lowest point on the lot.
 - ii. A rear yard free of buildings and structures shall be provided with a depth of not less than 3 m (9.84 feet) for detached secondary suites.
- e. Side Yards:
 - i. Side yards free of buildings and structures shall be provided with a width of not less than 1.2 m (3.94 feet) for single family dwellings.
 - ii. Side yards free of buildings and structures shall be provided with a width of not less than 2 m (6.56 feet) for detached secondary suites.
- f. <u>Water Bodies:</u>

Flood Construction Levels and Floodplain Setbacks of building and structures and Riparian Assessment Area setbacks for all development must conform with the provisions of Schedule "G" of this bylaw.

- 12. <u>Other Requirements:</u>
 - a. All attached secondary suites must comply with the following:
 - i. Attached secondary suites are to be located only in a single family dwelling; and
 - ii. No more than one attached secondary suite shall be permitted within a single family dwelling; and
 - iii. The maximum floor area of an attached secondary suite shall not exceed the lesser of 90 m² or 40% of the habitable floor area of the single family dwelling. The

minimum floor area of an attached secondary suite shall not be less than 36 m² (387.5 square feet); and

- iv. No portion of a building may be used as an attached secondary suite unless at least one (1) of the registered owners of the building resides within the building; and
- v. One (1) off-street parking space must be provided for each attached secondary suite; and
- vi. Attached secondary suites must comply with all relevant City Bylaws, and the BC Building Code; and
- vii. Attached secondary suites must be located in a building and on property which is a single family real estate entity. No strata titling will be permitted.
- b. Refer to Section 317 for the General Regulations related to detached secondary suites.
- Amend Division Nine Off-Street Parking of Schedule "B" of Zoning Bylaw No. 1550, 2014 to update Section 901.3 to include a requirement for 'Attached Secondary Suites' and 'Detached Secondary Suites' to provide a minimum of one (1) off-street parking space.
- 17. Amend Division Nine Off-Street Parking of Schedule "B" of Zoning Bylaw No. 1550, 2014 to replace Section 901.5 as follows:
 - 5. <u>Existing Buildings and Structures and Changes in Land Use in the "Downtown Designated Parking Area":</u>

Notwithstanding any other provisions of this bylaw, the regulations contained in this section shall not apply to buildings and structures existing on the effective date of this bylaw that are located in the "Downtown Designated Parking Area" designated on Schedule "A" attached to and forming part of the "Corporation of the City of Enderby Zoning Bylaw No. 966, 1987", or to any change in the use of those buildings or structures except that:

- a. Off-street parking shall be provided and maintained in accordance with this section where the total floor area is increased in excess of ten percent (10%) over the existing floor area, or where residential density is increased, in which case the amount of additional parking spaces required shall be calculated on the basis of:
 - i. the increase in the size of the existing structure exceeding ten percent; and
 - ii. the use of the addition; or
 - iii. the increase in residential density.

All crime statistics for specific areas are featured at the end of this report. Statistics reflect monthly totals for April to June 2017 and comparisons of the previous year, 2016.

It has been a very busy second quarter in the Vernon/North Okanagan as our members worked hard to achieve a 5.41% decrease in criminal code cases from the previous year. Despite proactive public awareness campaigns warning of the dangers of leaving valuables in vehicles, theft from motor vehicles remains constant and property crime is up, showing an increase of 1.78%. Our members are dedicated to our road safety initiatives, reporting a 21.8% increase in road safety check-stops conducted throughout the area.



The Jean Minguy Memorial Youth Academy was a success for the 40 students from throughout the Okanagan who participated in the week-long event, held from April 23rd to 28th. It was made possible by the many members who assisted as facilitators, including RCMP Air Service, Police Dog Service, Traffic Section and Forensic Identification Section.

In May the OIC conducted a presentation at the request of the Society for Open Learning & Discussion at the People Place in Vernon. As well, we were pleased to host a presentation by Kyle Friesen from the Department of Justice Legal Advisory Section at the Vernon library for business owners regarding retail and police cooperation. Both presentations were well attended by members of the public and fostered interesting discussions on a variety of topics.

This spring our officers were kept busy with the local flooding and activation of Emergency Operation Centers throughout our area. Officers assisted with issuing evacuation notifications, established road blocks in evacuated areas and pitched in as time permitted to help fill the hundreds of sand bags needed in Coldstream and the Okanagan Landing area.



During the summer months we notice a significant increase in use of our local beaches, parks and trails as residents and visitors take advantage of all our area has to offer. As some of these areas are difficult to access by car, we launched our EZ-GO Utility vehicle to conduct patrols ensuring these spaces remain safe for all users. The EZ-GO UTV is easily identified with the RCMP crest, police markings and a light bar.

This report reflects a representative sampling of our policing activities for the 2nd quarter of 2017.

GENERAL INVESTIGATION SECTION (GIS)

Serious Crimes Unit:

The following report is a synopsis of some of the most recent investigations that the Vernon Serious Crimes Unit (SCU) have conducted. This report does not reflect all investigations that officers are working on and does not include information which could impact ongoing police investigations or those which are of interest to, or under investigation by, other agencies. SCU investigators continue to work on numerous other historical major cases which were initiated outside of this reporting period.

- In April SCU recommended charges to Crown Counsel against an individual who had engaged in conduct with the intent to provoke a state of fear in a justice system participant. Charges were approved and the individual was arrested and released pending court; file 2017-4508.
- In May SCU assumed conduct of an investigation of the attempted murder of a subject in Vernon. This matter is still under investigation; file 2017-09802.
- In June SCU investigated two separate reports from BC Integrated Child Exploitation Unit (BCICE). The first investigation was regarding explicit videos of a teenaged person being uploaded to the internet. Investigators determined the young person had uploaded the videos by their own motivation and there were no exploitation or child protection concerns; 2017-11929. The second investigation involved child explicit materials being accessed on the internet which resulted in the arrest of a Vernon male for child pornography related offences; 2017-12020.
- In June SCU responded to a homicide of a female in Vernon where one person was arrested and remains in-custody. SCU continues to work on the file in preparation for court; 2017-13161.

Domestic Violence Unit (DVU):

- The DVU is monitoring two in custody high risk offenders. One offender has significant charges from 4 different communities throughout BC and was arrested on 21 outstanding warrants. The other has new charges laid against him for impersonating his defense lawyer.
- There were 3 new Integrated Case Assessment Team (ICAT) referrals to DVU this quarter.
- In April Vernon DVU assisted the newly appointed Kamloops DVU member with training regarding the ICAT process.

TARGETED POLICING

Targeted Policing provided assistance to a number of General Duty, Serious Crimes and Provincial GIS investigations. In an effort to continue working closely with partner agencies and stakeholders, the Targeted Policing Unit meet regularly with numerous partner agencies including Outreach, Interagency, Mentally Disordered Offenders, COOL Team and Public Spaces Action Team, which began as a multi-agency approach to harmful behaviors and safety concerns in and around the Vernon library and other public areas.

Task Force (TF):

- In April Task Force members conducted a traffic stop and arrested a male on outstanding warrants. A search of the vehicle located a loaded handgun. The investigation resulted in a search warrant of a related storage locker in Vernon where members seized over \$20,000 in stolen property, additional firearms, a half ounce of fentanyl, and explosives; 2017-6968 and 2017-6973.
- On June 29 Targeted Policing responded to a shooting incident in Polson Park. The investigation of that incident is ongoing; 2017-13984.

Crime Reduction Unit (Downtown Enforcement Unit & Prolific Offenders):

- Prolific Offenders: There are 22 prolific offenders identified for monitoring in our area. Of those, there are currently 11 in custody and 11 not in custody, with several residing in other jurisdictions.
- Our CRU members have been working hard to address property crime in our community. Some of our successes this quarter include:
 - An interview of a suspect in police custody for break and enter resulted in a confession to three residential break and enters; 2017-8107, 2017-9994, & 2017-10253.
 - Assisted Kamloops RCMP to locate a suspect and laptop stolen from the BC Lions training camp; 2017-12403.
 - Investigated a recovered stolen vehicle and charged a person believed to be connected to several thefts; 2017-12595.
 - Investigated a suspect believed responsible for numerous thefts from vehicles in our area. Charges are pending; 2017-13184.
 - Recovered approximately \$8,000 worth of hockey equipment stolen from a vehicle parked at the Civic Arena; 2017-13752 & 2017-13816.
- CRU has played a key role in conducting patrols and attending meetings with stakeholders to find solutions to the ongoing problems in key areas of the community, including Polson Park and the Upper Room Mission. As a part of their patrols, they interact with various members of the community which has resulted in the execution of several arrest warrants and breach of court condition charges.

Provincial Tactical Enforcement Priority (PTEP):

- Targeted Policing participated in identifying, profiling, selecting and targeting individuals and/or groups that are involved in criminal activity and/or associated to gangs/organized crime which pose a safety risk to the community. There are currently 8 such persons/groups identified from the Vernon North Okanagan area.
- Targeted Policing assisted the Combined Forces Special Enforcement Unit from Kelowna with the investigation of a South East District PTEP Target who was residing in Vernon. Investigation led to an arrest and charges.

• In May and June Targeted Policing members conducted an investigation of an identified Vernon PTEP target and his suspected drug trafficking operation which resulted in the arrest of the target and the seizure of a quantity of cocaine and suspected fentanyl. The individual has been charged with possession for the purpose of trafficking; 2017-11515.

NORTH OKANAGAN RURAL GENERAL INVESTIGATION SECTION (GIS)

The following report is a synopsis of some of the most recent investigations that the Provincial Rural General Investigation Section (GIS) have received and investigated, however does not reflect all investigations that are ongoing. Rural GIS investigators continue to work on numerous other historical major cases which were initiated outside of this reporting period.

• On May 2nd the Rural GIS members conducted an investigation regarding an invitation to sexual touching in the Armstrong area involving three youths. A suspect was arrested and the matter is before the courts; 2017-8802.

NORTH OKANAGAN RURAL GENERAL DUTY (GD)

- On April 14th police attended to a multi vehicle collision on Highway 97A south of Enderby. The driver of a north bound vehicle is subsequently facing a criminal charge of impaired driving after striking two south bound vehicles; 2017-7420.
- On April 14th unknown person(s) broke into numerous seasonal cabins on Westside Road. No suspects have been identified and the investigation continues; 2017-7431, 2017-7432, 2017-7433, 2017-7520, 2017-7527, 2017-7530, 2017-7531.
- On April 17th an elderly female wandered from her care facility in Armstrong. Police conducted patrols and the woman was located walking in the area of her former residence; 2017-7641.
- On May 4th police conducted a traffic stop of a vehicle for travelling 147 kms per hour in the posted 100 km per hour zone on Highway 97A in Armstrong, resulting in a fine for excessive speed and a seven day vehicle impound; 2017-8982.
- On May 10th an elderly male went missing from his residence in Spallumcheen during the night. Police conducted patrols and located the male uninjured, wandering on Highway 97; 2017-9387.
- On May 13th an elderly male suffering from dementia and requiring daily medication, went missing from his residence in Enderby. After a four day search, the male was located near Prince George, staying with family; 2017-9695.
- On May 24th police attempted to conduct a traffic stop of a new Ford pickup travelling above the posted speed limit in Enderby. The vehicle was later located abandoned and witnesses observed two persons running into the bush. The truck had been stolen from Sicamous. No suspects were identified; 2017-10619.

- On June 4th police investigated an incident where a vehicle struck the wall of the Falkland Community Hall. It was determined driver error was the cause and the driver was issued a fine under the Motor Vehicle Act; 2017-11653.
- On June 9th police received a report of a possible impaired driver on Highway 97 in Falkland. As our officer drove north to intercept the vehicle, he discovered a collision involving the suspect. It was determined the vehicle had crossed the center line and struck a southbound transport truck. The driver and lone occupant of the vehicle was deceased on scene and South East District Traffic Services has conduct of the investigation; 2017-12165, 2017-12168.
- On June 13th police investigated a report of a vehicle stolen from a residence in Grindrod. The vehicle was located in Salmon Arm, no suspects identified; 2017-12474.
- On June 29th officers responded to a plane crash in a field off Deep Creek Road in Enderby. The pilot and lone occupant of the ultralight aircraft was discovered deceased. Transport Canada and the BC Coroner's service have conduct of the investigation; 2017-14016.
- On June 26, the Armstrong Chamber of Commerce hosted a "Countdown to Canada Day" event where five members of the North Rural RCMP set up a bike rodeo for the children in attendance. Police had the participants maneuver a course and conducted bike safety checks.



Our PDS officers attended to the Jean Minguy Memorial Youth Academy to provide a PDS demonstration to the students. PDS has been involved in many incidents including;

- The track of an intoxicated female in Lumby who threatened to burn down a house; 2017-9764.
- The successful track of a person who fled from a stolen vehicle in Vernon and was located hiding behind a mobile home unit; 2017-12160.

- Conducted a search of the area in the vicinity of the homicide in Vernon; 2017-13161.
- Attended the shooting in Polson Park and conducted a search of the area for possible suspects and evidence; 2017-13984.

RESERVISTS

The Vernon/North Okanagan reservist constables conduct targeted traffic enforcement in our communities as well as participate in other duties to support of our General Duty and specialized units such as crime scene security, in-house training and liaising with Search & Rescue.

SCHOOL RESOURCE OFFICER (SRO)

The 2017 RCMP Jean Minguy Memorial Youth Academy was held April 23 to 29 at the Vernon Army Camp and involved 40 students from throughout the Okanagan. It was a very busy week for Cst Cocks who ensured the event was a successful and enjoyable experience for the youth, facilitators and numerous volunteers who made it possible.

COMMUNITY POLICING

The Vernon RCMP Volunteers currently have 53 active volunteers who have assisted with the RCMP Youth Academy, Lumby Days, Predator Ridge Stampede and the ICBC Speed Watch Challenge.

- The Citizens on Patrol have driven 4,435 kilometers, conducted 49 night time patrols and checked 2,718 license plates.
- The Speed Watch volunteers have set up 40 operations and have clocked 17,786 vehicles.
- A definite highlight in May was the volunteers' assistance to Vernon Search and Rescue in locating a missing 82 year old woman who was found unconscious in a wooded area, a short distance from her residence.
- The 4 Lumby RCMP Volunteers participated in Lumby Days and conducted 106 hours of patrols and 8 hours of Speed Watch Operations, involving 487 vehicles.
- The Community Safety Unit has been busy with their 17 volunteers donating 765 hours of their time, ensuring the office is open and accessible to the public.
- The coordinator continues to be involved in several action teams including the COOL Team's weekly visits to the tent camps, the Sharps Action Team to safely dispose discarded needles found in the parks and the Public Spaces Action Team to address public disorder in Vernon.

• The North Okanagan Restorative Justice Program received four referrals this quarter.

AUXILIARY CONSTABLES

There have been no further updates with regards to the changes to the RCMP Auxiliary Constable Program; no decision has been reached regarding a training standard or uniform requirement. The Vernon/North Okanagan Detachment will await further direction from National Headquarters with regards to the implementation of a three tiered program.

HUMAN RESOURCES

As typical within the RCMP, we saw many transfers this spring to our area, including Sgt. Justin Thiessen from Bella Coola to Armstrong, Cpl. Kris Josephson from the Sunshine Coast and Cst. Vince Bixby from East Kootney to Falkland. As well we welcomed two new recruits to our area from Depot. Outgoing we would like to congratulate Cst. Ted Bowen from our Lumby Detachment who was promoted to the corporals position in charge of Midway.

- Established Levels: Vernon/North Okanagan Detachment is currently at 100 Regular Members: 56 City of Vernon; 33 Provincial; 7 Coldstream; 3 Spallumcheen & 1 Splats'in First Nation.
- Funded Levels: As of the June 30th, 2017, the Vernon/North Okanagan Detachment billed 51.13 City of Vernon; 32.3 Provincial, 4.87 Coldstream; 2 Spallumcheen and 1 Splatsin First Nations.



PURPOSE:

The City will consider approving the temporary closure of municipal roads for a community event.

POLICY:

Temporary road closures will only be considered for community events which are sponsored by a recognized organization.

The Chief Administrative Officer or designate is granted the authority to approve a Temporary Road Closure Permit on behalf of Council, subject to the applicant meeting all the requirements of this policy. First time events must be approved by City Council.

A completed Schedule A, "Application for Temporary Road Closure," shall be submitted to City Hall at least 21 days prior to the closure. The application must include a map of the proposed road closure and emergency access through the closure. Applications for first-time or relocated events requiring Council approval must be submitted two months prior to the closure.

The organizer shall notify and consult with business owners within a one-block radius of the proposed road closure and residents adjacent to the proposed road closure. The organizer agrees to take reasonable steps to mitigate disruption for affected business owners and residents. Failure to adequately notify and consult affected businesses and residents may result in revocation of permit or refusal of future applications. Unless exempted by Council, all first-time or relocated event applications must include a petition signed by a majority of affected business owners agreeing to the proposed event.

The applicant for a Temporary Road Closure must submit proof of public liability and property damage insurance in a form acceptable to the City. The applicant may request that insurance requirements be waived based on the risk profile of the event. Such waiver does not affect any other responsibility of the applicant to obtain insurance.

The applicant shall be responsible for all traffic management, including the provision, set up, and removal of signs and barricades on the same day as the road closure.

The applicant shall be responsible for ensuring that all food service establishments, including but not limited to mobile vending units, food services at temporary events, and sellers of home-prepared foods, shall have the appropriate authorization or permit from Interior Health.

The applicant shall be responsible for emptying municipal garbage receptacles and cleaning up litter from the road closure area on the same day as the closure.

As a condition of permit, the City of Enderby will not be liable or otherwise responsible for any scheduling conflict, revocation, refusal, maintenance closure or other damage or harm related to the issuance of this permit.

RECOMMENDATION

THAT, pursuant to the provisions of Section 346 of the *Local Government Act*, Council does hereby consent, on behalf of the electors of the City of Enderby, to the Board of the Regional District of North Okanagan adopting University of British Columbia – Okanagan Connector (UBCO) Transit Service Amendment Bylaw No. 2752, 2017.

BACKGROUND

The Board of the Regional District of North Okanagan resolved at its meeting on July 19, 2017 to refer Bylaw No. 2752 to the service participants for consent. Under section 349(1)(b) of the *Local Government Act*, an establishing bylaw may only be amended with the consent of two-thirds of the service participants. Under section 346 of the *Local Government Act*, a Council may give participating area approval by consenting on behalf of the electors to the adoption of the proposed bylaw and then notifying the Board of its consent.

Bylaw No. 2752 proposes to adjust the apportionment of net annual costs of the UBCO Connector from ridership percentages adjusted based on an "on-bus" survey conducted at least every three years to ridership percentages adjusted at least every two years based on three one-week "on-bus surveys." Statistical data from the preceding three years will now be factored into the cost apportionment formula to "smooth out" fluctuations. Should there be evidence of a survey that is obviously unusual in its ridership data, the survey will be repeated.

The proposed change will result in a net average cost per year increase to the service of \$1,950, which is allocated among the service participants. The cost increase is due to higher survey costs associated with the methodology selected by the Board. As Enderby's ridership percentage is relatively small, and proportional to its contribution to the service (approximately 0.3%), the amendment should not have a significant impact for Enderby taxpayers.

BACKGROUND:

At the February 22, 2017 Board of Directors meeting, the following motion was carried:

"That staff be directed to report back on funding options for the UBCO Connector Transit (872) service."

At the May 3, 2017 Board of Directors meeting, the following motion was carried:

"That staff be directed to proceed with the process to amend the University of British Columbia – Okanagan Connector (UBCO) Transit Service Establishment Bylaw 2547, 2012, Section 6 – Cost Recovery that reflects an annual 'on bus' ridership survey in accordance with Option 2b, including the proposed weighting as described in the report dated April 25, 2017 from the Manager, Regional Engineering Services titled "University of British Columbia – Okanagan Connector Transit Service Cost Allocation"."

DISCUSSION:

At the May 3, 2017 Board meeting, the report dated April 25, 2017 from the Manager, Regional Engineering Services titled "University of British Columbia – Okanagan Connector Transit Service Cost Allocation" (Attachment "C") was reviewed and the above recommendation was carried. At this meeting, an issue was raised regarding statistical accuracy. Inaccuracy could occur due to a special event such as a group of secondary school students from Armstrong riding the bus on a survey day to tour UBCO (counting each rider in both directions). This influx of riders would be unusual and thereby skew the data and increase the annual cost to the City of Armstrong.

A statistical analysis of the data from the above example would demonstrate that based on past and current ridership counts, the special event day ridership counts would result in an unfair apportionment to one (1) or more participants. Should an event like this occur, the statistical analysis would indicate that an unusual count has occurred. Staff therefore recommend that should this type of event occur, the ridership survey be re-conducted on the same bus trips(s) and on the same day(s) of the week within the same University Term.

FINANCIAL/BUDGETARY CONSIDERATIONS:

The proposed survey cost of approximately 1.2% of the overall budget appears reasonable.

WHEREAS the Regional District of North Okanagan has adopted "University of British Columbia - Okanagan Connector Transit Service Establishment Bylaw No. 2547, 2012" to establish and operate a transit service to the University of British Columbia – Okanagan (UBCO);

AND WHEREAS the Regional District is desirous to amend Section 6 - Cost Recovery;

NOW THEREFORE, the Board of the Regional District of North Okanagan, in open meeting assembled, hereby ENACTS AS FOLLOWS:

CITATION

This Bylaw may be cited as "University of British Columbia - Okanagan Connector Transit Service Establishment Amendment Bylaw No. 2752, 2017".

TEXT AMENDMENT

1. Section 6. is hereby amended by deleting the section in its entirety and replacing it with the following:

The Regional District's share of the net annual cost of the service shall be apportioned based on ridership with changes to the ridership percentages made at a minimum every two (2) years based on three (3) – 'one (1) week' 'on bus' surveys confirmed by a statistical analysis to identify any unusual counts. The ridership counts shall be recorded three (3) times annually: UBCO Winter-Term 1, Winter-Term 2 and Summer Session over a one (1) week period for each sample. The most recent three (3) years of survey data will be used to determine cost allocations per jurisdiction based on a weighting: 60% (most recent survey); 25% (next most recent survey); 15% (3rd most recent survey).

Where the statistical analysis indicates that an unusual count has occurred, the ridership survey must be re-conducted on the same bus trip(s) and on the same day(s) of the week within the same University Term.

BYLAW No. 2547

To establish a transit service within the Regional District of North Okanagan for the purpose of providing a public passenger transportation service to the University of British Columbia – Okanagan from the Vernon Transit Terminus.

WHEREAS authority is provided by Part 24, Division 4, Section 796 of the Local Government Act for the Regional District of North Okanagan Board of Directors (the "Board") to establish and operate a transit service to the University of British Columbia – Okanagan (UBCO);

AND WHEREAS the Board authorized the commencement of a regional transit system in 1994 and established a regional transit service in 1997 which currently includes transit service to the UBCO;

AND WHEREAS the Board wishes to establish a separate and distinct service for the provision of transit between the UBCO and the Vernon Transit Terminus;

NOW THEREFORE, the Regional Board of the Regional District of North Okanagan, in open meeting assembled, ENACTS AS FOLLOWS:

TITLE

1. This bylaw may be cited as the "University of British Columbia - Okanagan Connector Transit Service Establishment Bylaw No. 2547, 2012'.

ESTABLISHMENT

 The Board of the Regional District of North Okanagan hereby establishes the "University of British Columbia – Okanagan Connector Transit Service" to provide the service of transit to the service area as described in Section 4 of this bylaw.

SCOPE OF SERVICE

3. The service established by this bylaw is to provide a public passenger transportation system, in partnership with British Columbia Transit, operating within the service area as described in Section 4.

SERVICE AREA / PARTICIPATING AREA

4. The service area for the service established by Section 2 shall encompass, and the participating jurisdictions for the local service shall include the City of Armstrong, District of Coldstream, City of Enderby, Village of Lumby, Township of Spallumcheen, City of Vernon, and Electoral Areas "B", "C", "D" and "F" of the Regional District of North Okanagan.

COST RECOVERY

- 5. The annual cost of providing the service shall be recovered by either or both of the following:
 - (1) the requisition of money under Sections 805 and 806 of the Local Government Act to be collected as a property value tax to be levied on land and improvements and collected in accordance with Sections 805.1 and 806.1 of the Act;
 - (2) the imposition of fees and other charges.
- 6. The Regional District's share of the net annual cost of the service shall be apportioned based on ridership with changes to the ridership percentages made at a minimum every two (2) years based on three (3) 'one (1) week' 'on bus' surveys confirmed by a statistical analysis to identify any unusual counts. The ridership counts shall be recorded three (3) times annually: UBCO Winter-Term 1. Winter-Term 2 and Summer Session over a one (1) week period for each sample. The most recent three (3) years of survey data will be used to determine cost allocations per jurisdiction based on a weighting: 60% (most recent survey); 25% (next most recent survey); 15% (3rd most recent survey).

Where the statistical analysis indicates that an unusual count has occurred, the ridership survey must be re-conducted on the same bus trip(s) and on the same day(s) of the week within the same University Term.

The Regional District's share of the net-annual cost of the service shall be apportioned based on ridership with changes to the ridership percentages made at a minimum every three years based on a two week 'on bus' survey. The ridership percentages are projected as follows:

MAXIMUM REQUISITION

7. The maximum amount which may be requisitioned annually for this service shall not exceed the product of a levy of \$0.10 for each \$1,000 of net taxable value of land and improvements in the service area.

WITHDRAWAL FROM SERVICE

 In addition to the withdrawal procedure under the Local Government Act, a participant may withdraw from the service at the end of the following calendar year by giving notice in writing at least six (6) months prior to the end of a calendar year.

GENERAL

- 10. The Cost Allocation Formula in Section 6 will be reviewed annually to incorporate any updates to ridership information.
- 11. The Regional District may provide the service through its own resources or by entering into contractual agreements.

That staff be directed to proceed with the process to amend the University of British Columbia – Okanagan Connector (UBCO) Transit Service Establishment Bylaw 2547, 2012, Section 6 – Cost Recovery that reflects an annual on bus' ridership survey in accordance with Option 2b, including the proposed weighting as described in the report dated April 25, 2017 from the Manager, Regional Engineering Services titled "University of British Columbia – Okanagan Connector Transit Service Cost Allocation".

BACKGROUND:

At the February 22, 2017 Board of Directors meeting, the following motion was carried:

"That staff be directed to report back on funding options for the UBCO Connector Transit (872) service."

As part of the 2017 budget discussion, the Board of Directors requested information on how cost percentages were established for the UBCO Connector Transit Service and expressed concerns that the current method can generate significant fluctuations in amount participants are required to pay for the service following a new ridership survey. A desire to include multiple surveys with a higher weighing for the most recent survey in the determination of each jurisdictions' cost share was expressed by the Board. Another concern expressed was the seasonality of the ridership and whether the survey could be completed over multiple times of the year.

In 2012, the University of British Columbia – Okanagan Connector (UBCO) Transit Service was established by Bylaw 2547, 2012 (attached). Section 6 states that the allocation of costs for the participants is as follows:

"The Regional District's share of the net annual cost of the service shall be apportioned based on ridership with changes to the ridership percentages made at a minimum every three years based on a two week 'on bus' survey."

Recent correspondence with the Ministry of Community, Sport and Cultural Development, states that the Service Establishment Bylaw must contain the entire procedure for gathering the data and outline in detail the procedure (including the mathematical method) to determine the resulting percentage of total cost that each participating area will bear.

Ridership surveys have been conducted since 2012 as follows:

2012 - November 14, 16, 19, 20, and 22 - by two (2) employees

2013 - October 7, 8, 9, 10, 15, 16, 17, 18, 21, and 25 - by one (1) employee

2016 - October 31, November 1, 2, 9, 15, 17, 18, 21, 24, and 25 - by one (1) employee

The procedure used to conduct the 'on bus' surveys was the same for each year and included the following:

- 1. One or two RDNO employees rode each of the two (2) buses on each week day (Monday to Friday) to ensure data from each day, each trip and each bus was captured.
- The RDNO employee asked each rider boarding at each stop to provide their postal code, and if they didn't know it, to provide their house number and street or their street and closest cross street. Those refusing to provide a postal code or other parts of their address were listed as 'Other'.
- 3. Data was compiled using a GIS mapping technique to determine the jurisdiction for each postal code or address recorded.
- 4. The riders for jurisdictions not in the service area were removed and the remaining number of riders for each jurisdiction were divided by the total in the service area in the given year.
- 5. 100% of the data set for a given survey was used for the cost allocations. There has been no averaging of surveys.

The above procedure was not formalized in an RDNO policy or procedure.

Since 2012, cost allocations have been based on the following:

Along with each of the three (3) surveys, BC Transit assisted with the collection of additional data from a questionnaire designed by staff and BC Transit. This information assists with transit planning.

DISCUSSION:

The three (3) surveys listed above have shown that the percentages fluctuate for some participants quite severely and for others not at all from year to year. In order to achieve a budget process that can harmonize the fluctuations in ridership and revenue requirements and to collect data that reflects year round ridership numbers, we assessed three (3) options. The options vary the frequency, time periods for data collection and methods for averaging the data sets over a longer time frame. Note that the number of trips per day varies between summer and fall/winter/spring and weekday and weekend days (when Saturday service begins). The type of rider will vary as well between seasons, for instance, the typical rider in the summer will not be a student.

Given the majority of the riders are students that attend post-secondary education facilities, the ridership surveys should reflect instructional terms. The UBCO currently has the following terms: Winter-Term 1 (September – December), Winter-Term 2 (January – April) and two Summer Sessions (Term 1 of Summer Session begins in early May and continues through July and Term 2 of Summer Session begins in early July and ends in late August). There are numerous options that could be reviewed, however, we are presenting only three (3) options for comparison that would minimize budget impact, including the following:

Option 1: Status Quo, a representative sample of ridership is recorded annually in the fall (Winter – Term 1 Session) with manual ridership counts of each scheduled trip (currently 10 round trips per day per weekday and four (4) trips per Saturday starting in 2018) over a two (2) week period from Monday to Friday and Saturday, with all trips surveyed.

Option 2 (a and b): A representative sample of ridership recorded three (3) times annually (Winter-Term 1 (in mid October), Winter-Term 2 (in mid March) and Summer Session (in mid June) over a one (1) week period for each sample. This option obtains ridership information for 50% of the bus trips over a one (1) week period, alternating one of the two buses each survey.

Option 3 (a and b): A representative sample of ridership recorded three (3) times annually (Winter-Term 1 (in mid October), Winter-Term 2 (in mid March) and Summer Session (in mid June) over a two (2) week period for each sample. This option obtains ridership information for each bus trip over a two (2) week period with both buses surveyed.

The costs shown for each option are also provided as a percentage of the BC Transit 2017/18 budgeted service cost (net municipal share of costs).

Review of Options:

Option 1 is the current method required under the existing bylaw and the resulting share of the service cost for each participant can vary significantly with each survey. Although less costly, it does not take into consideration the varying ridership between semesters, days of the week (once Saturday service begins) and gradual changes since the last survey. If we add the proposed weighting of data sets (see below) for this option, the bylaw would need to be amended, as it is not explicit with respect to how the data sets are weighted.

Option 2a and 2b above offers three snapshots through the year, but only samples 50% of the bus trips for each survey. Option 2b is less costly, however, the biennial survey may reduce the accuracy in ridership numbers. In order to ensure Option 2a and 2b methods cover each bus and each weekday, these elements of the survey will have to be carefully planned and distributed throughout each instructional semester and year. It is possible to ensure all bus trips are sampled over the survey periods.

Option 3a and 3b also offer three snapshots through the year, the sampling can occur on both buses (100% of the bus trips) for each survey, and both 3a and 3b are the most costly and they will provide the most accurate ridership numbers for each term, time period and instructional semester. These options ensure that each weekday and Saturday and each bus is surveyed each survey period. The costs for this option are significantly higher for the participants.

The current method provided for in Bylaw No. 2547 does not provide for any averaging of previous ridership counts and can result in fairly significant swings in the participants' share of the service costs. To soften these swings in the participants share it is recommended that for all five (5) options that the most recent three (3) years of survey data be used to determine cost allocations per jurisdiction for a given taxation year. It is also recommended that the three (3) years of data should be weighted to account for the most recent ridership to reflect changes in student demographics from semester to semester and other factors like ridership over the summer months. The most recent year should therefore be given the higher weighting. The recommended weighting of ridership counts for each survey year with no weighting of individual data sets (i.e. fall/spring/summer counts) is as follows:

Proposed weighting: 60% (most recent survey); 25% (next most recent survey); 15% (3rd most recent survey).

If the method selected is Option 1 (with weighting), Option 2a, 2b, 3a or 3b, the wording in Bylaw 2547, 2012 - Section 6 - Cost Recovery must be revised to reflect the detailed method of how the cost of the service is attributed to each participant. As this is a service establishment bylaw, the process will require approval of the Board and approval by at least two-thirds of the participants, and then approval by the Province. It will take at least four (4) months to complete this process. Consequently it may be feasible to have the new method of calculating the cost recovery in place for the 2018 taxation year.

Based on the above discussion, staff recommend Option 2b with the proposed weighting described above.

FINANCIAL/BUDGETARY CONSIDERATIONS:

Depending on the option chosen, the annual survey costs may change and any increase in cost will be passed on to the participants. The recommended option will result in a marginal increase in the cost to the participants. The proposed survey cost of approximately 1.2% of the overall budget appears reasonable.

It should also be noted that when BC Transit requests the addition of a questionnaire to deliver to riders during the survey, they would be requested to contribute financially to this extra scope of work, but for the annual survey cost, BC Transit would not contribute financially.

BYLAW No. 2547

To establish a transit service within the Regional District of North Okanagan for the purpose of providing a public passenger transportation service to the University of British Columbia – Okanagan from the Vernon Transit Terminus.

WHEREAS authority is provided by Part 24, Division 4, Section 796 of the Local Government Act for the Regional District of North Okanagan Board of Directors (the "Board") to establish and operate a transit service to the University of British Columbia – Okanagan (UBCO);

AND WHEREAS the Board authorized the commencement of a regional transit system in 1994 and established a regional transit service in 1997 which currently includes transit service to the UBCO;

AND WHEREAS the Board wishes to establish a separate and distinct service for the provision of transit between the UBCO and the Vernon Transit Terminus;

NOW THEREFORE, the Regional Board of the Regional District of North Okanagan, in open meeting assembled, ENACTS AS FOLLOWS:

TITLE

1. This bylaw may be cited as the "University of British Columbia - Okanagan Connector Transit Service Establishment Bylaw No. 2547, 2012".

ESTABLISHMENT

 The Board of the Regional District of North Okanagan hereby establishes the "University of British Columbia – Okanagan Connector Transit Service" to provide the service of transit to the service area as described in Section 4 of this bylaw.

SCOPE OF SERVICE

3. The service established by this bylaw is to provide a public passenger transportation system, in partnership with British Columbia Transit, operating within the service area as described in Section 4.

SERVICE AREA / PARTICIPATING AREA

4. The service area for the service established by Section 2 shall encompass, and the participating jurisdictions for the local service shall include the City of Armstrong, District of Coldstream, City of Enderby, Village of Lumby, Township of Spallumcheen, City of Vernon, and Electoral Areas "B", "C", "D" and "F" of the Regional District of North Okanagan.

COST RECOVERY

- 5. The annual cost of providing the service shall be recovered by either or both of the following:
 - (1) the requisition of money under Sections 805 and 806 of the Local Government Act to be collected as a property value tax to be levied on land and improvements and collected in accordance with Sections 805.1 and 806.1 of the Act;
 - (2) the imposition of fees and other charges.
- 6. The Regional District's share of the net annual cost of the service shall be apportioned based on ridership with changes to the ridership percentages made at a minimum every three years based on a two week 'on bus' survey. The ridership percentages are projected as follows:

MAXIMUM REQUISITION

 The maximum amount which may be requisitioned annually for this service shall not exceed the product of a levy of \$0.10 for each \$1,000 of net taxable value of land and improvements in the service area.

WITHDRAWAL FROM SERVICE

 In addition to the withdrawal procedure under the Local Government Act, a participant may withdraw from the service at the end of the following calendar year by giving notice in writing at least six (6) months prior to the end of a calendar year.

GENERAL

- 10. The Cost Allocation Formula in Section 6 will be reviewed annually to incorporate any updates to ridership information.
- 11. The Regional District may provide the service through its own resources or by entering into contractual agreements.

A bylaw to amend the public passenger transportation service to the University of British Columbia – Okanagan from the Vernon Transit Terminus.

WHEREAS the Regional District of North Okanagan has adopted "University of British Columbia - Okanagan Connector Transit Service Establishment Bylaw No. 2547, 2012" to establish and operate a transit service to the University of British Columbia – Okanagan (UBCO);

AND WHEREAS the Regional District is desirous to amend Section 6 - Cost Recovery;

NOW THEREFORE, the Board of the Regional District of North Okanagan, in open meeting assembled, hereby ENACTS AS FOLLOWS:

CITATION

This Bylaw may be cited as "University of British Columbia - Okanagan Connector Transit Service Establishment Amendment Bylaw No. 2752, 2017".

TEXT AMENDMENT

 Section 6. is hereby amended by deleting the section in its entirety and replacing it with the following:

The Regional District's share of the net annual cost of the service shall be apportioned based on ridership with changes to the ridership percentages made at a minimum every two (2) years based on three (3) – 'one (1) week' 'on bus' surveys confirmed by a statistical analysis to identify any unusual counts. The ridership counts shall be recorded three (3) times annually: UBCO Winter-Term 1, Winter-Term 2 and Summer Session over a one (1) week period for each sample. The most recent three (3) years of survey data will be used to determine cost allocations per jurisdiction based on a weighting: 60% (most recent survey); 25% (next most recent survey); 15% (3rd most recent survey).

Where the statistical analysis indicates that an unusual count has occurred, the ridership survey must be re-conducted on the same bus trip(s) and on the same day(s) of the week within the same University Term.




What was your main reason for making this trip?

If Saturday service was introduced on the 90 UBCO Connector, would you use it?












RECOMMENDATION

THAT Council approves Marilyn Hareuther's request to serve alcohol, including spirits, at the Enderby Lions Gazebo until 1:00 am on August 26, 2017;

AND THAT Council directs Staff to relax enforcement of the noise provisions of the City's bylaws until 1:00 am on August 26, 2017, and advise Ms. Hareuther that noise must be kept to a reasonable level and, notwithstanding any bylaw, may still be subject to RCMP enforcement;

AND THAT Council approves Sheila Rozenberg's request to serve alcohol, including spirits, at the Enderby Lions Gazebo until 1:00 am on Saturday September 2, 2017;

AND THAT Council directs Staff to relax enforcement of the noise provisions of the City's bylaws until 1:00 am on September 2, 2017, and advise Ms. Rozenberg that noise must be kept to a reasonable level and, notwithstanding any bylaw, may still be subject to RCMP enforcement.

BACKGROUND

The BC Liquor Distribution Branch (BCLDB) administers the issuance of Special Event Permits (SEP) to event hosts who wish to provide temporary or infrequent liquor service at events such as family gatherings, private functions, community festivals and manufacturer tastings. A SEP permits the host to serve or sell liquor at an event in accordance with BC's liquor laws and regulations. With regards to the serving of liquor at publicly owned facilities, such as the Enderby Lions Gazebo, a local government may impose conditions or restrictions on the use of those facilities (including rentals) which are over and above the provincial liquor laws and regulations.

The BCLDB looks for local government support for SEP applications, particularly when certain exemptions are requested. Council has delegated to staff, by way of the attached policy, the authority to consider event liquor licenses up to 12:00 am provided no hard alcohol is served; if an event is ending after 12:00 pm, or if hard alcohol is served at any time, the request must be considered by Council.

Event hosts may also request that Council not enforce the noise provisions of its local bylaws, although this is completely separate from Council's policy regarding event liquor licenses. There have been previous instances where Council has chosen to not enforce the noise provisions of its bylaws until a certain time, but it should be noted that this could potentially generate some neighbourhood complaints. It should also be noted that any Council decision regarding non-enforcement would not have any bearing on whether or not the RCMP chooses to enforce on their end; it only speaks to the non-enforcement of City bylaws.

Attached are requests from Marilyn Hareuther and Sheila Rozenberg who are proposing to serve liquor, including spirits, until 1:00 am at the Enderby Lions Gazebo, which they've rented for their wedding receptions on August 26, 2017 and September 2, 2017 respectively. Given that the events are proposed to go past 12:00 am, and hard alcohol is proposed to be served, these requests will need to be considered by Council. Staff are also recommending that Council considers the event hosts' requests to not enforce the noise provisions of the City's bylaws until 1:00 am. In order to strike a balance, Staff have recommended instead that 'relaxation' of the noise provisions of local bylaws may send a more appropriate message that noise should still be kept to a reasonable level out of respect for the surrounding neighbourhood.
