PORTFOLIO REPORTS

Councillor Schreiner

- UBCM
 - Minister meetings were all good.
 - Our Ride-Sharing resolution passed. Uber is not looking at smaller communities because they would need enough drivers to be a reliable service, although there are other ride-sharing services that may fit.
- Traffic Lights on Bridge:
 - The Chief Administrative Officer reported that there will be some interruptions on the Bridge for pedestrians and cyclists for the next little while until the south sidewalk is re-opened. He is working with the bridge contractor and Ministry.
- Salmon Arm Drive:
 - The Chief Administrative Officer reported that the project is on schedule. String lines are going in and curbs after that.
