<u>Telus – Steve Jenkins, General Manager – Okanagan and Kootenay Regions</u> Re: Presentation on Telus Initiatives

Mr Jenkins explained the technology that could be used for the Cliffs Crunch application. There is good cell phone coverage at the top of the trail. Power may be required at the parking lot. A kiosk could be set up where people could buy a chip, start their hike, and access solar powered entities along the way. Mr Jenkins asked to arrange for an in camera meeting so that he could describe some of Telus' upcoming business plans in Enderby.

## **REPORTS**

Councillor Baird – said that the Rail Trail meeting was intriguing.

<u>Councillor Schreiner</u> – attended the rail trail meeting and want to ensure that Enderby has a seat at the table for planning the future use of this corridor. Attended the wildfire plan open house and noted good attendance.

<u>Councillor Shishido</u> – discussed the 5-way intersection and Belvedere. The CAO noted that some design improvements are being worked on, but these would be temporary in nature given potential changes to the intersection owing to the rail trail and Highway 97A future alignment, both of which may impact any hard infrastructure.

<u>Mayor McCune</u> noted a large tree on Evergreen that is affecting sightlines and appears unhealthy. The CAO said that it would be cleaned up or removed depending upon its condition.

<u>Councillor Baird</u> noted that rosebushes as Johnson Meir Insurance were also affecting sightlines. The CAO will direct bylaw enforcement to follow up.

<u>Mayor McCune</u> noted that there is a tree on Johnston that is also interfering with sightlines, near the intersection with Cliffview.

The CAO noted that some hazard trees were going to be removed at the cemetery. Removal will be timed so as not to coincide with a funeral service.

<u>Councillor Knust</u> – Harvest Hut mural was very successful. The artist would next like to paint the commercial garbage disposal screen at the Russell Avenue parking lot. The artist intends to use "mis-tints" from the Harvest Hut project to create a colour spectrum designed to celebrate difference and inclusion.

Councillor Shishido asked whether or not the proposed mural may send a political message. Mayor McCune said that he did not feel that it was political, but rather social. Council discussed what public art should do and represent.

Moved by Councillor Knust, seconded by Councillor Baird that the mural on the Russell Avenue parking lot disposal screen be approved, and that \$600 be advanced to the artist, Heather Edwards, to honour her time, talent, and costs.

#### RECOMMENDATION

THAT Council gives Three Readings to the City of Enderby Public Spaces Bylaw No. 1604, 2016 Amendment Bylaw No. 1655, 2018;

AND THAT Council gives Three Readings to the City of Enderby Fees and Charges Bylaw No. 1479, 2010 Amendment Bylaw No. 1656, 2018;

AND THAT Council gives Three Readings to the City of Enderby Bylaw Notice Enforcement Bylaw No. 1581, 2015 Amendment Bylaw No. 1657, 2018;

AND THAT Council gives Three Readings to the City of Enderby Municipal Ticketing Information System Bylaw No. 1518, 2013 Amendment Bylaw No. 1658, 2018;

AND THAT Council adopts the attached Provincial Non-Medical Cannabis Retail Licence Referral Applications Policy;

AND THAT Council adopts the attached Personal Growing of Cannabis Policy;

AND THAT Council directs Staff to prepare an amendment to the City of Enderby Zoning Bylaw No. 1550 to prohibit the personal growing of cannabis in the following circumstances:

- i. In any mobile unit used on a permanent or temporary basis as a residence, or the land contiguous to the unit, or a building or structure on land contiguous to the mobile unit;
- ii. In any building or structure kept or occupied as a temporary residence, or the land contiguous to the temporary residence, or a building or structure on land contiguous to the temporary residence;
- iii. In any residential dwelling unit occurring as part of a mixed use development.

AND THAT Council directs Staff to prepare an amendment to the City of Enderby Zoning Bylaw No. 1550, 2014 in order to, i) regulate the production of non-medical cannabis in the same manner as medical cannabis, and ii) update definitions and references to be consistent with the language used in the Provincial and Federal Cannabis enactments.

#### ADDITIONAL RESOLUTIONS FOR COUNCIL CONSIDERATION

THAT Council directs Staff to prepare an amendment to the City of Enderby Zoning Bylaw No. 1550 to prohibit the personal growing of cannabis in multiple-occupancy buildings where there are shared walls between dwelling units.

THAT Council directs Staff to prepare an amendment to the City of Enderby Zoning Bylaw No. 1550 to prohibit the personal growing of cannabis outdoors.

#### BACKGROUND

At its regular meeting of June 4, 2018, Enderby City Council provided policy direction on how it wished to regulate non-medical cannabis. Specifically, Council resolved to:

- Maintain the existing Zoning Bylaw provisions for the retail of non-medical cannabis;
- Maintain the existing Business License and Regulation Bylaw provisions for the retail of nonmedical cannabis with Staff to monitor relative to Provincial regulatory changes and enforcement;
- Direct Staff to prepare an application intake procedure for applicants of a Provincial Non-Medical Cannabis Retail Licence, and prepare an amendment to the Fees and Charges Bylaw to include an application fee of \$1,000;
- Amend the Public Spaces Bylaw to regulate the smoking and vaping of cannabis in public spaces in the same manner as the consumption of alcohol; and
- Direct Staff to prepare a permitting system for the personal growing of cannabis which aims to ensure public safety, prevent nuisances, and preserve property values and building safety.

Staff have prepared amendment bylaws in accordance with the policy direction above, and are now advancing proposed regulations for the personal growing and commercial production of non-medical cannabis for Council's consideration.

#### Personal Growing of Cannabis

Under the *Cannabis Control and Licensing Act*, adults are permitted to grow up to four cannabis plants in a 'dwelling house' as long as the adult ordinarily resides at the dwelling house, the plants are not visible from public spaces off the property, and growing is not occurring in a home used as a day-care. The Act defines a 'dwelling house' as:

a) all or part of a building or structure that the adult keeps or occupies as a permanent or temporary residence and the land under the building or structure, including

(i) land that is contiguous to the building or structure and that the adult may use in conjunction with the building or structure, and

(ii) a building or structure on land referred to in subparagraph (i), or

b) a unit that is designed to be mobile and to be used on a permanent or temporary basis as a residence and that the adult uses as a permanent or temporary residence, including

(i) land that is contiguous to the unit and that the adult may use in conjunction with the unit, and

(ii) a building or structure on land referred to in subparagraph (i).

Staff anticipate that there will be a high demand for the personal growing of cannabis on private property which could potentially lead to a number of nuisance concerns (i.e. security, odour, etc.). It is recommended that Council directs Staff to prepare an amendment to the City of Enderby Zoning Bylaw No. 1550 to prohibit the personal growing of cannabis in the following circumstances:

i. In any <u>mobile unit</u> used on a permanent or temporary basis as a residence, or the land contiguous to the unit, or a building or structure on land contiguous to the mobile unit.

**Rationale:** A mobile unit could include vehicles such as travel trailers and motor homes. If the personal growing of cannabis were to occur in these types of vehicles, there would be a much higher potential for conflict given that these types of vehicles are not designed to be as air tight and secure as a typical residential dwelling.

ii. In any building or structure kept or occupied as a <u>temporary residence</u>, or the land contiguous to the temporary residence, or a building or structure on land contiguous to the temporary residence.

**Rationale:** Staff's concern with permitting personal growing within a 'temporary residence' is that the Province has not defined what this is. By not permitting personal growing within a 'temporary residence', Staff feel that it will prevent the exploitation of potential loopholes given the lack of a clear definition. Should the Province further define what constitutes a 'temporary residence', this prohibition may need to be revisited.

ili. In any residential dwelling occurring as part of a mixed use development.

**Rationale:** There are a number of instances throughout the community where residential dwellings accompany commercial businesses (i.e. second story apartments). In these instances, Staff anticipate that there is a high potential for conflict given that the personal growing of cannabis in the dwelling unit could impact the associated business.

Other circumstances for which Council may wish to consider prohibiting the personal growing of cannabis include multiple occupancy buildings where there are shared walls, such as row houses and apartments, as well as outdoors where cannabis plants would be more easily accessible.

In order to strengthen the City's enforcement ability should nuisances arise through the growing of cannabis, Staff are recommending that Council adopts the attached Personal Growing of Cannabis Policy whereby personal growing of cannabis is subject to the applicant obtaining a permit from the City (at no cost), with the issuance of the Permit being subject to the applicant:

- i. If renting, obtaining the written consent of the property owner;
- ii. Acknowledging that they are aware of all applicable regulations and legislation; and
- iii. Acknowledging that the City reserves the right to revoke the Permit should there be a demonstrated nuisance or if it's determined that there is a violation of any applicable regulations or legislation.

In addition, the permitting system would allow the City to maintain a record on file so that prospective property purchasers could be made aware that this activity has occurred on the property, as it may prompt a requirement for verification that the property's conditions are fully disclosed.

#### Production of Cannabis

When the Federal Government introduced the *Marihuana for Medical Purposes Regulations* for regulating medical marihuana production in 2014 (since replaced by the *Access to Cannabis for Medical Purposes Regulations* (ACMPR)), the City of Enderby adopted a Zoning Text Amendment Bylaw prohibiting medical marihuana production facilities (MMPFs) in all zones throughout the community, except in the Agricultural Land Reserve, as the Agricultural Land Commission considers the production of medical marihuana a 'farm use'. However, the City does regulate MMPFs in the Agricultural Land Reserve through setbacks, minimum lot area, servicing requirements, etc., in accordance with Section 46 of the *Agricultural Land Commission Act*.

The existing Zoning Bylaw regulations for MMPFs in the Agricultural Land Reserve are as follows:

- Minimum lot area of 5 ha (12.355 acres);
- All uses must take place entirely within a single, fully enclosed, standalone building;
- All buildings associated with a MMPF are considered an industrial building for the purposes of fire inspections;
- 30 m setback from all property lines;
- 150 m setback from any residential zone, daycare facility, playground, community centre, school, public park, or any use catering to individuals under the age of 18;
- Servicing in accordance with all applicable regulations and permitting, with on-site servicing potentially being permitted; and
- The facility must obtain a municipal business license before any operation may begin.

It should be noted that the proposed federal *Cannabis Act* states that the MMPFs licensed under the ACMPR will continue to be authorized to produce medical cannabis, but are also deemed to hold licenses for the production of *non-medical* cannabis.

The ACMPR sets forth strict requirements for MMPFs related to licensing, security, air filtration to prevent escape of odours, etc.; while it is clear that those licensed under the ACMPR who wish to produce <u>non-medical</u> cannabis will be subject to these strict requirements, it is not clear how licensed producers under the *Cannabis Act*, who are outside of the ACMPR framework, will be regulated. Given this uncertainty, it is recommended that Council direct Staff to prepare an amendment to the Zoning Bylaw to regulate the production of non-medical cannabis in the same manner as medical cannabis (i.e. prohibited in all zones except when located within the Agricultural Land Reserve, minimum lot area, setbacks, etc.). Should a prospective non-medical cannabis producer wish to operate within the City and is not able to comply with the Zoning Bylaw regulations, they have the ability to apply to Council for a Zoning Text Amendment. Council could then consider these applications on a case-by-case basis and a public hearing would be triggered so those who feel they are affected by the application could make their views known to Council.

In addition, Staff are recommending that the Zoning Bylaw be amended to update definitions and references to be consistent with the language used in the Provincial and Federal cannabis enactments.

Policy Title	Personal Growing of Cannabis

Effective Date	Adopted by Council	Replaces N/A

**PURPOSE:** To provide a permitting system for the personal growing of cannabis.

**POLICY:** The personal growing of cannabis within the City of Enderby shall be subject to the following conditions:

- 1. 'Cannabis' shall have the same definition as in the Cannabis Act.
- 2. 'Grow' shall have the same definition as in the Cannabis Control and Licensing Act.
- 3. The personal growing of cannabis is subject to the City of Enderby Zoning Bylaw No. 1550, 2014, as amended from time to time.
- 4. No person shall personally grow cannabis within the City of Enderby unless they have received a Personal Growing of Cannabis Permit from the City.
- 5. The personal growing of cannabis is subject to compliance with all local, provincial, and federal government enactments.
- 6. There is no fee associated with a Personal Growing of Cannabis Permit application but the City of Enderby may implement a fee structure at a later date.
- 7. The Chief Administrative Officer, or his/her designate, may determine the form and content of a Personal Growing of Cannabis Permit application and other materials.
- 8. The Chief Administrative Officer, or his/her designate, is delegated to issue a Personal Growing of Cannabis Permit subject to the applicant:
  - i. If renting, obtaining the written consent of the property owner;
  - ii. Acknowledging that they are aware of all applicable regulations and legislation related to the personal growing of cannabis; and
  - iii. Acknowledging that the City reserves the right to revoke the Permit should there be a demonstrated nuisance or if it's determined that there is a violation of any applicable regulations or legislation.
- 9. The Chief Administrative Officer, or his/her designate, is delegated to refuse an application or suspend or cancel a Personal Growing of Cannabis Permit if he/she is not satisfied that the applicant has complied with applicable regulations or legislation for the personal

growing of cannabis, or if he/she determines that there have been nuisances associated with the use.

- 10. The Chief Administrative Officer must advise an applicant who is subject to a decision to refuse an application, or suspend or cancel a Permit, that he or she is entitled to have Council reconsider the matter. Council may issue, restore, suspend, or cancel a Permit.
- 11. A Personal Growing of Cannabis Permit shall be automatically renewed on January 1st of each calendar year, unless the Permit has been suspended or cancelled by the Chief Administrative Officer.

Policy Title	Provincial Non-Medical Cannabis License Referral Applications

Effective Date	Adopted by Council	Replaces N/A

- **PURPOSE:** To provide a process for Council to consider applications for Provincial Non-Medical Cannabis Licenses.
- **POLICY:** When the City is considering an application for a Provincial Non-Medical Cannabis License, the applicant shall be subject to the following:
  - 1. In order for Council to consider an application for a Provincial Non-Medical Cannabis License, the applicant must submit to the City of Enderby a Provincial Non-Medical Cannabis License Referral Application.
  - 2. The Chief Administrative Officer, or his/her designate, may determine the form and content of a Provincial Non-Medical Cannabis License Referral Application or other materials.
  - 3. The applicant must pay the associated Provincial Non-Medical Cannabis License Referral Application fee as outlined in the City of Enderby Fees and Charges Bylaw No. 1479, 2010, as amended from time to time.
  - 4. In accordance with the *Cannabis Control and Licensing Act*, as amended from time to time, the City will provide an opportunity for the public to provide input on a Provincial Non-Medical Cannabis License Referral Application by:
    - i. Advertising and holding a Public Hearing in the same manner it does for other development applications; and
    - ii. Accepting written submissions in response to the application which will be read before Council at the aforementioned Public Hearing.
  - 5. Following the launch of the online application portal for Provincial Non-Medical Cannabis Retail Licences, the City will initiate a 30 period to develop its forms and other materials, during which time no Provincial Non-Medical Cannabis License Referral Applications will be accepted. Following this 30 day period, the City will initiate a 60 day initial intake period for Provincial Non-Medical Cannabis License Referral Applications and at the end of the intake period, the City will consider all applications received concurrently. For all applications received outside of the 60 day initial intake period, Council will consider the applications as they are processed by Staff.

#### BYLAW NO. 1655, 2018

# A BYLAW TO AMEND THE CITY OF ENDERBY PUBLIC SPACES BYLAW NO. 1604, 2016

WHEREAS Council of the City of Enderby has adopted "The City of Enderby Public Spaces Bylaw No. 1604, 2016";

NOW THEREFORE Council of the City of Enderby, in open meeting assembled, enacts as follows:

- 1. This bylaw may be cited as the "City of Enderby Public Spaces Bylaw No. 1604, 2016 Amendment Bylaw No. 1655, 2018".
- Section 2 DEFINITIONS AND INTERPRETATION of "City of Enderby Public Spaces Bylaw No. 1604, 2016" is hereby amended by including the definition of 'Cannabis' as follows:

"Cannabis" has the same definition as in the Cannabis Act.

- 3. Section 3 PROHIBITIONS of "City of Enderby Public Spaces Bylaw No. 1604, 2016" is hereby amended by adding Section 3.22.1 as follows:
  - 3.22.1 No person shall smoke, vape, consume or ingest Cannabis in any Public Space.

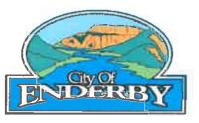

## Summary of Significant Accounting Policies

#### For the year ended December 31, 2017

#### 1. Status of the City of Enderby

The City of Enderby ("the City") is a municipality that was created on March 1, 1905 under the laws of British Columbia. The City provides municipal services such as public works, sewer, water, urban planning, fire protection services, and recreational and cultural services and other general government operations.

#### 2. Significant Accounting policies

These consolidated financial statements have been prepared by management in accordance with Canadian generally accepted accounting principles for governments established by the Public Sector Accounting Board of the Canadian Institute of Chartered Professional Accountants. The consolidated financial statements include the accounts of all funds of the City. All interfund transfers have been eliminated. The significant polices are summarized as follows:

#### a. Fund accounting

The resources and operations of the City are comprised of the funds listed below. Supporting schedules to the consolidated financial statements are included to show the financial activities and balance of each fund for supplementary information.

#### General Fund:

Accounts for operating and capital revenues and expenditures for the activities of the City except those included in the water and sewer funds and holds all property required for these purposes and related long term debt.

#### Water Fund:

Accounts for operating and capital revenues and expenditures for the water utility and holds all property required for these purposes and related long term debt.

#### Sewer Fund:

Accounts for operating and capital revenues and expenditures for the sewer utility and holds all property required for this purposes and related long term debt.

#### b. Basis of accounting

The consolidated financial statements are prepared using the accrual basis of accounting. The accrual basis of accounting records revenue as it is earned and measurable. Expenses are recognized as they are incurred and measurable based upon receipt of goods and services and/or the creation of a legal obligation to pay.

c. School taxes

The City is required by *The School Act* to bill, collect and remit provincial education support levies in respect of residential and other properties on behalf of the Province, and school division special levies on behalf of school divisions. The City has no jurisdiction or control over the school division's operations or their mill rate increases. Therefore, the taxation, other revenues, expenses, assets and liabilities with respect to the operations of school boards are not reflected in these consolidated financial statements.

#### d. Temporary investments

Temporary investments consist of term deposits in Canadian Chartered Banks and deposits with the Municipal Finance Authority pooled investment money market fund and are recorded at cost plus earnings reinvested in the funds, which approximates their quoted market value. These investments are redeemable on demand and have an effective average interest rate of 1.63% (2016 - 1.75%).

#### For the year ended December 31, 2017

#### e. Deferred revenue

÷

Grants, contributions and other amounts are received from third parties pursuant to legislation, regulation or agreement and may only be used in the conduct of certain programs, in the completion of specific work, or for the purchase of tangible capital assets. In addition, certain user charges and fees are collected for which the related services have yet to be performed. Revenue is recognized in the period when the related expenses are incurred, services performed or tangible capital assets acquired.

#### f. Non-financial assets

Non-financial assets are not available to discharge existing liabilities and are held for use in the provision of services. They have useful lives extending beyond the current year and are not intended for sale in the ordinary course of operations. The change in non-financial assets during the year, together with the excess of revenues over expenses provides the Change in Net Financial Assets for the year.

#### i. Tangible capital assets

Capital assets consist of land, buildings, engineering structures, water and sewer infrastructure, roads, and machinery and equipment. Tangible capital assets are recorded at cost which includes all amounts that are directly attributable to the cost, construction, development or betterment of the asset. The cost less residual value, of the tangible capital assets are amortized on a straight line basis over their estimated useful life as follows:

Assets under construction are not amortized until the asset is available for productive use.

#### ii. Contributions of tangible capital assets

Tangible capital assets received as contributions are recorded at their fair value at the date of receipt and also are recorded as revenue.

iii. Leases

Leases are classified as capital or operating leases. Leases which transfer substantially all of the benefits and risks incidental to ownership of property are accounted for as capital leases. All other leases are accounted for as operating leases and the related lease payments are charged to expenses as incurred.

#### g. Revenue recognition

Government grants and transfers are recognized in the financial statements as revenue in the period in which events giving rise to the transfer occur, providing the transfers are authorized, any eligibility criteria have been met, and reasonable estimates of the amounts can be made. Transfers received for expenditures not yet incurred are included in deferred revenue.

Taxation revenues are recognized at the time of issuing property tax notices for the fiscal year. Sale of services and user fees are recognized when the service or product is provided by the City. All other revenue is recognized as it is earned and is measurable. Expenses are recognized as they are incurred and measurable based upon receipt of goods and services and/or the creation of a legal obligation to pay.

#### h. Debt charges

Debt charges, including principal, interest and foreign exchange are charged to current operations. Interest charges are accrued for the period from the date of the latest interest payment to the end of the year.

#### i. Capitalization of Interest

The City capitalizes interest on temporary borrowing until the completion of the project which is to be financed by debenture debt.

#### j. Reserves

Reserves for future expenditures represent amounts set aside for future operating and capital expenditures.

#### k. Budget Figures

The budget figures are from the Financial Plan Bylaw No. 1628, 2017 adopted May 1, 2017. They have been reallocated to conform to PSAB financial statement presentation. Subsequent amendments have been made by Council to reflect changes in the budget as required by law.

#### I. Use of estimates

The consolidated financial statements of the City have been prepared by management in accordance with Canadian generally accepted accounting principles as prescribed by the Public Sector Accounting Board. As such, management is required to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. These estimates and assumptions are based on the City's best information and judgment and may differ significantly from actual results. The financial statements have, in the opinion of management been prepared using careful judgment within the reasonable limits of materiality and within the framework of the accounting policies identified.

## 4. Reserve - Municipal Finance Authority

The City issues its debt instruments through the Municipal Finance Authority. As a condition of these borrowings, a portion of the debenture proceeds are withheld by the Municipal Finance Authority as a debt reserve fund. The City also executes demand notes in connection with each debenture whereby the City may be required to loan certain amounts to the Municipal Finance Authority. These demand notes are contingent in nature and are not reflected in the accounts. The details of the cash deposits and demand notes at the year end are as follows:

## 9. Commitments and subsequent events

- (a) During the year, the City entered into a contract with Mountain Side Earthworks to upgrade the road along Salmon Arm Drive. The total budgeted amount was \$2,763,904. As at year end, approximately 30% of the project has been completed.
- (b) The amount of vacation and banked time pay has been accrued and is included in accounts payable for the current year. The estimated total liability for wages and benefits at December 31, 2017 is approximately \$130,451 (2016 - \$99,715). Of this amount \$112,105 (2016 - \$79,576) has been accrued and included in accounts payable and accrued liabilities.

## 10. Contingent liabilities

- (a) <u>Regional District of North Okanagan</u>: The City is a member of the Regional District of North Okanagan and is liable for its portion of any operating deficits or long-term debt related to functions in which it participates.
- (b) <u>Municipal Insurance Association of BC</u>: Commencing December 31, 1987, the City of Enderby entered into a self insurance scheme with British Columbia municipalities and regional districts. The City is obliged under the scheme to pay a percentage of its fellow insured's losses. The City pays an annual premium, which is anticipated to be adequate to cover any losses incurred.
- (c) Pension Liabilities: The Municipality and its employees contribute to the Municipal Pension Plan (the "Plan"), a jointly trusteed pension plan. The board of trustees, representing Plan members and employers, is responsible for administering the plan, including investment of assets and administration of benefits. The Plan is a multi-employer defined benefit pension plan. Basic pension benefits are based on a formula. As at December 31, 2016, the Plan has about 193,000 active members and approximately 90,000 retired members. Active members include approximately 38,000 contributors from local governments.

Every three years, an actuarial valuation is performed to assess the financial position of the plan and adequacy of plan funding. The actuary determines an appropriate combined employer and member contribution rate to fund the plan. The actuary's calculated contribution rate is based on the entry-age normal cost method, which produces the long-term rate of member and employer contributions sufficient to provide benefits for average future entrants to the plan. This rate may be adjusted for amortization of any actuarial funding surplus and will be adjusted for the amortization of any unfunded actuarial liability.

The most recent actuarial valuation for the Municipal Pension Plan as of December 31, 2015, indicated a \$2,224 million funding surplus for basic pension benefits on a going concern basis. As a result of the 2015 basic account actuarial valuation surplus and pursuant to the joint trustee agreement, \$1,927 million was transfered to the rate stabilization account and \$297 million of the surplus ensured the required contribution rates remained unchanged.

The Corporation for the City of Enderby paid \$75,949 (2016 - \$77,650) for employer contributions to the plan in fiscal 2017.

The next valuation will be as at December 31, 2018 with results available in 2019.

Employers participating in the Plan record their pension expense as the amount of employer contributions made during the fiscal year (defined contribution pension plan accounting). This is because the plan records accrued liabilities and accrued assets for the plan in aggregate, resulting in no consistent and reliable basis for allocating the obligation, assets and cost to individual employers participating in the plan.

# 15. Financial instruments

The City's financial instruments consist of cash, temporary investments, accounts receivable, accounts payable, deferred revenue, deposits and long term debt. The fair values of these financial instruments approximate their carrying values. It is management's opinion that the City is not exposed to significant interest, currency or credit risks arising from these financial instruments.

#### 17. Segmented information

The City of Enderby is a municipal government that provides a range of services to its citizens. For management reporting purposes the City's operations and activities are organized and reported by Fund. Funds were created for the purpose of recording specific activities to attain certain objectives in accordance with special regulations, restrictions or limitations.

City services are provided by departments and their activities are reported in these funds. Certain departments have been separately disclosed in the segmented information, along with the services they provide, as follows:

#### General government services - Legislative, administration and finance

The function of the legislative department includes mayor and council is to set bylaws and policies for the governance of the City in accordance with the Community Charter. The function of the Administration Department is to coordinate the operation of the municipality in accordance with policies set by Council. The Administration Department is responsible for functions such as personnel, organizational changes, employee review and training, manpower planning, strategic planning, information systems, GIS and records management. The mandate of the Finance Department is to achieve excellence in customer service through the efficient and effective use of technology and personal service. Also, to provide operational efficiency, financial planning and accountability through the application of sound accounting practices and internal control. The Finance Department is responsible for functions such as financial records reporting and safekeeping; investment of municipal funds; advice and guidance to Council and Administration on financial matters; financial planning and budget development and analysis; property tax and utility user fee notification and collection; accounts payable and receivable; payroll, pension and benefits administration; records maintenance of tickets, fines and other municipal business.

#### Protective services - Fire and animal control services

The mandate of the Fire Department is to provide fire suppression service; fire prevention programs; training and education related to prevention, detection or extinguishment of fires. The mandate of Animal Control is to control the animal population and the issuance of dog licenses.

#### Public works services

The public works department is responsible for the delivery of municipal public works services related to the planning, development and maintenance of roadway systems, and street lighting.

#### Environmental health services

The mandate of environmental health services is to provide for the collection, disposal and recycling services; and waste minimization programs of solid waste.

#### Community development services

Community development provides services to manage urban development for business interests, environmental concerns, heritage matters, local neighbourhoods and downtown, through City planning, community development, parks and riverbank planning. It ensures an acceptable quality of building construction and maintenance of properties through enforcement of construction codes, building standards and bylaws for the protection of occupants. It facilitates economic development by providing services for the approval of all land development plans, the application and enforcement of zoning bylaws, and the processing of building permit applications.

#### Recreational and cultural services

The recreational and cultural services mandate in cooperation with the Regional District is to provide for the maintenance of parks and open space.

#### Area F Services

The City administers Fortune Parks, Animal Control & Cemetery services for the citizens of Area F.

#### 18. Segmented Information (cont'd)

#### Water supply and services

The water department provides for the delivery of safe drinking water to the citizens of Enderby.

## Sewer services

The sewer department provides for the collection and treatment of wastewater.

Certain allocation methodologies are employed in the preparation of segmented financial information. The General Revenue Fund reports on municipal services that are funded primarily by taxation such as property and business tax revenues. Taxation and payments-in-lieu of taxes are apportioned to General Revenue Fund services based on the Fund's net surplus. Certain government grants, transfers from and to other funds, and other revenues have been apportioned based on a percentage of budgeted expenses.

The accounting policies used in these segments are consistent with those followed in preparation of the consolidated financial statements as disclosed in Note 2. For additional information see the Consolidated Schedule of Segment Disclosure - Service (Schedule 1).

# Re: Cannabis Related Legislation

With the upcoming legalization of cannabis in Canada, we are writing to express our concerns around siting library facilities next to non-family friendly businesses, such as BC cannabis stores.

At the Library Board Meeting held May 16, 2018, the Board passed a motion to add language to the ORL's Facilities Policy as noted below that, though driven by the current cannabis discussion, was broad enough to cover other things that will raise similar issues:

"Consideration should also be given to surrounding businesses and activities so as to avoid, as much as possible, adjacency to non-family friendly or incompatible uses."

The Library Board directed that we write each of our members to request that when you are creating bylaws related to land use and zoning, and retail locations of cannabis-related businesses, you consider their proximity to public libraries in the same context as schools, daycares, youth centres and other sensitive areas.

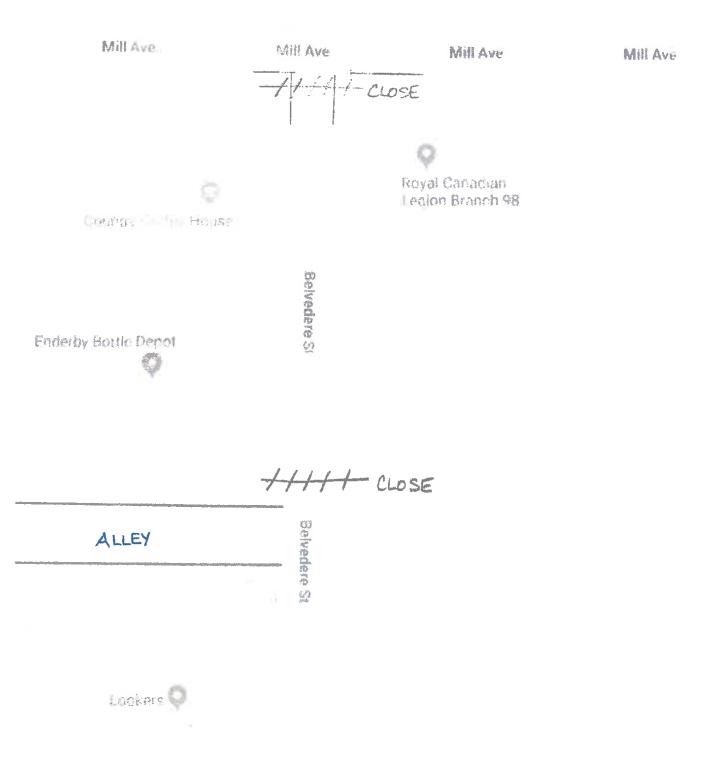
