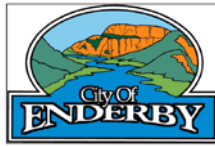

### **PORTFOLIO REPORTS**

#### Councillor Schreiner

- RDNO has developed a Terms of Reference for the Rail Trail Committee. This includes Lumby, Spallumcheen, Armstrong, Electoral Area D and F.
- RCMP Strategic Meeting.

*Councillor Case entered the room (4:06 p.m.)*

- The CAO gave an update on exploring options for lighting the Riverwalk. Looking at a rustic post and beam fence with lighting underneath. This could serve as a barrier to the

riparian area, improve public safety, and provide a light source that is non-intrusive yet still effective. Likely an opportunity to seek grant funding.

*“That Staff develop the concept of a lighted fence for the Riverwalk and report back with further details and an analysis of potential grant funding opportunities.”*

- Councillor Schreiner said that he had a request to add a hand railing to the Belvedere hand launch. The CAO will bring forward a cost estimate to the Commission as part of its 2019 budget deliberations.

Councillor Knust

- Substance Abuse presentation. Would like to see this drop-in service advertised more broadly to the public.
- FED – Feed Enderby & District looking to confirm permanent space for the Harvest Hut and wants to remove the trees on the east side of the Maud Street parking lot to make space for a garden area. Staff directed to remove the trees and bring the area level to grade with the rest of the parking lot.
- Discussion on resident reporting an incident to the RCMP and whether it was followed up appropriately. Councillor Knust to provide the file number to the CAO so that it can be followed up with the detachment commander at their next meeting in a few weeks.
