# RE: Shuttle Bus with Wheel Chair Lift and Taxi Service Support Letter request

In reference to the above and further to our conversation this morning, please accept this as my formal request for a support letter from the City of Enderby. Due to tight deadlines we are hoping to have the letters in by March 5, 2019 so that we can put your logo on our poster at the Job Fair on March 11 at Splastin. We will be submitting the letters to BC Transportation by the end of March with our permit applications to show that there is a need and support in the area.

My husband and I purchased a 14-passenger shuttle bus that has a wheel chair lift to pick people up right from their homes or other locations. This shuttle bus has passed inspection and is currently getting a face lift with a new logo and decals. We have drivers ready to roll and we have one taxi that is in the shop for inspection.

Our current plan is to run the shuttle during the day focusing on those with mobility issues, service groups, and general passengers. In the evenings and weekends we will be running the shuttle as an events bus such as wine tours, theatre performances, music in the park, etc. Our taxi services will be available for smaller groups or individuals whom don't have mobility issues.

We will be picking up passengers between Armstrong and Grindrod. We are prepared to take the passengers as far as Salmon Arm or Vernon with return.

This shuttle will also have advertising space inside along the top for local businesses to rent. This will help off-set costs in order to keep the shuttle services reasonably priced.

Just a side note, we have joined the Enterprize Challenge and are in the process of preparing for our first pitch in April. If we are successful in making the top 7 we will be throwing our final pitch closer to the end of April. For your information, I will forward the dates and times of the pitches as soon as they are confirmed.

Establishment of Community Heritage Register for Civic Buildings

#### RECOMMENDATION

THAT in accordance with Section 598(1) of the *Local Government Act*, Council resolves to establish a Community Heritage Register for civic buildings with the following properties to be included:

1. Enderby Drill Hall at 208 George Street, Enderby BC; and

2. Enderby City Hall at 619 Cliff Avenue, Enderby BC;

AND THAT Council endorses the attached Statements of Significance for the two aforementioned properties to be included in the Community Heritage Register;

AND THAT in accordance with Section 598(3) of the *Local Government Act*, Council directs Staff to give notice of the establishment of the Community Heritage Register, with the aforementioned properties included, to the Minster of Forests, Lands, Natural Resource Operations and Rural Development.

#### **BACKGROUND**

A Community Heritage Register (CHR) is a heritage planning tool that identifies local places which embody a community's heritage values and character-defining elements. A CHR provides information regarding the heritage value of a property, while improving education and awareness of local heritage within a community. A CHR does not provide heritage protection to properties on the Register. In addition to the informational purpose, properties that are included in a CHR may be eligible for grant funding opportunities which are intended to preserve key heritage assets within a community.

When Staff engaged with a Heritage Planner through the Heritage Branch of the Provincial government as part of the City's most recent Official Community Plan review, the Heritage Planner recommended the establishment of a CHR as a highly effective tool for educating and raising awareness regarding heritage values and resources, while in no way encumbering a property.

At its Regular Meeting of September 4, 2018, Council supported the development of a CHR for civic buildings with heritage value, with the Drill Hall and City Hall to be the first buildings added to the Register. Since then, Bob Cowan, President of the Enderby & District Heritage Commission, has spent considerable time researching both the Drill Hall and City Hall in order to compile historical data which communicates the heritage value of these civic buildings. Mr. Cowan has used this information to

develop Statements of Significance for both locations, which are attached to this memorandum. Statements of Significance are three-part statements which include the description, the heritage value, and the character-defining elements of a historic place; they are the foundation of a CHR, and are intended to indicate the reasons why properties included in the Register are considered to have heritage value or heritage character, which is a requirement under Section 598(2) of the Local Government Act.

Staff are recommending that Council resolves to establish a CHR with the Drill Hall and City Hall properties to be included through the attached Statements of Significance. It is also recommended that Council directs Staff to give notice of the establishment of the CHR, with the aforementioned properties included, to the Minster of Forests, Lands, Natural Resource Operations and Rural Development in accordance with Section 598(3) of the *Local Government Act*. Once the Statements of Significance have been submitted and accepted by the Minister, the properties will be included on the BC Register of Historic Places.

Once the CHR is established, Staff will develop a 'Community Heritage Register' page on the City of Enderby website in order to celebrate the heritage value of the Drill Hall and City Hall buildings, and any other historic places that may be added to the CHR in the future. The online CHR will include photos of City Hall and the Drill Hall which will showcase the character-defining elements of the buildings; these photos will be taken in the spring when the downtown foliage and greenery are on full display.

It should be noted that although the CHR will only focus on civic properties, should residential or commercial property owners request that their properties be added, the requests would be referred to the Enderby & District Heritage Commission for input and evaluation.

Enderby City Hall 619 Cliff Avenue Enderby, BC Built in 1909

## Description

Enderby City Hall is a two-storey brick building built in the heart of Enderby's downtown core on the northeast corner of George Street (Highway 97A) and Cliff Avenue. The historic place includes the entire building and the surrounding property.

## Heritage Value

Enderby City Hall is significant as a symbol of Enderby's civic affairs, and for its architecture.

Enderby City Hall was built in 1909, four years after Enderby's incorporation as a municipality. The building included a Council Chambers that was also used as a courtroom and had various other public purposes. Next to the Council Chambers was a committee room that was also used as a library. The building also contained a City Clerk's office, a City police office, cells for the detention of prisoners, and also served as a headquarters for the fire department. The main facade facing Cliff Avenue remains as it was in 1909, but the rest of the building was added on in 1985, with a library and museum on the bottom floor. The building has served as a municipal office continuously to the present day, and is valued today as a symbol for the City's civic affairs. The building also has aesthetic value for its imposing scale, its unembellished facade, and construction materials which include locally-produced Enderby bricks.

#### **Character Defining Elements**

Key elements that define the heritage character of Enderby City Hall include:

- Imposing brick building form and massing
- Construction materials including locally-produced Enderby bricks
- Edwardian architectural style that is more functional than ornate, with an unembellished façade that is articulated by brick pilasters on either side of the building's entrance
- Colonial roof pitches from the 19th century
- Eyebrows over the facade windows
- Continuing use as an administrative and cultural centre for Enderby

Enderby Drill Hall 208 George Street Enderby, BC Built in 1914

## Description

The Enderby Drill Hall is a two-storey brick building located at the south end of Enderby on the southwest corner of George Street (Highway 97A) and 2nd Avenue. The historic place includes the entirety of the building and the surrounding property.

## Heritage Value

The Enderby Drill Hall is valued as a landmark in Enderby for its architecture, its rarity as a surviving building built in preparation for the First World War, and for its continuing community use.

The Enderby Drill Hall was built with locally-produced Enderby bricks in 1914 by the Dominion Government, on lands donated by Fred Barnes, in preparation for the First World War. The building was military in nature but was also used for community events. The Dominion Government specified the design and size of the building. There were many similar buildings constructed in western Canada, but this is one of the last intact still in its original location. The building was used during both World War I and World War II. After World War II, the Federal government sold the building to the City of Enderby, and it has since operated as a community hall for dances, art shows, theatre, and recreational classes.

## **Character Defining Elements**

Key elements that define the heritage character of Enderby Drill Hall include:

- 19th Century design with imposing facade on the gable ends
- Construction materials including locally-produced Enderby bricks
- High ceilings
- Gun range in the basement and officers' mess upstairs
- Large size and massing as one of the largest buildings in Enderby
- Continuing use as a community space

7th Annual Our Enderby Clean-Up Challenge

#### RECOMMENDATION

THAT Council endorses either April 6, 13 or 27 as the date for the 7th Annual Our Enderby Clean-Up Challenge;

AND THAT Council supports integrating a FireSmart awareness component into the 7th Annual Our Enderby Clean-Up Challenge.

#### **BACKGROUND**

Since 2013, the City of Enderby has been hosting the annual Our Enderby Clean-Up Challenge which is a community event aimed at reducing local pollution, beautifying the community, and fostering a sense of community and civic pride. The clean-up event is followed by an appreciation barbecue hosted by the Enderby & District Lions Club, where food and refreshments are provided to clean-up participants to celebrate their community contribution; once Council has endorsed a preferred date, the Lions Club will be contacted to confirm their availability for the event.

The event has historically been held on the third Saturday in April, but this year that day falls on the Easter long weekend. Given this, Staff are recommending that Council endorses either April 6, 13 or 27 as the date for the 7th Annual Our Enderby Clean-Up Challenge. In addition, it is recommended that a FireSmart awareness component be integrated into the Clean-Up Challenge. There is a natural linkage between the Our Enderby Clean-Up Challenge and FireSmart principles, as both encourage the maintenance and cleaning of private property, albeit for different purposes (i.e. beautification vs. wildfire protection). The City's Fire Chief has confirmed that a Fire Department member would be available to set up a table at the event in order to distribute FireSmart materials and educate residents on steps they can take to protect their property from the potential spread of wildfire; during the course of 2019, the City will be implementing a full-fledged FireSmart program in accordance with a recent grant.
