BC Timber Sales Proposed Cut Blocks in Community Watershed

Brian Sye and Janet Beltz from BC Timber Sales gave a presentation on the proposed harvesting blocks overlapping the Brash Creek Watershed.

- K6MK will overlap by 6 hectares
- K6P& will overlap by 1.5 hectares
- Study includes a hydrology report by Urban Systems. BCTS cannot share the report with stakeholders.
- Total impact would equal 0.5%
