## Discussion with Salmon Arm Security

Prasad, Salmon Arm Security proprietor provided an overview of services available through Salmon Arm Security.

- Patrols on foot and marked vehicle between the designated hours
- Clearly identified as security officials
- Vehicle equipped with front and rear facing cameras
- Deal with problem activities and notify City officials of bylaw infractions.
- In case of conflict, will notify RCMP
- Daily log
- Professional and courteous at all times

Councillor Baird asked what some examples of current work are. They are currently patrolling the CSRD Parks and monitor each site, provide lock up services and help to deal with improper uses in a constructive manner.

Councillor Case mentioned that Council has identified the area from Mill Avenue to Barnes Park, Tuey Park and the downtown core as the most "at-risk". Would be looking at 16-20 hours per week on varying days, with a focus on daytime hours.

Mayor McCune asked if there was a possibility to expand services if the trial is successful. Prasad indicated that, if there is enough interest from others, such as the businesses community, separate contracts could be drawn up with them as individual customers or together.

Councillor Davyduke entered the room (4:09 p.m.)

The Chief Administrative Officer reviewed the strategic direction provided by Council to provide an increased security presence in public spaces to improve safety. He noted that 4 other security providers were contacted, and Salmon Arm Security was able to offer a program that best fit with the direction that Council provided.

Moved by Councillor Case, seconded by Councillor Baird "That the City of Enderby enter into a service contract with Salmon Arm Security from mid-July to mid-September 2019 to provide security in public spaces."
