NEW BUSINESS

New Pool – Scoping and Engagement Discussion with Mark Hentze, HDR Inc.

Mark Hentze from HDR Inc. presented to the Commission on the proposed new pool preliminary design process. He provided his qualifications and past experience. He then described the proposed methodology for the preliminary design, where stakeholder and public engagement will occur. Mr. Hentze reported that the end product will be a basic design with a range of options, each having different cost impacts. He reported on his site visit to the current pool. He noted that most of his work is focused on replacing Centennial pools built in the late 1960s that were past their usable life, while Enderby's pool was built in the early 1950s and is a generation older. He said that the pool's advanced age is a testament to its original construction quality and the work of staff to keep it in good condition throughout the years, but it is now at or past end-of-life.

Councillor Baird asked what a bare bones budget would be. Mr. Hentze reported that this is part of what will be determined during the preliminary process. However, he noted that similar pools and bath houses typically cost around 4.5 to 5 million dollars. He said that, in some cases, it may be effective to provide the infrastructure now for "nice to have" options, which can be built at a later date.

Director Delisle asked what projects Mr. Hentze has done recently. Mr. Hentze described pools in Port Hardy, Langley, and Lions Bay. He is also working on a pool in Vulcan, Alberta and has completed a major outdoor waterpark in Aldergrove.

Alternate Director Halvorson asked about the new pool dimensions. Mr. Hentze said that this would form part of the work of this process. However, the 4 lanes would likely be replicated with improvements for inclusivity and accessibility, as well as an improved leisure area, all of which would drive the budget.

Councillor Case asked about the potential for senior government funding to help with the costs. Mr. Hentze said that grants can be available and they can help staff by providing what they need to make the grant applications.

Councillor Baird asked about the timeline for construction. Mr. Hentze said that pool construction typically takes a year, but this does not factor into the timeline things like a borrowing referendum and desired start dates so as to minimize interruption to the existing facility.

Councillor Case asked about whether the pool could be heated through the district heating system, as is done with the current pool. Mr. Hentze said that this was entirely feasible and should be looked at, as it represents a good news story for the community in terms of reducing its environmental impact.

Alternate Director Halvorson said that he supports moving forward, but needs the numbers and concept for the public. He asked about how a referendum would occur for this project. The Chief Administrative Officer discussed some of the potential options. He said that there is a legislative requirement for the City of Enderby to seek the assent of its electors, as it holds the debt and the asset. However, while this legislative requirement does not exist for Area F, there should still be a process in place to obtain assent from Area F residents

Councillor Case asked if there have been any innovations in the field in the last decade, which Enderby could capitalize upon. Mr. Hentze said that the innovation has come more around how pools are used, and how this is changing. There has been a big shift towards leisure water over lap lanes. There is more of a focus on wellness, and pools as part of a lifestyle choice. Accessibility and universal access are bigger priorities so that pools are more inclusive.

Mr. Hentze said that he would be coming up with a refined process for the next steps in conjunction with staff, which would involve stakeholder engagement and a public open house. The end product will likely be a "bare bones" option with costed-out optional components and amenities.

Sheryl Hay, with Enderby & District Recreation Services, then spoke to the pool and the impact that she sees it having upon those who use it.

The Commission thanked Mr. Hentze for his presentation and answers.

We respectfully request the City of Enderby and Electoral Area F of the Regional District of North Okanagan to consider renewal of the 4-year funding agreement for 2020 to 2023. As per our current agreement, this would start jointly for Enderby/Area F at \$11,100 per year plus the BC CPI Index increase for each subsequent year. We would be pleased to present to the Commission, at the Commission's convenience, the details of the work that was accomplished between 2016 and 2019 and the STA's priorities and goals for the next four years working on your behalf.

 - c. Environmental Screening / Adaptive Planning:
 - d. Trail Stewardship;
 - e. Trail Experience Development and Programs;
 - f. Capital Projects Co-Ordination as may be agreed upon; and
 - g. Technical Trail Services
- 4. The Commission will pay to the Society the sum of:

- 5. The annual contribution will include the annual 'BC Consumer Price Index All Items' increase to a maximum of 2% annually in 2017, 2018 and 2019.
- 6. Prior to September 1, the Society shall provide the City with a copy of its budget for the following fiscal year.
- 7. The Society will maintain complete and accurate records of all its expenditures and will, on request, make such records available for inspection by the City at all reasonable times.
- 8. The Society will provide an unaudited financial statement to the City no later than sixty (60) days following the end of each year of the Term.

- 9. Any surplus Commission funds retained by the Society, not committed to specific projects, shall be repaid to the Commission unless those funds are, with the approval of the City, applied to the operations of the Society for any renewal term of this Agreement.
- 10. The Society, during the Term, shall:
 - maintain its status as a British Columbia non-profit organization in good standing pursuant to the requirements of the laws and regulations of the Province of British Columbia;
 - b. notify the City of any change to its name or any alteration to its Memorandum or Articles;
 - c. ensure compliance with all municipal, provincial and federal requirements with respect to the conduct of its business; and
 - d. assume responsibility for engaging or dismissing any of its employees and ensure compliance with all provincial and federal enactments with respect to employee and employer remittances, employment standards and otherwise.
 - e. obtain and maintain throughout the term of this agreement comprehensive liability insurance in the amount of \$3,000,000 with the City and RDNO as named insured.
 - f. indemnify and save harmless the City and RDNO, including its officers, employees, elected officials, servants, and agents from and against any and all liabilities, damages, losses, costs, expenses (including lawyer's fees and litigation) incurred in any actions, applications, claims, suits, and other proceedings in connection with or arising from any breach or non-performance with the Society, any loss or damage resulting from the negligence or willful misconduct of the Society, its employees, agents, servants, contractors, and board members, which shall survive the expiration or termination of this agreement.
- 11. The Commission shall, in the event of any breach by the Society of the provisions of this Agreement, provide written notice to the Society that such breach must be remedied within thirty (30) days from the date of such notice. Failure by the Society to rectify such breach shall entitle the City to terminate this Agreement effective ninety (90) days from the date of such notice. In the event of such termination, any services required to be rendered by the Society and any payments required to be made by the City shall cease as at the date of termination. The City may terminate this agreement without cause with one (1) year's written notice.

RECOMMENDATION

THAT the Enderby & District Services Commission receives and files the "Pool Survey – Summary of Responses" dated October 30, 2019.

BACKGROUND

As part of its 2019 budget, the Enderby & District Services Commission committed funding for preliminary design of a new pool.

One of the two main opportunities for public engagement was a survey that was conducted over August and September 2019. The survey information forms part of a matrix of inputs that also includes site feasibility, economic pressures, and public policy considerations. The survey included questions that were designed to provide insight into the public sentiment to construct a new pool, gain a better understanding of usage habits, and identify the most desired amenities. The survey is not a "vote" and should be taken as a qualitative rather than quantitative representation of the public's interest; however, the survey results have already provided useful guidance that has been applied to the preliminary design work that is in progress.

The survey generated over 500 responses, which indicates a relatively high level of interest in the project. There was very strong representation from families with young children. Nearly half of the respondents indicated a desire for accessibility improvements that would make it easier to use the pool.

Among the respondents, the highest-ranked limitations affecting their ability to use the pool included the short season and hours of operations and a lack of desirable amenities, particularly a hot tub, shade areas, and leisure features. There was dissatisfaction with respect to the physical condition of the pool but satisfaction with the quality of programming delivered at the facility.

Of the respondents, 440 supported building a new pool while 34 supported closing the pool facility once it could not longer operate.

There was a strong desire expressed for an indoor pool, but staff caution that no capital or operating cost information was available during the survey to inform opinion, as it is beyond the scope of this preliminary survey. Anecdotal information derived from the survey responses indicates a need to raise awareness about the capital and operating costs of an indoor facility as it relates to revenue sources. The Commission should note that there is a correlation between those who expressed a desire for an indoor pool and those who indicated a concern over higher taxes, which indicates that their desire for an indoor pool facility is tempered by a consideration of tax impacts.

There was also very strong interest in improving the amenities in comparison with the existing pool. The top-ranked amenities are:

- 1. Leisure/public swimming
- 2. Swimming lessons
- Hot tub
- 4. Family change rooms
- Adult fitness
- 6. Gentle (beach) entry
- 7. Shade areas

As part of the concept design process, the Commission will be presented with a variety of information that it will need to consider, should it decide to move ahead with the next phase. This information includes matters related to capital and operating costs, site logistics, legal requirements associated with borrowing, and time horizon. The attached survey results represent one important public input into that broader matrix of considerations. A second opportunity for public comment will occur near the end of the concept design process when an open house is hosted.

BACKGROUND

Included in the 2019 financial plan is funding for one of three proposed columbarium units for the upper cremation garden. A request for proposal was issued and three proposals were received. The proposals were evaluated based on the following weighted criteria:

1.	Design & Schedule	30 %
2.	Qualifications & References	25 %
3.	Cost	40 %
4.	Warranty	5 %

One proposal was disqualified as it did not meet the mandatory deliverables. The remaining two proposals were evaluated by both the Chief Administrative Officer and the Chief Financial Officer, which resulted in the following average weighted scores:
