#### **NEW BUSINESS**

Hunters Range Snowmobile Association (HRSA) Presentation

Curtis Munroe represented the HRSA and gave a presentation on its history.

HRSA was founded in 1977 as a non-profit, volunteer-based organization managing approximately 90km of groomed trails under a partnership agreement with Recreation Sites and Trails BC. They have two cabins, two groomers and collect trail fees for approximately 5000 users during the winter season.

HRSA is applying to the Off Road Vehicle (ORV) Trail Fund for funding for construction and maintenance of trails and to promote the safe and responsible use of Off Road Vehicles. They are requesting a letter of support from City Council.
