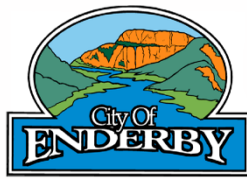

#### Councillor Schreiner

Job Fair anticipated for the Spring of 2022, subject to business feedback.

Mayor McCune

Rick Dugdale is operating Enderby Entertainment in Kelowna. Met the new Chief Executive Officer for Splatsin Development Corporation. Asked about why recreation vehicles from the Riverside RV Park appeared to be overflowing into the adjacent park area. Staff will look into this. Expressed his appreciation for staff's emergency management performance.

Councillor Knust

Asked if there has been any follow-up from the Interior Health Authority regarding a rescheduled date for their proposed meeting with elected officials in the area about improving vaccination rates. Staff will follow up with the Interior Health Authority. Has received positive feedback regarding the Tuey Park parking lot expansion and its impact upon congestion. Asked about future paving and servicing plans for Brickyard Road and how active transportation will fit into that planning context.
