

The Planner read written submissions from the public.

## Kathy Fabische: 130 Cliffview Lane, Enderby BC

- Suggested that the electrical building should be shorter with a larger footprint.
- Suggested that the electrical building should be located on the North side of the property.
- Concerned that the car wash may now be used as an industrial truck wash and, because of the small parking lot, there would be an excess of noise from commercial vehicles backing up.

The planner explained that under its current zoning this would not be allowed to be used as a commercial truck wash.

Councillor Case asked whether the electrical building could be located to the North.

Mayor McCune explained that service to the property is on the side where the building is proposed.

Councillor Baird stated that to move the building to the north side the owner would likely need to tear up and repave the parking lot.

## Moved by Councillor Baird, seconded by Councillor Davyduke

"THAT Council authorizes the issuance of a Development Variance Permit for the property legally described as LOT C DISTRICT LOT 150 KAMLOOPS (FORMERLY OSOYOOS) DIVISION YALE DISTRICT PLAN 5784 and located at 1806 George Street, Enderby B.C. to permit a variance to Section 402.10.a of City of Enderby Zoning Bylaw No. 1550, 2014 by reducing the minimum exterior side yard setback from 4.5 m (14.76 feet), as shown on the attached Schedule 'A', subject to the applicant providing a revised site plan showing the proposed electrical building being sited at least 1.83 m (6 feet) from the edge of the statutory right-of-way shown on Plan A9568"

Councillor Case asked if the servicing of the lot would occur at a further stage of development.

The Planner responded that it is a later stage when servicing would occur. The purpose of the restrictive covenant is to inform a prospective buyer that the lot is not yet serviced.

## **REPORTS**

Mayor and Council Reports

Councillor Schreiner

Attended SILGA and reported that it was a great conference. The Regional District of Okanagan Similkameen put in a resolution on ride-sharing that is similar to the one that the City of Enderby has submitted to UBCM.

Rogers and Shaw had a booth at SILGA. Explained that the two companies are combining globally and Councillor Schreiner discussed with them the need for fibre optic internet in our community.

The ongoing drug crisis was also discussed, and Councillor Schreiner explained that we cannot police ourselves out of a drug crisis. When drug houses are shut down, people with addiction will find supply somewhere else. Stated that this is a social issue and to make progress, more addiction services will need to be offered.

Councillor Schreiner also discussed the housing crisis across the country and explained that homeowners own their property, but not their neighbourhood. Asked that homeowners show compassion when looking at proposed housing projects in their neighbourhoods. Explained that new legislation is coming to change when public hearings will be necessary.

Chief Administrative Officer explained that our bylaws currently outline a process for the holding of public hearings notwithstanding the legislative changes, but that Staff is working on a report with options for Council to consider.

Councillor Schreiner attended a workshop put on by RDNO about housing for the workforce.

Reported that Councillors from Spallumcheen and Armstrong would like to meet with Council to discuss information from the Ministry of Transportation and Infrastructure.

Mayor McCune noted that there is a meeting upcoming with Spallumcheen and Armstrong to address certain issues related to Highway 97A.

Councillor Schreiner asked if the Event Coordinator could appear as a delegation at an upcoming Council Meeting.

Chief Administrative Officer responded that the Event Coordinator is scheduled to attend the next Council meeting.

Attended a meeting of the Splatsin-Enderby Joint Committee along with Mayor McCune to discuss an agenda for a larger Community-to-Community meeting.

Chief Administrative Officer noted that he has reviewed the proposed agenda put forth by the Splatsin-Enderby Joint Committee and advanced it to the Splatsin interim administrators for their review.

Councillor Schreiner noted that there is a possibility that the RCMP may be replaced by a Provincial Police Force. Discussed with Kupki7 Thomas the possibility of a joint police force with Splatsin.

Councillor Schreiner asked if we have received feedback yet from the Business Walk.

The Planner responded that he has been engaging with Community Futures and that there will be a presentation of the report at the June 6 Council Meeting.

Councillor Knust asked if letters were sent to the owners of the old Crystal Garden building, the D&E Diner, and the two vacant lots on Cliff Avenue.

Chief Administrative Officer responded that letters were sent and briefed Council on the responses received thus far.

#### Councillor Baird

A Rail Trail meeting was cancelled and is in the process of being rescheduled.

Working with the Event Coordinator on planning for Canada Day events. The Farmers Market will be setting up at the skateboard park in Barnes Park which will help with the need for food vendors at the event.

Will be attending a library board meeting on Wednesday.

Reported that there was a great turn-out at the Prom Parade.

Councillor Baird asked if the police who set up at the Drill Hall parking lot ask for permission to use that space.

Chief Administrative Officer responded that there is no formal agreement. There has been concern in the past about the space being used by police when there are events happening at the Drill Hall. The RCMP will relocate when there is a booking at the Drill Hall.

#### Councillor Davyduke

Reported that Community Futures is putting on a workshop on June 2 about hiring and retaining staff and that she will pass on more information regarding this when she receives it.

#### Councillor Case

Discussed the housing crisis and that the Agricultural Land Reserve has very tight restrictions on housing.

Chief Administrative Officer explained that this is provincially regulated and that the ALC believes the focus should be on densifying already-developed land instead of using agricultural land for housing.

Area F Director Delisle explained that, within the ALR, detached suites are allowed up to 90 m<sup>2</sup>, and depending on the size of the land, a second residence may be allowed as well, though the size is limited.

#### Mayor McCune

Mayor McCune asked if there is still value in having a Committee of The Whole meeting.

## Area F Director

Attended a Harm Reduction Meeting at SILGA. It was discussed that more policing won't solve the drug problem and that the solution may be allowing people with addiction to access a clean supply of drugs. It has been shown that if people with addiction do not have to commit crimes to get drugs, their usage often will lessen. Explained that deaths from drugs happen in housed people more than in unhoused, and that indigenous people are four and a half times more likely to die of drug overdoses.

Also discussed at SILGA were heat domes, and how to minimize impacts of them in communities.

Discussed how the thinning of the forest around Logan Lake was effective in slowing down forest fires in that area last year.

Attended a FireSmart conference in Kamloops and discussed that it is very important to apply FireSmart principles to homes to prevent major damage from fire.

**Chief Administrative Officer** 

Reported that line painting in the City is now complete.

Construction at Mill Avenue is now in progress. The project is going well so far.

The next stage of the Arena restoration will be beginning soon.

The design stage for the new pool is in progress, with geotechnical and survey works scheduled.

Met with the Chief Financial Officer and Recreation Services to discuss how the remaining Participaction funds could be used, as several projects have had to be cancelled due to the grant funds being confirmed for the new pool, which may cause some amenities to be relocated or removed for the construction.

Attended a conference last week in Kelowna where emergency management and catastrophic risk were major themes.

There are sandbags available now in front of the Public Works yard that are available for use to City of Enderby, Area F, and Splatsin residents.

Reported that things at Riverside RV Park are going well and the online booking system is up and running.

Councillor Case asked if there is a large snowpack this year.

Chief Administrative Officer explained that because it has remained so cold this spring that if there is a rapid shift to hot weather and rain there will be a high risk of flooding.

Councillor Shishido asked what the timeline will look like for construction of the pool. Asked if Enderby will go a season without a functioning pool.

Chief Administrative Officer responded that the hope is to have the construction of the pool out to tender late in 2022 with construction starting in 2023. Because of the likely change in location of the pool, the current pool should be able to operate while the new pool is being built.

Councillor Baird asked if the new concession operator is up and running.

Chief Administrative Officer replied that the new operator began business last week at the Gazebo, but that the concession in the Arena is in need of a new handwashing sink before if will be approved by Interior Health. The sink is being installed as part the other renovations that are occurring inside the Arena concession.

## Bylaw Enforcement Statistics for First Period of 2022 (Jan-Apr)

Councillor Knust asked whether multi-family dwellings could be placed on nuisance abatement in cases where RCMP have been called to the property.

The Planner stated that Staff can explore if it is possible to include multi-family dwellings on the nuisance abatement list.

Councillor Shishido asked if the six excessive noise complaints noted on the report were all from the same property.

Moved by Councillor Baird, seconded by Councillor Knust "THAT Council receives the Bylaw Enforcement Statistics for First Period of 2022 (Jan-April) report for information."

## RECOMMENDATION

THAT Council receives this 2022 Business Walk Results memorandum for information.

## BACKGROUND

Enderby City Council and Community Futures North Okanagan undertook its annual Business Walk on April 12, 2022. The intent of this Business Walk was to learn more about local businesses through face-to-face interviews and to identify opportunities for further supporting community economic development; the British Columbia Economic Development Association has identified Business Walks as a key way to support business retention and expansion.

A total of 12 Councillors/Community Futures representatives took part in this year's Business Walk and were split into 5 teams. The Business Walk targeted commercial and industrial areas within the community and the volunteers gathered information from a total of 35 businesses. A report of the results of the Business Walk survey is attached as Schedule 'A' to this memorandum; some key highlights from this report include:

- 1. 94.3% of surveyed businesses stated that their current state of business is either 'good/increasing' or 'fair/steady', and 56.2% of businesses anticipated that their 2022 revenues would be more than 2021;
- The surveyed businesses identified 'Clientele' and 'Location' as what they liked most about doing business within the area, and identified 'finding employees' as the biggest challenge facing their business;
- 3. 40.0% of surveyed businesses had used a Provincial or Federal business recovery program as a result of COVID-19; and
- 4. Improved marketing of local businesses, increased municipal supports, and highway beautification were identified as being critical to helping business thrive in Enderby.

The City of Enderby and Community Futures North Okanagan are currently in the process of following up with the 9 businesses that were identified as requiring further assistance.



# Schedule 'A' - Enderby Business Walks Survey Results 2022

## 1. Please rate the current state of your business.

This question is an important indicator in gauging the current economic climate for local business and industry within Enderby. The below results are quite positive in that 94.3% of businesses stated that their current state of business is either 'good/increasing' or 'fair/steady'.




# 2. What is the average number of employees at your business?

The average number of employees ranged from 1-13, with 83.3% of businesses surveyed employing 10 people or less.

# 3. What do you like most about doing business in the area?

This question was used in order to identify the unique characteristics of the community which are conducive to good business. 51.4% of the businesses surveyed identified 'Clientele' as what they liked most about doing business within the area while 34.3% identified 'Location' as a key factor. Of the 45.7% who chose 'Other' factors, Enderby's small town feel and atmosphere, sense of community, and central geographic location were identified as key strengths.




# 4. What can be done to help your business thrive?

This open-ended questioned was used in order to identify, i) what can be done to better support local businesses, ii) which areas provide the best opportunity for strengthening the local economic climate, and iii) how best the City of Enderby and Community Futures can follow up with individual businesses in order to provide assistance.

The main themes were improved marketing of local businesses, increased municipal supports, and highway beautification.


# 5. What are the biggest challenges facing your business?

This question was used to gain insight regarding the main challenges that local businesses are facing. A total of 40.0% of the surveyed businesses noted that 'finding employees' was their biggest challenge, while 11.4% noted 'lack of space for growth'. Of the 57.1% of surveyed businesses who chose 'Other' challenges, the main themes related to supply chain issues, increasing costs of goods, and lack of available commercial space.



# 6. What specific information would you like to have access to locally?

This question was geared towards identifying the types of resources that could be used to support local businesses better; 11.4% of the surveyed businesses noted they would most like to have access to information related to 'Marketing and Sales Information' and 'Hiring/Human Resouces'.




7. Have you used any of the Provincial or Federal business recovery programs as a result of COVID-19? How would you describe the impact of the COVID-19 pandemic upon your business?

Of the businesses surveyed, 40.0% had used a Provincial or Federal business recovery program as a result of COVID-19.

There was a spectrum of responses to the question regarding the impact of the COVID-19 pandemic upon local businesses; many businesses noted an increase in business as a result of the pandemic, due in part to more people shopping local and having more disposable income to spend, whereas many businesses noted negative impacts as a result of the pandemic, particularly businesses that were most directly affected by Public Health Orders, such as restaurants.


# 8. What is the anticipated outlook for your business in 2022?


This question was geared towards gaining an understanding of the local economy moving forward, particularly as we begin to move towards the end of the COVID-19 pandemic. Of the businesses surveyed, 56.2% anticipated that their 2022 revenues would be more than 2021.



# 9. Do you have an updated Business Plan? Do you plan on selling your business within the next 5 years?


These questions were used to gain insight on opportunities where business support organizations such as Community Futures North Okanagan could help businesses with business planning and succession planning. Of the businesses surveyed, 21.9% had an updated business plan and 6.1% planned on selling their business within the next 5 years.





# Walker Question: Should this company be revisited to provide 1:1 assistance?

One of the primary objectives of the Business Walk was to identify businesses that needed additional support or assistance from the City of Enderby or business support organizations such as Community Futures North Okanagan. Of the businesses surveyed, 25.7% required some form of assistance; the City of Enderby and Community Futures North Okanagan are currently in the process of following up with the 9 businesses that were identified as requiring further assistance.

PROPOSED VARIANCES:	Reduce minimum lot area for adult retirement housing, reduce minimum rear yard setback for single family dwelling, reduce minimum lot frontage, not require further road dedication for Brickyard Road, not construct Brickyard Road to centreline, defer the requirement to design and construct a storm drainage system, not require a direct connection to the community sanitary sewer system for proposed new lot, not provide ornamental street lighting or underground wiring

## **RECOMMENDATION:**

THAT Council authorizes the issuance of a Development Variance Permit for the property legally described as LOT 2 DISTRICT LOT 150 KAMLOOPS (FORMERLY OSOYOOS) DIVISION YALE DISTRICT PLAN 15492, and located at 171 Brickyard Road, Enderby BC., to permit variances to the following Sections of City of Enderby Zoning Bylaw No. 1550, 2014:

- Section 604.6.e by reducing the minimum lot area for adult retirement housing from 1,900 m<sup>2</sup> (20,452) square feet) to 1,461 m<sup>2</sup> (15,727 square feet), as shown on the attached Schedule 'A';
- Section 604.10.d by reducing the minimum rear yard setback area for a single family dwelling from 6 m (19.68 feet) to 2.97 m (9.75 feet), as shown on the attached Schedule 'A';

• Section 1101.c.i by reducing the minimum lot frontage for a panhandle lot that cannot be further subdivided from 10 m (32.81 feet) to 9 m (29.53 feet), as shown on the attached Schedule 'A';

THAT Council authorizes the issuance of a Development Variance Permit for the property legally described as LOT 2 DISTRICT LOT 150 KAMLOOPS (FORMERLY OSOYOOS) DIVISION YALE DISTRICT PLAN 15492, and located at 171 Brickyard Road, Enderby BC., to permit variances to the following Sections of City of Enderby Subdivision Servicing and Development Bylaw No. 1278, 2000:

- Section 2.0 of Schedule "A" by not requiring Brickyard Road adjacent to the proposed lots to be dedicated a minimum of 9.0 m from the existing mean centreline of the road in accordance with the Local Road Standards;
- Section 5.0 of Schedule "A" and Schedule "B" by deferring the requirement to design and construct a storm drainage system to a future subdivision or Building Permit stage;
- Section 6.0 of Schedule "A" by not requiring the provision of ornamental street lighting; and
- Section 7.0 of Schedule "A" by not requiring the provision of underground wiring for power, telephone and cablevision,

AND THAT Council authorizes the issuance of a Development Variance Permit for the property legally described as LOT 2 DISTRICT LOT 150 KAMLOOPS (FORMERLY OSOYOOS) DIVISION YALE DISTRICT PLAN 15492, and located at 171 Brickyard Road, Enderby BC., to permit a variance to Section 4.0 of Schedule "A" and Schedule "B" of City of Enderby Subdivision Servicing and Development Bylaw No. 1278, 2000 by not requiring a direct connection to the community sanitary sewer system for the proposed new lot with the existing single-family dwelling, subject to the owner demonstrating and constructing an alternate sanitary sewer servicing solution, acceptable to the City of Enderby and its Approving Officer, which is properly and lawfully secured on title such that it runs with the land, in order to allow for an indirect connection to the community sanitary sewer service to be constructed, maintained, and renewed;

AND THAT Council affirms that the issuance of the Development Variance Permit to not require a direct connection to the community sanitary sewer system in no way implies or permits a holding tank or sewerage system under the *Sewerage System Regulation* of the *Public Health Act* as an acceptable alternate servicing solution for sanitary waste;

AND THAT Council NOT authorize the issuance of a Development Variance Permit for the property legally described as LOT 2 DISTRICT LOT 150 KAMLOOPS (FORMERLY OSOYOOS) DIVISION YALE DISTRICT PLAN 15492, and located at 171 Brickyard Road, Enderby BC., to permit a variance to Section 2.0 of Schedule "A" of City of Enderby Subdivision Servicing and Development Bylaw No. 1278, 2000 by not requiring Brickyard Road adjacent to the proposed lots to be constructed to the centreline of the road in accordance with the Local Road Standards;

AND FURTHER THAT Council authorizes an exemption to Section 604.8 and 1101.1.b.i of the City of Enderby Zoning Bylaw No. 1550, 2014 by, i) reducing the minimum lot frontage for a single family dwelling from 12 m (39.37 feet) to 9 m (29.53 feet) for the proposed new lot, ii) reducing the minimum lot frontage for adult retirement housing from 35 m (114.8 feet) to 17.93 m (58.83 feet) for the proposed Remainder Lot, and iii) permitting a frontage to be less than one-tenth the perimeter of the parcel for the proposed new lot and Remainder Lot, as part of the proposed subdivision shown on the attached Schedule 'A'.

## BACKGROUND:

This report relates to a Development Variance Permit application for the property located at 171 Brickyard Road. The owner is proposing to subdivide the property in order to create one new lot, as shown on the attached Schedule 'A'. The existing single family dwelling would be located on the smaller parcel, while the larger Remainder Lot is proposed to be used for a future adult retirement housing development. The applicant is seeking variances to the City of Enderby Zoning Bylaw No. 1550, 2014 in order to, i) reduce the minimum lot area for adult retirement housing from 1,900 m<sup>2</sup> (20,452 square feet) to 1,461 m<sup>2</sup> (15,727 square feet), ii) reduce the minimum rear yard setback area for a single family dwelling from 6 m (19.68 feet) to 2.97 m (9.75 feet), and iii) reduce the minimum lot frontage for a panhandle lot that cannot be further subdivided from 10 m (32.81 feet) to 9 m (29.53 feet). Furthermore, the applicant is seeking variances to the City of Enderby Subdivision Servicing and Development Bylaw No. 1278, 2000 in order to, i) not require Brickyard Road adjacent to the proposed lots to be dedicated a minimum of 9.0 m from the existing mean centreline of the road in accordance with the Local Road Standards, ii) not require Brickyard Road adjacent to proposed lots to be constructed to the centreline of the road in accordance with the Local Road Standards, iii) not require a direct connection to the community sanitary sewer system for the proposed new lot with the existing single-family dwelling, iv) defer the requirement to design and construct a storm drainage system to a future subdivision or Building Permit stage, v) not require the provision of ornamental street lighting, and vi) not require the provision of underground wiring for power, telephone and cablevision. Lastly, the applicant is seeking a lot frontage exemption for both of the proposed lots.

## Site Context

The 1,900 m<sup>2</sup> (0.4695 acre) subject property is located on the east side of Brickyard Road. A single family dwelling, built in 1901, is located in the southwest corner of the property while an accessory residential building is located along the northern property boundary. The single family dwelling is connected to the City's community sanitary sewer system via a private service line that encroaches through a neighbouring property to the south and does not appear to be secured on title. The property is flat and access is gained via a gravelled driveway off of Brickyard Road. The rear of the property is adjacent to the AL Fortune Secondary School field.

The zoning and OCP designations of the subject property and surrounding properties are as follows:

- <u>Subject property</u> Zoned Residential Multi-Family Medium Intensity (R.3) and designated in the Official Community Plan (OCP) as Residential Medium Density
- North and south properties Zoned Residential Single Family (R.1) and designated in the OCP as Residential Low Density

- <u>Western property</u> Zoned Transportation Corridor (S.2) and designated in the OCP as Transportation Corridor
- <u>Eastern property</u> Zoned Assembly, Civic and Public Service (S.1) and designated in the OCP as School Site



The following figure shows the zoning designations of the subject and surrounding properties:

#### The Proposal

The property owner is proposing to subdivide the property in order to create one new lot, as shown on the attached Schedule 'A'. The existing single family dwelling would be located on the smaller parcel, which is proposed to have an area of 350 m<sup>2</sup> (3,767 square feet); the larger Remainder Lot, which would have an area of 1,461 m<sup>2</sup> (15,727 square feet), is proposed to be used for a future adult retirement housing development; it should be noted that the property owner is in no way tied to these proposed land uses for the lots, and may develop the properties in accordance with any of the permitted uses of the Residential Multi-family Medium Intensity (R.3) zone.

Given that the existing single family dwelling is connected to the City's community sanitary sewer system via a private service line that encroaches on a neighbouring property, and appears to be unsecured, the City's Approving Officer is requiring that this matter must be resolved prior to subdivision approval; in response, the applicant is proposing to service the dwelling via an indirect connection to the community sanitary sewer system via a future collection system on the proposed Remainder Lot.

## ZONING BYLAW:

The subject property is zoned Residential Multi-Family Medium Intensity (R.3) and uses permitted within this zone include:

- Apartment and multi-family residential;
- Adult retirement housing;
- Four family dwellings and three family dwellings;
- Two family dwellings;
- Single family dwellings
- Row housing;
- Boarding, lodging or rooming houses;
- Convalescent, nursing and personal care homes;
- Restricted agricultural use;
- Secondary suites and accessory residential;
- Bed and breakfasts; and;
- Civic and public service use.

The proposal as compared to the Zoning Bylaw requirements for the R.3 zone is as follows (highlighted items require a variance):

## SUBDIVISION SERVICING AND DEVELOPMENT BYLAW

Section 2.0 of Schedule "A" of the Subdivision Servicing and Development Bylaw requires the dedication and construction of local roads adjacent to residential properties proposed for subdivision, in accordance with Design, Materials, and Installation standards outlined in Section 2.0 of Schedule "A" of the Bylaw. Sections 6.0 and 7.0 of Schedules "A" and "B" of the Bylaw require the provision of ornamental street lighting and underground wiring for power, telephone and cablevision.

Section 4.0 of Schedule "A" and Schedule "B" of the Bylaw require properties zoned Residential Multi-Family Medium Intensity (R.3) to be connected to the community sanitary sewer system, while Section 5.0. of Schedule "A" and Schedule "B" of the Bylaw requires the design and construction of a storm drainage system as part of a proposed subdivision.

The applicant is seeking variances to the following Sections of the Subdivision Servicing and Development Bylaw No. 1278, 2000 as part of the proposed subdivision:

- Section 2.0 of Schedule "A" by not requiring Brickyard Road adjacent to the proposed lots to be dedicated a minimum of 9.0 m from the existing mean centreline of the road in accordance with the Local Road Standards;
- Section 2.0 of Schedule "A" by not requiring Brickyard Road adjacent to the proposed lots to be constructed to the centreline of the road in accordance with the Local Road Standards;
- Section 4.0 of Schedule "A" and Schedule "B" by not requiring a direct connection to the community sanitary sewer system for the proposed lot with the existing single-family dwelling;
- Section 5.0 of Schedule "A" and Schedule "B" by deferring the requirement to design and construct a storm drainage system to a future subdivision or Building Permit stage;
- Section 6.0 of Schedule "A" by not requiring the provision of ornamental street lighting; and
- Section 7.0 of Schedule "A" by not requiring the provision of underground wiring for power, telephone and cablevision.

## **OFFICIAL COMMUNITY PLAN:**

Policies contained within the Official Community Plan which apply to this development include:

- <u>Policy 3.3.c</u> Council recognizes that development of land has social impacts and will act through the approval process to minimize negative and maximize positive impacts.
- <u>Policy 3.3.h</u> Council will utilize the development approval process, including Phased Development Agreements, to secure an adequate supply of quality affordable, attainable and special needs housing which meets the needs of all residents of the community, regardless of age, mobility, background or socio-economic status.
- <u>Policy 4.4.c</u> Council will encourage and support a spectrum of housing choices throughout the community, including secondary suites, in order to meet the diverse housing needs of residents.

- <u>Policy 5.3.f</u> Council will develop strategies and tools to encourage and facilitate infill and redevelopment within existing developed areas of the community.
- Policy 8.3.h Council will support infill and redevelopment within the community.
- o Policy 8.3.i Council will employ Smart Growth principles in future development.
- <u>Policy 9.3.f</u> Council will develop a robust strategy to support infill, redevelopment, and brownfield reclamation that utilizes existing infrastructure, revitalizes the community, and enhances the use of underutilized lands.
- <u>Policy 20.3.f</u> Council will encourage infill, redevelopment and brownfield strategies that focus growth towards areas with existing infrastructure.
- <u>Policy 20.3.g</u> Council will support innovative options that will assist in maintaining appropriate levels of infrastructure and service delivery in a fiscally responsible manner.

#### **REFERRAL COMMENTS:**

The subject application was referred to the City of Enderby Public Works Manager, Building Inspector, and Fire Chief.

The following comments were received in response to the referral:

#### Public Works Manager

"Given the nature of the development, the following variances should not be supported, or only supported subject to certain conditions being met:

Reconstructing Brickyard Road to centreline adjacent to the subject property should not be waived, but rather cash in lieu should be collected so that this can be contributed towards future road and service upgrades.

Not requiring a direct connection to the community sanitary sewer system for the future lot with the existing single-family dwelling on it should only be varied conditional upon the owner demonstrating and constructing an alternate sanitary sewer servicing solution, acceptable to the City of Enderby and its Approving Officer, which is properly and lawfully secured on title such that it runs with the land, in order to allow for an indirect connection to the community sanitary sewer service to be constructed, maintained, and renewed. For clarity, this would be a private line through another private parcel, and the City would not be responsible for the ownership, maintenance, or renewal of this alternate sanitary sewer servicing solution.

The subdivision should not be approved until the alternate sanitary sewer servicing solution is accepted by the City and its Approving Officer, the necessary agreements are registered on title, and either (a) the accepted alternate sanitary servicing solution is constructed through the new multi-family parcel prior to subdivision approval; or (b) a covenant is registered against the new multi-family

parcel restricting the issuance of a building permit until such time as the accepted alternate sanitary solution has been constructed.

The variance should clearly state that the waiving of a direct connection to the community sanitary sewer system in no way implies or permits a holding tank or sewerage system under the Sewerage System Regulation of the Public Health Act as an acceptable alternate servicing solution for sanitary waste.

With respect to designing and constructing a storm drainage system, it is appropriate to defer this until subdivision or potentially building permit, as we will not know the density and area of impermeable surfaces until that time. The developers should be made aware of the fact that there is no storm collection system in this vicinity and, as a result, drainage will need to be managed on-site.

With respect to undergrounding the overhead wiring and adding ornamental lights, these are not necessary given the infrastructure context of the surrounding neighbourhood."

No other comments of concern were received in response to the referral.

## PLANNING ANALYSIS:

## Minimum Lot Area for Adult Retirement Housing

The City of Enderby Planner raises no objections to the applicant's request to vary Section 604.6.e of the City of Enderby Zoning Bylaw No. 1550, 2014 by reducing the minimum lot area for adult retirement housing from 1,900 m<sup>2</sup> (20,452 square feet) to 1,461 m<sup>2</sup> (15,727 square feet), as shown on the attached Schedule 'A'. Upon consideration of input from adjacent land owners, it is recommended that Council authorize the issuance of the Development Variance Permit given that the proposed Remainder Lot is a large, flat lot that has significant development potential, and without a variance to reduce the minimum lot area for a more intensive residential land use, the highest intensity residential use that could occur on the property would be a four-family dwelling; by reducing the minimum lot area for adult retirement housing, this will enable the property to be used in a manner that maximizes its development potential.

## Rear Yard Setback for Single Family Dwelling

The City of Enderby Planner raises no objections to the applicant's request to vary Section 604.10.d by reducing the minimum rear yard setback area for a single family dwelling from 6 m (19.68 feet) to 2.97 m (9.75 feet), as shown on the attached Schedule 'A'. Upon consideration of input from adjacent land owners, it is recommended that Council authorize the issuance of the Development Variance Permit given that the reduced setback would only impact the proposed Remainder Lot, which is currently undeveloped. Should the proposed subdivision be approved, and the Remainder Lot is subsequently developed, any future purchaser would have been aware of the reduced setback for the single family dwelling on the adjacent new lot, prior to purchase.

## Reduced Lot Frontage

The City of Enderby Planner raises no objections to the applicant's request to:

- Vary Section 1101.c.i of the City of Enderby Zoning Bylaw No. 1550, 2014 by reducing the minimum lot frontage for a panhandle lot that cannot be further subdivided from 10 m (32.81 feet) to 9 m (29.53 feet), as shown on the attached Schedule 'A'; and
- Receive an exemption to Section 604.8 and 1101.1.b.i of the City of Enderby Zoning Bylaw No. 1550, 2014 by, i) reducing the minimum lot frontage for a single family dwelling from 12 m (39.37 feet) to 9 m (29.53 feet) for the proposed new lot, ii) reducing the minimum lot frontage for adult retirement housing from 35 m (114.8 feet) to 17.93 m (58.83 feet) for the proposed Remainder Lot, and iii) permitting a frontage to be less than one-tenth the perimeter of the parcel for the proposed new lot and Remainder Lot, as shown on the attached Schedule 'A',

and upon consideration of input from adjacent land owners, it is recommended that Council authorize the issuance of the Development Variance Permit and lot frontage exemption for the following reasons:

- The proposed variance and lot frontage exemption would enable the proposed subdivision, such that the existing single family dwelling could be maintained while still allowing for a more intensive residential land use to occur on the proposed Remainder Lot;
- It is anticipated that the proposed frontages of 9 m (29.53) for the new lot with the single family dwelling, and 17.93 m (58.83 feet) for the proposed Remainder Lot that is to be used for adult retirement housing, are sufficient to be able to accommodate the anticipated traffic and access demands associated with sites, especially given that the Brickyard Road corridor is straight and provides clear sight lines for vehicles gaining ingress and egress to the road; and
- It is not anticipated that the proposed variance and lot frontage exemption would negatively impact the use and enjoyment of the subject and surrounding properties.

## Road Dedication and Construction to Centreline

The City of Enderby Planner raises no objections to the applicant's request to vary Section 2.0 of Schedule "A" of the City of Enderby Subdivision Servicing and Development Bylaw No. 1278, 2000 by not requiring Brickyard Road adjacent to the proposed lots to be dedicated a minimum of 9.0 m from the existing mean centreline of the road in accordance with the Local Road Standards. Upon consideration of input from adjacent land owners, it is recommended that Council authorize the issuance of the Development Variance Permit given that the existing road dedication along Brickyard Road is sufficient to accommodate the road standard, and no additional dedication is necessary.

However, the City of Enderby Planner has concerns with the applicant's request to vary Section 2.0 of Schedule "A" by not requiring Brickyard Road adjacent to proposed lots to be constructed to the centreline of the road in accordance with the Local Road Standards. The proposed development has the potential to add a significant amount of density to the property, thus increasing the amount of traffic and wear-and-tear to Brickyard Road; given this, Staff feel that it is appropriate for the applicant to contribute towards the

construction of Brickyard Road to the centreline of the road, which would likely be collected as a cash-in-lieu payment that would be directed towards a future renewal of the road. For those reasons, it is recommended that Council not support this variance request.

## Indirect Connection to Community Sanitary Sewer System

Consistent with the referral comments from the City of Enderby Public Works Manager, the City of Enderby Planner recommends that Council support the applicant's request to vary Section 4.0 of Schedule "A" and Schedule "B" of City of Enderby Subdivision Servicing and Development Bylaw No. 1278, 2000 by not requiring a direct connection to the community sanitary sewer system for the proposed lot with the existing single-family dwelling, subject to the owner demonstrating and constructing an alternate sanitary sewer servicing solution, acceptable to the City of Enderby and its Approving Officer, which is properly and lawfully secured on title such that it runs with the land, in order to allow for an indirect connection to the city's Public Works Manager, this arrangement would be a private line through another private parcel, and the City would not be responsible for the ownership, maintenance, or renewal of this alternate sanitary sewer servicing solution. It is recommended that Council makes explicit that the waiving of a direct connection to the community sanitary sewer servicing solution of the *Public Health Act* as an acceptable alternate servicing solution for sanitary waste.

## Defer Design and Construction of Storm Drainage System

The City of Enderby Planner raises no objections to the applicant's request to vary Section 5.0 of Schedule "A" and Schedule "B" of City of Enderby Subdivision Servicing and Development Bylaw No. 1278, 2000 by deferring the requirement to design and construct a storm drainage system to a future subdivision or Building Permit stage. Upon consideration of input from adjacent land owners, it is recommended that Council authorize the issuance of a Development Variance Permit given that the density and degree of impermeable surfaces associated with a future adult retirement housing development are not known at this time; Staff feel that it is appropriate to defer the requirement to design and construct a storm drainage system until a future subdivision or Building Permit application process.

## Provision of Ornamental Street Lighting and Underground Wiring

The City of Enderby Planner raises no objections to the applicant's request to vary Section 6.0 and 7.0 of Schedule "A" of the City of Enderby Subdivision Servicing and Development Bylaw No. 1278, 2000 by not requiring the provision of ornamental street lighting or underground wiring for power, telephone and cablevision. Upon consideration of input from adjacent land owners, it is recommended that Council authorize the issuance of the Development Variance Permit for the following reasons:

• There is no ornamental street lighting along the Brickyard Road corridor and the existing street lights affixed to hydro poles along Brickyard Road provide sufficient light to accommodate the needs of traffic in that area, such that additional lighting is not necessary; and

 Overheard wiring is the existing standard along the entirety of the Brickyard corridor and requiring the installation of underground wiring for the subject property's minimal frontage along Brickyard Road is unnecessary and would have no impact on improving the broader service standard of the neighbourhood.

#### SUMMARY

This report relates to a Development Variance Permit Application for the property located at 171 Brickyard Road. The property owner is proposing to subdivide the subject property in order to create one new lot, as shown on the attached Schedule 'A'. As part of the proposed subdivision, the applicant is seeking a number of variances to the City's Zoning Bylaw and Subdivision Servicing and Development Bylaw. Staff are recommending that several of the variances be supported, that the variance request to not require a direct connection to the City's community sanitary sewer system be supported with a condition, and that the variance request to not construct Brickyard Road to centreline not be supported.





## BACKGROUND:


This report relates to a Development Variance Permit application for the property located at 155 Vetter Place, Enderby BC. The applicant is seeking to legalize two existing retaining walls, and in order to do so must obtain a variance to Section 309.1.i of the City of Enderby Zoning Bylaw No. 1550, 2014 by increasing the maximum height of a retaining wall from 1.2 m (3.94 feet) to 1.52 m (5 feet) and 2.44 m (8 feet), as

shown on the attached Schedule 'A'. The retaining walls were originally constructed without a Building Permit and exceed the Zoning Bylaw's maximum height provisions for retaining walls.

## Site Context

The 752.6 m<sup>2</sup> (8,101 square feet) subject property is located on the north side of Vetter Place. The property slopes significantly in a southerly to northerly direction. A single family dwelling constructed in 2021 is located in the central portion of the lot. A 1.52 m (5 foot) retaining wall is located along the western property boundary and a 2.44 m (8 foot) retaining wall is located along the northern property boundary.

The subject property and surrounding properties are all zoned Residential Single Family (R.1) and are designated in the Official Community Plan (OCP) as Residential Low Density

#### The Proposal

The applicant is seeking to legalize two existing retaining walls, and in order to do so must obtain a variance to Section 309.1.i of the City of Enderby Zoning Bylaw No. 1550, 2014 by increasing the maximum height of a retaining wall from 1.2 m (3.94 feet) to 1.52 m (5 feet) and 2.44 m (8 feet), as shown on the attached Schedule 'A'. It should be noted that as part of the applicant's process to legalize the retaining walls, they are also applying for a Building Permit consistent with the requirements of the City of Enderby Building Bylaw No. 1582, 2015. Given that the retaining walls are greater than 1.2 m (3.94 feet) in height, as part of the Building Permit process the applicant will be required obtain a professional design and field review by a Registered Professional, in order to ensure that the retaining walls are structurally safe.

## ZONING BYLAW:

The subject property is zoned Residential Single Family (R.1) and the permitted uses within this zone include accessory residential buildings, single-family dwellings, secondary suites, bed and breakfasts, civic and public service use, and restricted agricultural use.

Section 309.1.i of the Zoning Bylaw requires that retaining walls on all residential lots, except those required as a condition of subdivision approval, must not exceed a height of 1.2 m (3.94 feet) measured from grade on the lower side, and must be constructed so that multiple retaining walls are spaced to provide at least a 1.2 m (3.94 feet) horizontal separation between them.

## OFFICIAL COMMUNITY PLAN:

Policies contained within the Official Community Plan which apply to this development include:

- <u>Policy 2.2.b</u> To maintain and enhance the City of Enderby as a sustainable, diverse, vibrant, unique and attractive community.
- <u>Policy 2.2.c</u> To maintain and enhance the social well-being, development, and the quality of life for all citizens of Enderby.
- <u>Policy 2.2.f</u> To respect and preserve a process of open, flexible and participatory decision making in the ongoing planning and day-to-day decisions of the City.
- <u>Policy 3.3.c</u> Council recognizes that development of land has social impacts and will act through the approval process to minimize negative and maximize positive impacts.

## **REFERRAL COMMENTS:**

The subject application was referred to the City of Enderby Public Works Manager, Building Inspector, and Fire Chief. No comments of concern were received in response to the referral.

## PLANNING ANALYSIS:

The City of Enderby Planner raises no objections to the applicant's request to vary Section 309.1.i of the City of Enderby Zoning Bylaw No. 1550, 2014 by increasing the maximum height of a retaining wall from 1.2 m (3.94 feet) to 1.52 m (5 feet) and 2.44 m (8 feet), as shown on the attached Schedule 'A'. Upon consideration of input from adjacent land owners, it is recommended that Council authorize the issuance of the Development Variance Permit for the following reasons:

- For the northern retaining wall, having a single 2.44 m (8 foot) tall retaining wall versus a series of smaller 'stepped' retaining walls would have little to no visual impacts to the adjacent, lower property to the north located at 152 Cliffview Drive, given that there is a distance of approximately 90 feet (27.4 m) between the retaining wall and associated dwelling, with a significant amount of vegetation between them;
- Constructing taller, single retaining walls versus a series of smaller 'stepped' retaining walls has significantly increased the useability and constructability of the property; a stepped approach would have significantly diminished the useable open space of the rear and side yards of the property; and
- Should there be any safety considerations associated with taller retaining walls (i.e. guard rails), this will be identified and dealt with through the required Building Permit process and the requirement to engage a Registered Professional for professional design and field review.

#### SUMMARY

This is an application for a Development Variance Permit for the property located at 155 Vetter Place, Enderby BC. The applicant is seeking to legalize two existing retaining walls, and in order to do so must obtain a variance to Section 309.1.i of the City of Enderby Zoning Bylaw No. 1550, 2014 by increasing the maximum height of a retaining wall from 1.2 m (3.94 feet) to 1.52 m (5 feet) and 2.44 m (8 feet), as shown on the attached Schedule 'A'. The retaining walls were originally constructed without a Building Permit and exceed the Zoning Bylaw's maximum height provisions for retaining walls.






Figure 1 – Northern retaining wall (facing east)




Figure 4 – Western retaining wall (facing south)

#### RECOMMENDATION

THAT Council gives three readings to the City of Enderby Wildlife Attractant Bylaw No. 1754, 2022 and the City of Enderby Garbage Collection Regulation Bylaw No. 1566, 2015 Amendment Bylaw No. 1755, 2022.

#### BACKGROUND

The City of Enderby is located in a wildlife-urban interface area. In these areas, wildlife is at risk of being habituated to unnatural food sources such as residential garbage, which often leads to the wildlife losing their fear of humans and becoming dangerous, at which point they must be euthanized.

The Conservation Officer Service has reported a 100% increase in call volumes related to bears in Enderby since 2021, and a 60% increase over the 2020 numbers. The Conservation Officer Service has asked the City of Enderby to consider regulations to require the management of wildlife attractants by property owners in order to reduce wildlife habituation and its consequences (conflicts, danger, and euthanasia).

Many communities in BC already have animal attractant bylaws, including Gibsons, Squamish, Revelstoke, Kamloops, Armstrong, Kelowna, West Kelowna, Kamloops, Naramata, Princeton, Maple Ridge, West Vancouver, Coquitlam, Pemberton, Sooke, Castlegar, Whistler, Cranbrook, Prince George, Kimberley, and Summerland, in addition to a number of regional districts. This list is non-exhaustive; staff are also aware of several other communities that are in the process of developing animal attractant bylaws.

As a municipality that is subject to the *Community Charter*, the City may only regulate wildlife in a manner that is consistent with the *Spheres of Concurrent Jurisdiction – Environment and Wildlife Regulation*. This regulation enables the City to "regulate, prohibit and impose requirements respecting the feeding or attracting of dangerous wildlife or members of the family Cervidae [deer]." The regulation requires that certain activities must be exempt from a local government wildlife attractant bylaw: trapping, normal farm operations, and solid and liquid waste disposal facilities; these activities are regulated directly by the Province.

The City of Enderby Wildlife Attractant Bylaw No. 1754, 2022 proposes to prohibit the leaving or placing of wildlife attractants on or about land or premises where there are or are likely to be people, in a manner in which the attractants could attract wildlife to the premises and be accessible to wildlife. The bylaw also prohibits the feeding of wildlife. The bylaw provisions are commonplace among wildlife attractant bylaws and are consistent with guidance from WildSafeBC.

In addition, an amendment to the City of Enderby Garbage Collection Regulation Bylaw No. 1566, 2015 is proposed in order to deal with two related issues. First, the amendment removes from the definition of "garbage container" the phrase "heavy weight plastic bag," with the implication that all garbage must be placed at curbside in rigid containers with lids. Second, the amendment adds a clause that requires garbage to be placed at curbside "no earlier than 4:00 a.m." on the day of collection.

Secondary effects of the proposed regulations include:

- assisting in making properties less attractive to rats and other vermin by making food sources less accessible; and
- preventing other wild and domestic animals from ripping through garbage bags and scattering garbage on collection day.

Staff anticipate that there will be an adjustment period for residents. Engagement will start with an educational approach, which will supplement ongoing awareness initiatives encouraging the public to "bear proof" their properties; as is often the case, a purely educational approach has helped, but uptake has been mixed. In the meantime, wildlife conflicts are continuing to occur, often with tragic consequences for wildlife, as well as placing domestic animals and humans at risk.

Subject to Council giving three readings to the proposed bylaws, staff will commence work on corollary amendments to the City's ticketing bylaws; as education-based compliance will precede enforcement, staff are comfortable staggering the implementation of penalties and can generally address situations that are severely problematic under one of the City's other bylaws, or otherwise refer to the Conservation Officer Service.

#### BYLAW NO. 1754, 2022

A bylaw to regulate, prohibit, and impose requirements respecting the feeding and attracting of dangerous wildlife and members of the family Cervidae

WHEREAS Section 8(3)(k) of the *Community Charter* authorizes the Council of the City of Enderby to, by bylaw, regulate, prohibit and impose requirements in relation to animals;

AND WHEREAS Section 9(1)(c) of the *Community Charter* recognizes wildlife as a sphere of concurrent authority for which Council may not adopt a bylaw unless in accordance with a regulation, an agreement, or an approval of the Province;

AND WHEREAS Section 2(1)(c) of the *Spheres of Concurrent Jurisdiction – Environment and Wildlife Regulation* enables Council to regulate, prohibit, and impose requirements respecting the feeding or attracting of dangerous wildlife or members of the family Cervidae;

NOW THEREFORE the Council of the City of Enderby, in open meeting assembled, enacts as follows:

#### 1. CITATION

1. This Bylaw shall be cited as "City of Enderby Wildlife Attractant Bylaw No. 1754, 2022".

#### 2. DEFINITIONS AND INTERPRETATION

In this Bylaw:

"City" means the Corporation of the City of Enderby.

"Dangerous Wildlife" includes bear, cougar, coyote, wolf, and any species of wildlife that is prescribed as dangerous under the *Wildlife Act.* 

"Wildlife" includes Dangerous Wildlife and members of the family Cervidae [deer].

"Wildlife Attractant" includes any substance which could reasonably be expected to, or does, attract Wildlife, including but not limited to food products, food containers, pet and bird food, seeds, restaurant grease, game meat, carcasses, animal waste products, uncollected fruit, garbage, organic waste, barbecues, grills, and related equipment, diapers, grease barrels, petroleum products, antifreeze, other chemical products and any other substance or thing prescribed by the *Wildlife Act*.

#### 3. GENERAL

- 1. Bylaw Enforcement Officers appointed by the City are authorized to enforce and carry out the provisions of this Bylaw.
- 2. Bylaw Enforcement Officers appointed by the City are hereby authorised to enter, at all reasonable times, upon any property within the municipal boundaries of the City of Enderby

subject to this Bylaw and Section 16 of the *Community Charter*, in order to ascertain whether the regulations of this Bylaw are being obeyed.

3. A person, operation, or facility is exempt from this Bylaw if their activities are consistent with section 2(3) of the *Spheres of Concurrent Jurisdiction – Environment and Wildlife Regulation*.

#### 4. REGULATIONS, PROHIBITIONS AND REQUIREMENTS

- 1. Except as permitted in this Bylaw, a person must not:
  - (a) Leave or place Wildlife Attractants in, on, or about any land or premises where there are or are likely to be people, in a manner in which the Wildlife Attractant could attract Wildlife to the premises and be accessible to Wildlife.
  - (b) Feed, or attempt to feed, Wildlife.
- 2. Every owner or occupier of real property must ensure that:
  - (a) Fruit that has fallen from a tree or bush is removed, stored, or disposed in such a manner so as not to attract or be accessible to Wildlife.
  - (b) Birdfeeders containing bird feed, suet or nectar are suspended on a cable or other device in such a manner that it is inaccessible to Wildlife, and the area below any birdfeeder is kept free of accumulations of Wildlife Attractants.
  - (c) Barbecue equipment and tools that remain outdoors after use must be clean and free of residual food or grease so as not to attract or be accessible to Wildlife.
  - (d) Refrigerators, freezers, storage containers or similar units containing Wildlife Attractants of any type, if outdoors, are located and equipped in a manner that is inaccessible to Wildlife.
  - (e) Grease, antifreeze, paint and petroleum products are stored in such a manner that is inaccessible to Wildlife.
  - (f) Compost is kept and maintained in an enclosed and secure rigid container that is inaccessible to Wildlife.
  - (g) Other animals, including backyard hens and bees, as well as domestic animals, are kept in a manner that is reasonably inaccessible to Wildlife, including their food.
  - (h) Garbage is stored indoors or otherwise in durable, rigid receptacles fitted with covers that are inaccessible to Wildlife, and not placed at curbside until 4:00 a.m. on the day of collection.
  - (i) All garbage is kept and disposed in accordance with this Bylaw, the City of Enderby Garbage Collection Regulation Bylaw No. 1566, 2015 and any other relevant enactment.

#### 5. OFFENSES

- Every person who contravenes or violates any provision of this Bylaw, or who suffers or permits any act or thing to be done in contravention or in violation of any provision of this Bylaw, or who neglects to do or refrains from doing anything required to be done by any provision of this Bylaw, commits an offence and, upon conviction, shall be liable to a fine or penalty not to exceed \$10,000, and a jail term of not more than 6 months.
- 2. Each day the offence continues is considered a separate offence.
- This bylaw is enforceable through the City of Enderby Municipal Ticketing Information (MTI) System Bylaw No. 1518, 2013 and the City of Enderby Bylaw Notice Enforcement Bylaw No. 1581, 2015.

#### 6. SEVERABILITY

1. If a section, subsection, sentence, clause or phrase of this Bylaw is for any reason held to be invalid by the decision of a Court of competent jurisdiction, it shall be severed and such decision shall not affect the validity of the remaining portions of this Bylaw.

#### 7. EFFECTIVE DATE

1. This bylaw shall come into force and effect as and from the date of adoption.

City of Enderby Garbage Collection Regulation Bylaw No. 1566, 2015 is hereby amended as follows:

2. By replacing the definition of "garbage container" with:

"garbage container" means a non-corrosive, durable, rigid receptacle, fitted with secure handles and a watertight cover, used for the collection of garbage from residential premises.

3. By replacing section 4.1 with:

All garbage containers shall be kept, maintained and readily accessible for emptying or collection by 7:00 a.m. on the day of collection and shall be placed at curbside no earlier than 4:00 a.m. on the day of collection.



#### PURPOSE:

The City will consider approving the temporary closure of municipal roads for a community event.

#### POLICY:

Temporary road closures will only be considered for community events which are sponsored by a recognized organization.

The Chief Administrative Officer or designate is granted the authority to approve a Temporary Road Closure Permit on behalf of Council, subject to the applicant meeting all the requirements of this policy. First time events must be approved by City Council.

A completed Schedule A, "Application for Temporary Road Closure," shall be submitted to City Hall at least 21 days prior to the closure. The application must include a map of the proposed road closure and emergency access through the closure. Applications for first-time or relocated events requiring Council approval must be submitted two months prior to the closure.

The organizer shall notify and consult with business owners within a one-block radius of the proposed road closure and residents adjacent to the proposed road closure. The organizer agrees to take reasonable steps to mitigate disruption for affected business owners and residents. Failure to adequately notify and consult affected businesses and residents may result in revocation of permit or refusal of future applications. Unless exempted by Council, all first-time or relocated event applications must include a petition signed by a majority of affected business owners agreeing to the proposed event.

The applicant for a Temporary Road Closure must submit proof of public liability and property damage insurance in a form acceptable to the City. 

#### PURPOSE:

The City will consider approving the temporary closure of municipal roads for a community event.

#### POLICY:

Temporary road closures will only be considered for community events which are sponsored by a recognized organization.

The Chief Administrative Officer or designate is granted the authority to approve a Temporary Road Closure Permit on behalf of Council, subject to the applicant meeting all the requirements of this policy. First time events must be approved by City Council.

A completed Schedule A, "Application for Temporary Road Closure," shall be submitted to City Hall at least 21 days prior to the closure. The application must include a map of the proposed road closure and emergency access through the closure. Applications for first-time or relocated events requiring Council approval must be submitted two months prior to the closure.

The organizer shall notify and consult with business owners within a one-block radius of the proposed road closure and residents adjacent to the proposed road closure. The organizer agrees to take reasonable steps to mitigate disruption for affected business owners and residents. Failure to adequately notify and consult affected businesses and residents may result in revocation of permit or refusal of future applications. Unless exempted by Council, all first-time or relocated event applications must include a petition signed by a majority of affected business owners agreeing to the proposed event.

The applicant for a Temporary Road Closure must submit proof of public liability and property damage insurance in a form acceptable to the City. The applicant may request that insurance requirements be waived based on the risk profile of the event. Such waiver does not affect any other responsibility of the applicant to obtain insurance.

The applicant shall be responsible for all traffic management, including the provision, set up, and removal of signs and barricades on the same day as the road closure.

The applicant shall be responsible for ensuring that all food service establishments, including but not limited to mobile vending units, food services at temporary events, and sellers of home-prepared foods, shall have the appropriate authorization or permit from Interior Health.

The applicant shall be responsible for emptying municipal garbage receptacles and cleaning up litter from the road closure area on the same day as the closure.

As a condition of permit, the City of Enderby will not be liable or otherwise responsible for any scheduling conflict, revocation, refusal, maintenance closure or other damage or harm related to the issuance of this permit.

#### RECOMMENDATION

THAT Council receives and files Cypress Land Services' Request for Concurrence for a TELUS Telecommunications Tower at 2308 McGowan Street, Enderby, BC dated May 12, 2022;

AND THAT Council directs staff to provide public notice of its intent to dispose of an interest in land at 2308 McGowan Street, Enderby, BC pursuant to section 27 of the Community Charter and invites written submissions to be received by 3pm on June 20, 2022, for consideration at the regular Council meeting scheduled for the same day.

#### **ALTERNATE RECOMMENDATION**

THAT Council receives and files Cypress Land Services' Request for Concurrence for a TELUS Telecommunications Tower at 2308 McGowan Street, Enderby, BC dated May 12, 2022;

AND THAT Council advises Cypress Land Services that it does not intend to proceed with disposing of an interest in land at 2308 McGowan Street, Enderby, BC and will not provide a resolution of concurrence to that effect.

#### BACKGROUND

At its in-camera meeting of March 21, 2022, Council considered a proposed agreement with Telus Communications Inc. ("Telus") for the installation of a telecommunication tower at the City of Enderby Public Works Yard, located at 2308 McGowan Street ("the Land").

The agreement involves the granting of a statutory right-of-way ("the SRW") pursuant to section 218 of the Land Title Act and a fee agreement ("the Fee Agreement"). At this meeting, Council resolved as follows:

THAT Council supports in principle the terms and conditions of the Statutory Right of Way instrument and fee agreement with Telus Communications Inc., both dated for reference March 14, 2022, with respect to the property owned by the City of Enderby at 2308 McGowan Street, Enderby, BC and having a legal description of LOT 1 DISTRICT LOT 226 KAMLOOPS DIVISION YALE DISTRICT PLAN KAP57152 ("the Land"), as a reasonable basis for the City and Telus to proceed with their respective public notification and consultation requirements;

AND THAT Council determines that the consideration received for the interest in land to be disposed meets or exceeds market value based upon a proportionate share of the assessed value of the Land;

AND THAT Council authorizes Staff to communicate to Telus Communications Inc. that it may commence its public consultation requirements, and requests that Telus Communications Inc. provide documentation of all public consultation to the City;

AND THAT Council authorizes Staff to communicate the Telus Communications Inc. that it will decide upon the disposal of the interest in land following consideration of Telus' public communications documents as well as consideration of the outcomes of the City's public notification requirements pursuant to Division 3, Part 3 of the *Community Charter*;

AND FURTHER THAT Council releases this resolution and the Statutory Right of Way instrument and fee agreement with Telus from in camera.

Telus has since completed its public consultation requirements, which involves sending notices to neighbours who are a distance of three times the tower height, and advertising in a local newspaper. Telus' consultation package is attached to this memorandum. No inquiries were received in response to the public consultation.

At this point, Council may decide to proceed with its own legislative obligations in order to consider disposing of an interest in the Land, pursuant to the proposed agreement with Telus. This involves providing public notice in two consecutive editions of a local newspaper. The public notice must include the following:

- (a) a description of the land or improvements;
- (b) the person or public authority who is to acquire the property under the proposed disposition;
- (c) the nature and, if applicable, the term of the proposed disposition; and
- (d) the consideration to be received by the municipality for the disposition.

Staff recommend that the public notice expressly invite written representations from the public, which must be received by 3pm on June 20, 2022, which is the same day as the next meeting of Council following the completion of the City's public notice obligations.

Following its consideration of public representations, Council would then make its decision about the disposal of the interest in the Land. At the same time, Council would provide its resolution of concurrence with the proposed location in accordance with Innovation, Science and Economic Development Canada's public consultation process for locating telecommunications towers.

Subject to Council deciding to proceed, Staff would execute the agreement and register the easement on the title of the Land.

The consideration received would be an annual fee of \$15,000 plus inflationary increases, over four five-year terms renewable at Telus' option.

#### What is TELUS Proposing?

TELUS seeks to continue to provide high quality wireless telecommunications services to communities throughout British Columbia. Increasingly, communities depend on wireless communications services to meet their business, personal and emergency needs. As such, TELUS is proposing to install a new wireless antenna system to improve services in the north end of Enderby and surrounding areas. This notification package is intended to formalize the consultation process.

The subject site is an Industrial property comprised of the City of Enderby's public works yard located at 2308 McGowan Street, Enderby, BC. The tower is proposed to be located in the southwest corner of the property. Access to the site exists through the property. The proposed installation consists of a 40-metre monopole structure with nine (9) panel antennas mounted 1.0 metre above the top of the tower. An equipment shelter will be located near the base of the tower enclosed by a chain-link fence, occupying an area of 15.0 by 15.0 metres. The proposed tower may have sufficient space/capacity for additional antennas should another carrier wish to install equipment to support their network requirements at this location. The proposed facility will improve services to the immediate area.

#### **Regulatory Authority**

Telecommunications carriers are required by Innovation, Science, and Economic Development Canada (ISED), formerly Industry Canada, to consult with the local municipality and the general public regarding new installations. ISED does have exclusive jurisdiction over the approval and placement of telecommunications installations.

The consultation process will provide an opportunity for residents, stakeholders and landowners to obtain detailed information regarding the proposal and to provide comments for consideration. Any inquiries that are received as a result of this notification will be logged and submitted to the City of Enderby and ISED as part of our application for concurrence.

#### Local Municipality

The City of Enderby does not have a telecommunications consultation process to guide the consultation process. As such, ISED's Client Procedures Circular CPC-2-0-03 (CPC) consultation process will be followed. This process requires all properties within three times the structure height to be notified (in this instance those within approx. 123.0 metres) and an advertisement in the Okanagan Advertiser. This notification is to provide the opportunity to obtain information regarding the proposal, ask questions and provide comments. The closing period for comments to be received by TELUS is May 9, 2022.

#### Location

The new facility is proposed to be located at the coordinates 50.561862°, 119.140287°. To confirm, there are no existing structures in the vicinity of the proposed tower to collocate antennas on.



#### Safety Code 6

ISED requires all wireless carriers to operate in accordance with Health Canada's safety standards. TELUS attests that the installation described in this notification package will be installed and operated on an ongoing basis so as to comply with Health Canada's Safety Code 6, as may be amended from time to time.

#### Site Access

Access will be obtained via an existing access off McGowan Road and through the property. Construction is expected to take approximately one to two months.

#### Environment

TELUS confirms that the installation is excluded from environmental assessment under the *Canadian Environmental Assessment Act*. Any municipal environmental regulations will be followed.

#### Transport Canada

The tower will be constructed to include aeronautical markings or lighting required by Transport Canada. Comments are pending. No marking or lighting is anticipated.



# **AERIAL MAP OF TELUS SITE LOCATION**






PRELIMINARY DESIGN PLANS – TOWER PROFILE



PRELIMINARY DESIGN PLANS – SITE PLAN







#### RECOMMENDATION

THAT Council directs Staff to submit an application under the Extreme Heat Risk Mapping, Assessment, and Planning funding stream of the Community Emergency Preparedness Fund in order to undertake the following activities:

- 1. Undertake extreme heat risk mapping;
- 2. Undertake an extreme heat risk assessment; and
- 3. Develop an Extreme Heat Response Plan.

AND THAT Council confirms that the City of Enderby is willing to provide overall grant management for the aforementioned activities.

#### BACKGROUND

The Community Emergency Preparedness Fund is a suite of funding programs intended to enhance the resiliency of local governments and their residents in responding to emergencies. Funding is provided by the Province of BC and is administered by Union of BC Municipalities. One of the recently added funding streams is Extreme Heat Risk Mapping, Assessment, and Planning. This funding stream is aimed at better positioning communities to ensure they have accurate knowledge of the risks associated with extreme heat, and develop effective response plans and strategies to prepare, mitigate, and adapt to those risks. This funding stream contributes 100% of the cost of eligible activities to a maximum of \$30,000.00.

Extreme heat is a significant threat to communities across the province, including Enderby. The 2019 Preliminary Strategic Climate Risk Assessment for British Columbia identified a heat wave as one of the greatest risks to the province with the highest consequences related to public health and social functioning with lesser, but still substantial, impacts to wildlife and aquatic ecosystems, and agricultural productivity. The impacts of an extreme heat event were experienced most recently with the 'heat dome' phenomenon which took place between June 25<sup>th</sup> and July 1, 2021. Not only did this extreme heat event have human impacts, including hundreds of heat-attributable deaths province-wide, it had significant environmental impacts as it played a major factor in the wildfire season that soon followed.

In order to better position the City of Enderby to understand the risks associated with extreme heat events, and to develop strategies to prepare for, mitigate and adapt to these risks, it is recommended that Council direct Staff to submit an application under the *Extreme Heat Risk Mapping, Assessment, and Planning* funding stream of the Community Emergency Preparedness Fund in order to undertake the following activities:

- 1. Undertake extreme heat risk mapping;
- 2. Undertake an extreme heat risk assessment; and
- 3. Develop an Extreme Heat Response Plan.

The aforementioned activities will allow the City of Enderby to achieve the following objectives:

- Identify populations disproportionally at risk to extreme heat;
- Determine local vulnerabilities to extreme heat;
- Identify the social, economic and environmental impacts of extreme heat events; and
- Develop a framework for short and long-term action to prepare, mitigate and adapt to risks associated with extreme heat.

It is also recommended that Council confirms that the City of Enderby is willing to provide overall grant management for the aforementioned activities, which is a requirement of the grant program.

Integrated Transportation and Infrastructure Services Division	• The Integrated Transportation and Infrastructure Services Division (ITIS) provides cross ministry planning, engineering, and property services, and oversees major infrastructure projects. ITIS is responsible for all aspects of strategic planning, capital programming, including development and management of the provincial 10-year Transportation Investment Plan, management of federal and community cost sharing programs, and the delivery of the major transportation projects throughout the province. The division oversees the acquisition, management and disposition of the ministry's thousands of properties and land interests, including those owned by the BC Transportation Financing Authority and BC Railway Company. Through the Chief Engineer's Office, the division is also responsible for ensuring that the ministry's designs and standards are adapting to climate change.
