# Official Community Plan Amendment and Rezoning Application #0016-24-OR-END

AND THAT the referral process which requests that various authorities and organizations review the amendments proposed by City of Enderby Official Community Plan Bylaw No. 1549, 2014 Amendment Bylaw No. 1800, 2024, as outlined in this Staff Report, be considered appropriate consultation for the purposes of Sections 475 and 476 of the Local Government Act;

AND FURTHER THAT City of Enderby Zoning Bylaw No. 1550, 2014 Amendment Bylaw No. 1801, 2024 which proposes to rezone the property legally described as LOT 4 DISTRICT LOT 150 KAMLOOPS (FORMERLY OSOYOOS) DIVISION YALE DISTRICT PLAN 12563, and located at 1605 George Street, Enderby BC, from the Residential Single Family (R.1-A) zone to the Highway and Tourist Commercial (C.2) zone, be given First and Second Reading and forwarded to a Public Hearing."

# CONTINUING BUSINESS AND BUSINESS ARISING FROM COMMITTEES AND DELEGATIONS

Delegation Request for Amendment to City of Enderby Sidewalk Encroachments Policy

Council discussed the origin of the sidewalk encroachments policy and Council's policy decision in 2014 to clean up off-premise signs proactively because of the number of signs accumulating.

Council discussed signs that are regularly placed for the Enderby Farmers Market and Music by the River Events.

Staff explained that exceptions to the policy can be made for community events according to the Streets and Traffic Bylaw No. 1471, 2010.

Councillor Baird suggested that Cardiff Miller may be able to approach the Ministry of Transportation about having a permanent sign placed on the highway.

Councillor Ramey clarified that the intention of their sandwich board is to be placed only when the gallery is open, as the gallery is not always open consistent hours.

Council discussed the possibility of allowing sandwich boards to be placed on George Street only for non-profits, as Ms. Cardiff mentioned in her delegation at the regular meeting of September 3, 2024 that they are exploring the possibility of obtaining non-profit status for the Cardiff Miller Art Warehouse.

Council discussed the importance of a clear policy for fairness and enforcement.

Council discussed postponing indefinitely this matter until more information can be gathered from Cardiff Miller Art Warehouse.

Reported that there are renovations being done to the Enderby Library including new carpet and paint.

Attended the National Day for Truth and Reconciliation Walk and Gathering hosted by Splatsin.

Attended Enderbeer and reported it was a great event.

Has attended the Enderby Chamber of Commerce coffee chats.

Reported that the Enderby Food Bank has been seeing some new clients recently.

#### Councillor Davyduke

Attended the National Day for Truth and Reconciliation Walk hosted by Splatsin.

Attended an interagency meeting in September.

Reported that the Harvest Hut is wrapping up its 10th season of operation with cake on October 14th.

Reported that the Meal Mentoring for Moms program hosted by the Enderby & District Community Resource Centre is going very well.

#### Councillor Shishido

Attended a meeting of the Enderby Fish & Game Club where volunteer engagement was discussed.

Spoke with the organizer of the Friday Night Lights burn out competition from past years and reported that the event was cancelled this year because of a lack of available people to help run the event, but that there may be an opportunity to bring the competition back next year.

Reported that the United Church will be closing as of December 31<sup>st</sup> and that the Enderby & District Community Resource Centre is looking for a new location.

The Enderby & District Museum Society AGM is scheduled for November.

#### Mayor Galbraith

Attended the National Day for Truth and Reconciliation Walk and Gathering hosted by Splatsin.

Attended the Splatsin Development Corporation Golf tournament fundraiser.

Attended an Okanagan Regional Library Board Meeting.

Met with Dr. Abdalla to present the welcome gift basket that local businesses and residents contributed to. Thanked all who contributed to the basket.

# **Chief Administrative Officer**

Reported that Russell Avenue was paved last week and is nearing completion. The contractor is doing landscape and driveway/pathway crossing tie-ins this week.

The Reservoir 1 request for proposals has been posted to BC Bid. There is a bidder information meeting tomorrow afternoon on site, which will provide a good sense of contractor interest. Staff is waiting to hear back on the Construction Permit application with IHA.

The Pool's construction drawings were completed to 50% and a submission to the Interior Health Authority for a Construction Permit has been made. The Construction Manager is engaging with trades to refine prices. Some site preparation work will be done ahead of actual construction in January, including some tree removal and realigning the district heating line that runs through Barnes Park.

The Arena is up and running without any problems. It has been quite busy and is expected to get even busier. Thanked Parks staff for their work coordinating with the various contractors to ensure that the refrigeration system was back in action.

There is a ribbon cutting for the Grindrod Park ball diamond, at 11am on October 10th.

The new Fire Department Command/Utility vehicle is in full operation. The CFO is preparing to advertise for the disposal of Rescue 17. The Fire Department is hosting an open house as part of fire prevention week. It will be held on October 12 from 9am to 2pm.

A new digitized system for getting pre-incident plans into the hands of our firefighters and ensuring that they are always up-to-date is being rolled out. Thanked the Clerk-Secretary for her work in getting the new system in place.

Public Works is getting everything prepared for the cremation garden expansion, which is part of the amended Cemetery Land Use Plan. The existing utility shed has been removed and tools and stored materials have been relocated to the Public Works Yard. The site is being levelled and excavated, and then the new section will be poured. There are plans to extend the screening late this year or early next.

Public Works has installed the new stop sign beacons at the Cliff/Belvedere intersection. They have also added some signs on Kildonan Avenue to help direct boat launch and campground traffic to the preferred route back out to Highway 97A, as there have been issues with this traffic having to back out of Kildonan Drive. Signs encouraging southbound truck traffic on Belvedere to turn at Knight or Mill, rather than trying to navigate Maud/Cliff, have been installed.

Public Works along with a local fabricator have extended the handrails at the Riverwalk stairwell.

Enderbeer and Wine Festival has been delivered. Thanked those who were able to attend and all involved in putting on the event, particularly the Events Coordinator and CFO.

The storage enclosure in the Russell Avenue parking lot is being repainted by the original artist. The results already look amazing. The City is hopeful that there will be an opportunity for the artist to share with local media the symbolism and vision of the work.

The inaugural Coffee with Mayor and Council is scheduled for October 8, 9:30-11:00am at Hungry Jack's.
